

# **EXHIBIT 1**

We represent The Select Group LLC (“TSG”) located at 801 Fast Park Drive, Suite 301, Raleigh, North Carolina, 27617, and are writing to notify your office of an incident that may affect the security of certain personal information relating to one (1) Maine resident. By providing this notice, TSG does not waive any rights or defenses regarding the applicability of Maine law, the applicability of the Maine data event notification statute, or personal jurisdiction.

### **Nature of the Data Event**

On March 28, 2022, TSG discovered some suspicious activity within an employee’s email account. TSG immediately took steps to ensure the security of its email system and, with the assistance of cybersecurity specialists, launched an investigation into the nature and scope of the event. The investigation recently determined that an unauthorized actor gained access to certain TSG employee email inboxes between February 12, 2022, and March 28, 2022. TSG then underwent a thorough review of these inboxes and determined on September 2, 2022, that some information may have been contained in one of these inboxes.

The information that could have been subject to unauthorized access includes name, Social Security number and government issued identification information.

### **Notice to Maine Resident**

On or about October 7, 2022, TSG provided written notice of this incident to one (1) Maine resident. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

### **Other Steps Taken and To Be Taken**

Upon discovering the event, TSG moved quickly to investigate and respond to the incident, assess the security of TSG email tenant, and identify potentially affected individuals. TSG is also reviewing their current policies, procedures, and employee training program to reduce the likelihood of similar events from occurring in the future. TSG is providing access to credit monitoring services for twelve (12) months, through Equifax, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, TSG is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. TSG is also providing individuals with information on how to place a fraud alert and security freeze on one’s credit file, information on protecting against tax fraud, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud. TSG is providing written notice of this incident to relevant state regulators, as necessary.

The Select Group LLC (“TSG”) writes to inform you of a recent event potentially impacting your personal information. TSG takes this event very seriously and the confidentiality, privacy, and security of information in TSG’s care is one of our highest priorities. While we are not aware of any actual or attempted misuse of your information, we are providing you with an overview of the incident, our response, and resources to help further protect your information, should you feel it necessary to do so.

**What Happened?**

On March 28, 2022, TSG discovered some suspicious activity within an employee’s email account. TSG immediately took steps to ensure the security of its email system and, with the assistance of third-party cybersecurity specialists, launched an investigation into the nature and scope of the event. While the investigation is ongoing, it was recently determined that an unauthorized actor gained access to certain TSG employee email inboxes between February 12, 2022, and March 28, 2022. TSG then underwent a thorough review of these inboxes and determined on September 2, 2022 that your information may have been contained in one of these inboxes.

**What Information Was Involved?**

While our investigation into the full nature and scope of the event is ongoing, the investigation recently determined that the potentially at-risk information related to you is your name and <<Breached Elements>>. To date, TSG is not aware of any actual or attempted misuse of your information.

**What We Are Doing.**

TSG takes this event and the security of information in our care very seriously. Upon learning of the event, we moved swiftly to respond and investigate, assess the security of our email system, and notify potentially impacted individuals. As part of our ongoing commitment to information security, we are currently reviewing our policies, procedures, and employee training program to reduce the likelihood of similar events from happening in the future. TSG is also offering you 12 months of complimentary credit monitoring through Equifax. Instructions are included in the enclosed *Steps You Can Take to Protect Personal Information*. We encourage you to follow the instructions to enroll as TSG cannot do so on your behalf.

**What You Can Do.**

We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. Please review the enclosed *Steps You Can Take to Protect Personal Information*, which includes further information on what you can do to better protect your information against misuse, should you feel it necessary to do so.

## **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
