Types of complaints Office of the State Auditor personnel investigate:

- Illegal acts affecting State government such as theft, fraud, and financial conflict of interest,
- financial fraud depleting resources or increasing expenditures of the State,
- significant abuse of State equipment or property,
- clear misuse of State property, programs, or work time for personal gain,
- gross misconduct with significant financial effects,
- consistent, wasteful conduct with significant financial implications, and
- kickbacks or similar acts involving return payments to State workers or vendors.

Types of complaints Office of the State Auditor personnel do not investigate, but the Office does generally refer these complaints to other State agencies or other government authorities:

- Personal conflicts between individuals or domestic or other threats of violence,
- alleged improper acts by federal officials,
- personal gripes against State employees about personal matters,
- mistakes made by State personnel,
- insignificant matters or complaints without sufficient factual basis, and
- matters handled by other specific State investigation units.

The Office of the State Auditor does not have enforcement power. However, we work with governmental entities that do have enforcement power. This includes the Attorney General's Office and the District Attorneys' Offices.

A person called. Wishes to remain anonymous, I returned the call. This is meant to be a summary, not a transcription.

The complainant wants to know how to the town of _____ audited. The town meeting is held every year at the grange hall which is not accessible, nor is there enough parking to allow the citizens to attend. There is a school in town which would allow room and accessibility to the town folks, but the petition to have the town meeting there was "lost" The vast majority of the people who do attend are related to each other, and effectively run the town, by overwhelming any opposition.

One of the town's selectmen is the ____ of the head of the ____ dept. who is paid a salary of \$80,000 without any licensing to justify it. The majority of all funding is spent through public works. A piece of property was purchased through the Public Works Dept. that caused an inability to purchase sufficient salt/sand for the winter road treatments.

Complaint

States there are eight checkbooks for the town, with no known reasons for them, that all town employees seem to have one. Information about the town's business affairs go unanswered or referred to town meetings that are not forthcoming. Freedom of Information Act requests have been ignored. Allegedly no one can understand or explain the audited financials, and the books are kept in the locked fire house that is not open to the public.

Paperwork of entire periods of time have been "lost"

An Atty has not been engaged yet. The concern is that the town is losing money and engaging in illicit activity.

I told him/her that although we do have the authority to audit a town, it is not typical. I suggested that (S)he, or his/her group seek the guidance of an Atty to see if their request could be possibly done in a manner to get his results. I told him/her that (S)he or the group could send in a letter if (S)he wishes. I told him/her that if there were any external referrals, they would be in my name, and if needed, I would act as an information conduit between him(her)self and the requestor."
