



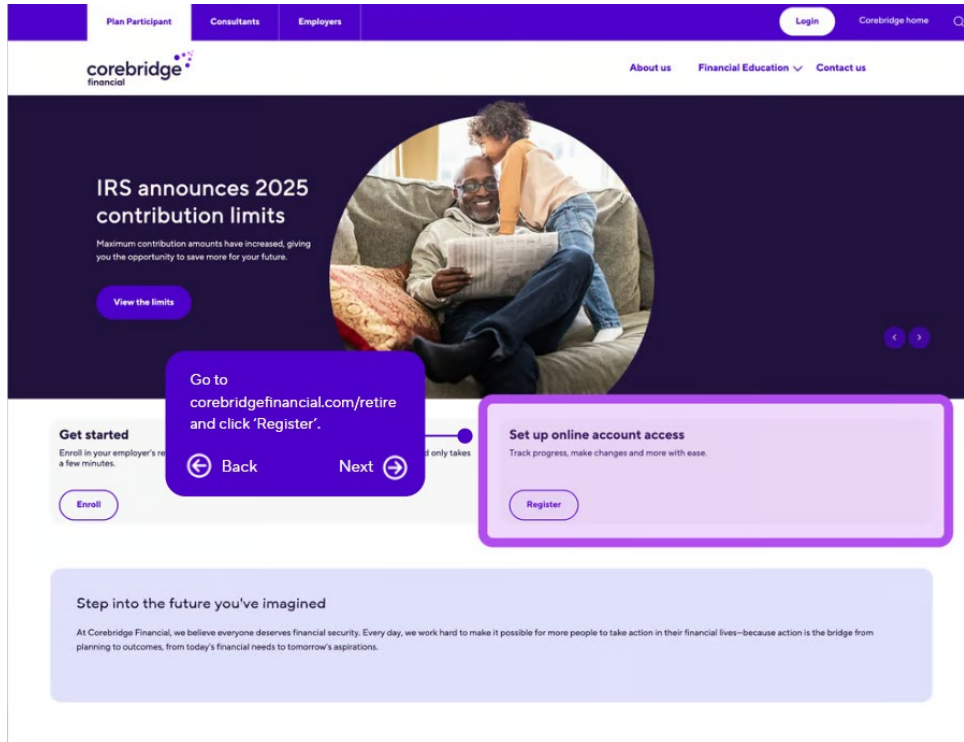
Step 2: Follow the instructions provided below.



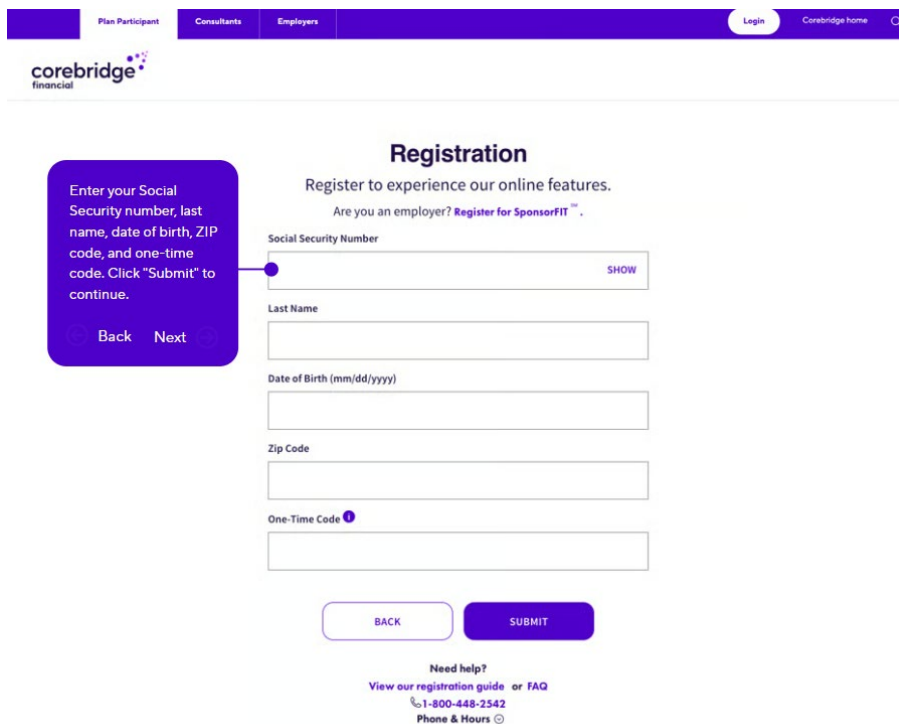
Step 3: Enter required information and click Submit.


