a. Employee Health and Wellness Highlights – The Office of Employee Health, Wellness, and Workers' Compensation Information contained in written report; highlights and discussion noted below:

Wellness Highlights -

 WondrHealth: On-demand enrollment for WondrHealth starts this summer for active employees, spouses and covered dependents 18 year of age and over who are enrolled in the State of Maine Health Plan. Application to the program is ongoing throughout the year. The program will be announced in August, and a unique enrollment link will be on the website.

Communications Highlights –

- 2025 Annual Open Enrollment: State of Maine employees received two emails regarding open enrollment. Two constant contact emails also went out, one to both active State employee subscribers and ancillary employee subscribers and another to ancillary employee subscribers only. A home mailer was sent to all State of Maine employees.
- Constant Contact: The following campaigns have been sent to one or more of the State of Maine groups: 2025 Open Enrollment (11,526 Recipients, 52% Open Rate, 4% Click Rate), Mental Health Awareness Month (11,534 Recipients, 47% Open Rate, 1% Click Rate), 2025 Open Enrollment Ancillary (2,024 Recipients, 48% Open Rate, 2% Click Rate, Skin Cancer Awareness Month (14,220 Recipients, 36% Open Rate, 1% Click Rate). The Book of Business Open Rate is 50% and the Book of Business Click Rate is 3%.

- An intense data review will be undertaken in July to prepare for the PRISM golive early this fall.

V. QUARTERLY PLAN UPDATES				
a. Plan Experience Summary – Active Medical and Dental – Lockton	 Information contained in written report; highlights and discussion noted below: State of Maine Health Insurance Administrative Payments: From July of 2024 through April of 2025, administrative payments by the State of Maine to all vendors to administer the network and process claims, as well as various fees to other entities, totaled \$11,642,235. State of Maine Experience Detail – Self-Funded Medical: With claims and expenses representing 107% of the budget, the plan is over budget in the current plan year. State of Maine Experience Detail by Status: Lockton has been working with the State of Maine General Government Service Center to align financial reports and going forward Lockton will provide separate reporting on active and retiree status. State of Maine High Cost Claimants: There are currently five claims exceeding the \$750K attachment point where insurance kicks in; for reference, there were two claims in the prior year. Overall, there are 53 claimants exceeding the half-way point of \$275K which is in line with last year's total of 51 claimants.
