SUBJECT: VALUE OF BENEFITS WHEN PUBLISHING SALARIES: AMENDMENT TO HR MEMO 6-03 ADDING "MSEA CORRECTIONS LAW ENFORCEMENT - SPECIAL PLAN"

Maine law requires that a statement of the dollar value of the fringe benefits package provided by the state must be placed in all advertisements that indicate the salary of a position. This includes all advertisements or other announcements that agencies may develop to fill "direct hire" vacancies. This memorandum reflects revised rates for the state share of retirement and revised dental insurance rates.

Effective July 1, 2003 all advertisements must reflect the health/dental insurance rates and retirement rates listed below. All previous human resource memoranda pertaining to the value of benefits are superseded.
