INTRODUCTION

This document is a Consent Agreement regarding Carolyn C. Nagy's license to practice as a licensed practical nurse in the State of Maine, entered into pursuant to 32 M.R.S.A. Section 2105-A(1-A)(B) and 10 M.R.S.A. Section 8003(5)(A-1)(4). The parties to this Consent Agreement are: Carolyn C. Nagy, L.P.N., the Maine State Board of Nursing ("Board") and the Department of Attorney General, State of Maine.

By letter dated October 2, 1990, Ms. Nagy was notified to meet with the Board in an informal conference to discuss the complaint filed against her by Colonial Acres Nursing Home and her subsequent criminal conviction regarding diversion and abuse of drugs. At the informal conference held on November 8, 1990, Ms. Nagy was present, along with hospital representatives.

FINDINGS OF FACT

As a result of the informal conference, the Board made the following findings of fact:

- 1. Licensee did obtain a requested screening and evaluation.
- 2. Licensee states she has been substance free for one year.
- 3. Licensee still has chronic back pain.
- 4. Licensee admits to substitution and diversion of drugs.
- 5. Licensee was convicted of a misdemeanor for stealing drugs.
- 6. There was no documented evidence of patient harm.
- 7. Licensee has at least a 15 year alcohol abuse history.

- 8. Licensee does have a supportive family system.
- 9. Licensee quit her nursing job because of the theft of drugs incident.
- 10. Licensee is involved in professional substance abuse counseling.
- 11. Licensee has limited contact with self-help programs.
- 12. Licensee surrendered her license on June 8, 1990. \bigcirc

COVENANTS

Based on the above findings of fact, the Board voted to place Ms. Nagy's license to practice nursing on a probationary status for a two year period, beginning November 8, 1990, on the following terms and conditions:

- 1. Licensee is to remain substance free (alcohol and drugs).
- 2. Licensee shall continue in a formal treatment program as recommended by her counselor.
- 3. Licensee shall increase her involvement in her self-help recovery program to three times a week, if possible.
- 4. Quarterly progress reports from Licensee's aftercare counselor shall be submitted to the Board.
- 5. Upon termination from formal aftercare a final report shall be submitted to the Board from Licensee's counselor.
- 6. Quarterly progress reports from Licensee's nurse employer shall be submitted to the Board.
- 7. Licensee shall engage in no employment for contract nursing agencies or nurse registries.
- 8. The failure to comply with any term or condition of this Consent Agreement shall result in the automatic and permanent revocation of Licensee's license.
- 9. Licensee hereby waives all claims of confidentiality and privilege she may have regarding reports to be submitted to the Board in accordance with this Consent Agreement.
