INTRODUCTION

This document is an Addendum to the Consent Agreement dated October 26, 2004, regarding Tracey L. Fish's license to practice registered professional nursing in the State of Maine. The Board met with Ms. Fish on September 27, 2006, to consider her request to modify her Consent Agreement. The parties enter into this Addendum pursuant to Paragraph No. 14 of the Consent Agreement. The parties to this Consent Agreement are Tracey L. Fish ("Licensee"), Maine State Board of Nursing ("Board") and the Office of the Attorney General, State of Maine.

FACTS

- 1. On July 20, 2006, Ms. Fish requested modification of her October 26, 2004 Consent Agreement.
- 2. Tracey L. Fish is currently employed at Home, Hope, and Healing. Her position at Home, Hope, and Healing is an office support with no direct patient care. New opportunities at Home, Hope, and Healing would allow her to be involved in case management / utilization management regarding patient care. This is not a structured setting as defined by the terms of the October 26, 2004 Consent Agreement.
- 3. The Parties to this Consent Agreement have agreed to a limited modification of Paragraph No. 6.g. of the Consent Agreement.

ADDENDUM

4. Tracey L. Fish's Consent Agreement with the Board, attached hereto, amend Paragraph No. 6.g. as follows:

With the exception of Ms. Fish's current employment at Home, Hope, and Healing, Ms. Fish' employment is restricted during the period of probation to structured settings, which shall not include assignments from temporary employment agencies, school nursing, working as a traveling nurse or working within the correctional system.

5. This Addendum is only a modification of Paragraph No. 6.g. of the October 26, 2004, Consent Agreement. All other terms and conditions of the October 26, 2004, Consent Agreement remain in full force and effect.
