**INTRODUCTION**

This document is a Consent Agreement regarding Jennifer Olson’s license to practice professional nursing in the State of Maine. The parties enter into this Agreement pursuant to 10 M.R.S.A. § 8003(5)(A-1)(1), § 8003(5)(B) and 32 M.R.S.A. § 2105-A (1-A)(A) and (B). The parties to this Consent Agreement are Jennifer Olson (“Licensee”), Maine State Board of Nursing (“Board”) and the Department of Attorney General, State of Maine. The parties reached this Agreement pursuant to an informal conference held on December 6, 2000 based on information submitted by Visiting Nurse Service of Southern Maine by a letter dated December 8, 1999.

**FACTS**

1. Jennifer Olson has been a registered nurse licensed by the Board to practice in Maine since 1989.
2. Jennifer Olson crossed professional boundaries.
3. Jennifer Olson admits that she developed a personal relationship with a patient while employed by the agency.

**AGREEMENT**

4. Jennifer Olson agrees and understands that her conduct constitutes grounds for discipline under 32 M.R.S.A. § 2105-A(2)(F), (2)(H) and Chapter 4(4)(B)(1). Jennifer Olson is hereby **WARNED**. Ms. Olson is hereby **WARNED** because she engaged in a romantic relationship with a former patient without a sufficient lapse of time between the nurse/patient relationship and the subsequent romantic relationship.
5. Jennifer Olson understands that this Consent Agreement imposes discipline regarding her license to practice professional nursing in the State of Maine. Ms. Olson understands that she does not have to execute this Consent Agreement and that she has the right to consult with an attorney before entering into this Consent Agreement.
6. Jennifer Olson affirms that she executes this Consent Agreement of her own free will.




