### **TELECOMMUNICATIONS**

The Project includes: a) a microwave system from Bass Harbor in the Town of Tremont across 6 miles of ocean to the Island where it will connect to a new central office via fiber optic cabling, b) securing rights to attach fiber optic cabling to 962 utility poles covering 23.5 miles of roadway, c) fiber optic cabling between the central office and each of 597 potential Internet subscriber locations, d) optical electronic equipment in the central office and at each subscriber location, e) emergency backup generator for the central office, f) bucket truck and tools for an on-island technician, and g) miscellaneous components to deploy symmetrical 1 gigabit per second service to all subscribers. All aspects of the entire network will be owned by the Town of Swan's Island. The central office and fiber optic network have been fully engineered, construction drawings prepared, bill of materials produced, and project costs have been estimated. The microwave system has been designed and costs have been estimated for a turn-key tower site development and permitting, construction and turn-up. All aspects of the network construction will be subjected to a thorough RFP process. The network will be operated and maintained by an experienced network operator / service provider selected through an RFP process.

### \*\*BUSINESS DEVELOPMENT

The sole industry of the community is currently fishing, which has been negatively impacted by global warming, whale protection and COVID-19. Deployment of affordable, reliable high-speed Internet is key to diversifying the economy and requires diversification to enable the development and growth of new and existing businesses. Most all residents and businesses are struggling with the limited Internet service currently available in the community where more than 70% of potential subscriber locations are below the FCC definition of broadband. We have numerous stories of opportunities lost, real estate sales falling through, and job offers declined, due to the current Internet service. In the current situation with COVID-19, we see overloaded networks hampering our students and the community from accessing the educational and business opportunities now only available on-line.

The Town of Swan's Island will inventory jobs within the community when the Project is initiated and update the inventory on an annual basis in order to document job-creation and retention.

Except for the generations old fishing trade, there is little to keep young people on Swan's Island. Children that are raised on Swan's Island must leave for High School and any further education or training. Once gone, unless they intend to fish, there is little to bring them back to the community.

By providing high-speed affordable Internet, we expect to create employment opportunities beyond fishing. We expect to be able to allow multiple and diverse incomes in families that currently depend solely on fishing, by enabling non-working spouses and seasonal workers to generate income from home-based businesses and telecommuting opportunities. Seasonal residents have told us they will stay longer and possibly convert to year-round residency if they are able to work from their homes on the island. New residents are more likely to be attracted to our community to occupy the 26% of homes that are currently vacant, increasing the number of homeowners able to telecommute from the Island.

Our current service often times requires individuals trying to telecommute to travel to the Town Library in order to adequately participate in teleconferences or send and receive large files from remote locations. There is a business in the community who has contracted for a dedicated internet connection costing hundreds of dollars a month in order to run his business. Another seasonal resident, with generational ties to the Island and a business owner in another state, rarely visits because their home is in an area with such low speeds, they cannot maintain a reliable connection with their business.

Providing these opportunities through high-speed Internet is expected to lower unemployment, increase earning potential and thereby lower the poverty level. Most importantly, it will give young people opportunities to create their own business or telecommute to off-island locations. It will lower out-migration which is a vital concern to the residents and the viability of our local school.

Currently, our community K-8 school has an enrollment of approximately 35. Increasing enrollment is vital for the continuation of local schooling. Availability of affordable, reliable high-speed Internet on other nearby islands such as Islesboro, has attracted new families with school age children and has been key to enabling existing families to remain. We believe similar results can be attained on Swan's Island and actually reverse the current out-migration trend.

See detailed results at www.swansisland.org/index.php/island-information/swans-committees/comprehensive-planning-committee. The survey found Internet is the top goal for the Island with 81% support for developing an Internet solution and its the most important infrastructure project for the future of the community. At the March 2020 Town Meeting, voters approved to fund up to 25% of the costs of a broadband network.

We have developed a very conservative detailed 5-year financial pro forma to support the Project and to ensure the Project can be operated sustainably and predictably. There are a number of variables that will impact sustainability that have been factored into the pro forma with sensitivities including:

- Take rate
- Final debt service amount
- Interest rates
- Actual construction costs
- Service pricing
- Inflation

Our model assumes worst case construction costs and contains a 10% contingency on all major components of the project. We have assumed a worst case 4% interest rate and 3% inflation rate. We have mirrored the actual results from Islesboro which is similarly situated in terms of competitive environment and remote location and have assumed a take rate less than what Islesboro has achieved. With this level of conservatism and service pricing less than what residents are currently paying for substandard DSL service, the network can operate sustainably without ongoing public subsidy for the duration of the pro forma.

Our goal, however, is to price service at no more than 50% of what residents are currently paying in order to ensure affordability for all. Should ongoing public subsidy be required to operate sustainably while ensuring affordability, the residents are committed to creating a balance between affordability and Town funding of any operating shortfall.

The Town of Swan's Island will own any required land via fee title for the central office and tower location on the Island. Tower land in Bass Harbor in the Town of Tremont will be via a long-term lease or fee title. All fiber optic cabling will be owned by the Town of Swan's Island and deployed via long-term Pole Attachment Lease Agreements with the pole owners, under terms governed by both FCC and Maine PUC regulations. Where fiber optic cabling transits private property, long-term easements will be acquired. All optical / electronic equipment will be owned by the Town of Swan's Island.

After >4 years of attempting to entice TDS to improve its existing DSL service, it is clear the Town is on its own, and as a result, at the March 2020 Town Meeting, voters committed to funding up to 25% of the Project Cost, in spite of the high taxes they already pay. At the same time, they are poised to launch a fund-raising campaign to off-set up to half of the Town commitment in order to lower the tax burden of the project.

The State of Maine is looking forward to an application for \$425,000 of the total Project cost if the \$15M Broadband Bond is approved by voters on July 14, 2020. See attached letter of support.

This NBRC grant is the 1st federal grant we have pursued, but we plan to also apply for other federal grants such as from the EDA or USDA. Without NBRC, our committed funds will be 37.5% of the total Project. With NBRC, we will have received commitments for 67% of the project, pushing us over the tipping point of 50% and making it much more likely to successfully attract a large charitable donation or additional grants. When we reach full funding, we will have leveraged our local funds 4:1, state funds 8:1, NBRC funds close to 3:1 and the remaining funds 3:1.

Without the NBRC grant request, the Project will still move forward and it will just take much longer to raise capital. In the interim, the economy of Swan's Island will continue to decline, children will not move back to the Island, the fishing industry and family incomes will continue to decline.
