

# MAINE DEPARTMENT OF CORRECTIONS

## ALLOWABLE GROUP RELIGIOUS ITEMS

### Notes:

1. The maximum allowed value of any item (excluding religious journals, religious publications, religious calendars, and religious audio CDs) is one hundred dollars (\$100.00).
2. All items must be obtained through approved vendors only unless otherwise specified below or in an applicable policy.
3. Food and beverage items listed below must be used as part of a group religious ceremony, must be made equally available to all participants, must not be shared in a way that is unsanitary (e.g., no drinking juice out of a shared cup), and must not be removed from the area where the group ceremony is taking place. No other food or beverage items are allowed, except as part of a group's approved annual religious feast.
4. In the case of a candle, there shall be only one wick, and the candle must be completely encased in a DOC provided lantern candle holder, with the candle dimensions complying with the safety recommendations of the manufacturer of the lantern candle holder. Only one candle may be used at a time (though more than one candle may be kept in the faith group's locker or other location as required by the Chief Administrative Officer, or designee, so that they may be swapped out for different ceremonies). Tapered candles, floating candles, and tea candles are not allowed. Electric candles are not subject to any of the above restrictions.
5. Not included on the list, but still considered an allowable group religious item, is any item that is available to all general population residents, e.g., body oils, Tarot cards.
6. All religious groups are allowed:
  - a. a religious calendar, max 12" x 12", no spiral binding;
  - b. religious journals;
  - c. religious publications; and
  - d. religious audio CDs
7. Unless otherwise noted below, when not in use, all allowable group ceremonial items must be stored in the faith group's locker or other location, as required by the Chief Administrative Officer, or designee. Each faith group may also store allowable religious publications, religious calendars, religious audio CDs, and religious DVDs in its locker or other location, as required by the Chief Administrative Officer, or designee.

Tribal attire (may not obscure the resident's face) (during ceremony only and stored in group locker)

Honey (approved quantity) and cups (paper or plastic to be disposed of immediately after use) (honey must be stored in its pure form, not mixed with water while in storage) (one drop of honey max. allowed per cup of water for ceremony, any mixture not consumed must be discarded)  
Incense holder with sand and incense sticks (max. 2)  
Individual prayer blankets (max. 60" and 80", approved design only)  
Mead horn (bone) (max. 12")  
Oath ring, wooden (max. 10")  
Pentagrams and pentacles  
Plate (wood or plastic only) (max. 6" diameter) (max. 2)

World Tree ritual tool (wooden tree with plastic leaves) (max. 12" high)
