

MAINE DEPARTMENT OF CORRECTIONS

COLLECTION PRIORITY LIST

Collections are to be made from a resident's General Account only, unless the collection type is noted with an asterisk*, in which case collections are to be made from both the General Account and the Phone Account. Collections from earnings are figured based on gross earnings (unless, in the case of a DHHS ongoing child support order, net earnings are specified in the order).

Note: Collections are not to be made from any benefits checks sent directly to a resident from the Veterans Administration except for the following obligations: child support, court-ordered filing fees (federal and state), and medical co-pay, unless the resident specifically requests the funds, or a portion thereof, be applied to another obligation.

1.	Account corrections (including for "bounced" deposits)*	(100% of current balance, up to amount owed) (thereafter 100% for DOC error or 50% or other agreed upon % for "bounced deposits," up to amount owed, including savings account portion of general account)*
2.	Court-ordered restitution	(25%)
3.	Court-ordered penalties, fines (including Victim Compensation Fund assessments), surcharges	(fines collected after court-ordered restitution is paid in full) (25%)
4.	Child support Back child support*	(100% of current balance, up to amount owed, including savings account portion of general account)*
	Ongoing child support	(Specified amount or percentage in DHHS order, whichever is less, from earnings only)
5.	Order to Execute Civil Judgement*	(100% of current balance, up to amount owed, including savings account portion of general account)*
6.	Order to Enforce Payment after Default/Order on Payment of Fines	(25%)
7.	Court-ordered filing fees-federal*	(Initial partial fee as court ordered, including savings account portion of general account, then 20% each time the total amount in the accounts exceeds \$10)*
8.	Court-ordered filing fees-state	(Initial partial fee as court ordered, including savings account portion of general account, then 20% each time the total amount in the account exceeds \$10)
9.	Court-ordered attorney's fees	(25%)

10.	Back taxes*	(25%)*
11.	Room & Board (Adults)	(10% from work release and remote work earnings only)
12.	Room, Board, & Transportation (Adults) (only if the DOC provides transportation)	(20% from work release earnings only)
13.	Facility restitution (through disciplinary process)	(25%)
14.	Monetary sanctions (through adult disciplinary process)	(25%)
15.	Medical co-pay (including co-pays for medical services, dental services, medications, and prosthetic devices) (Adults)	(100%)
16.	Technology fee (Adults)	7% or \$35, whichever is less, from earnings only and only if there are earnings of at least \$100 during the month, with earnings to be figured after all above listed deductions are made, as applicable, except for account corrections.
17.	Technology fee recovery (Adults)	(100%)
18.	Savings (Adults)	(10% from earnings only)
19.	Facility charges	(100%)
20.	Replacement ID Card	(100%)
21.	Miscellaneous	(100%)
