## 1.0 Population & Demographics

**1.1 Average Daily Population (ADP)** The ADP has changed significantly over the last six years. From its peak in 2018 the census for both male and female residents saw decreases though 2021. In 2022 males stayed similar, but the female population began to rise. 2023 showed an increase in both male and female populations. From the high in 2018 to the current year 2023, there was a decrease in ADP of 625 male residents (28%). In comparison, the female population decreased by 62 since 2018 (26%).

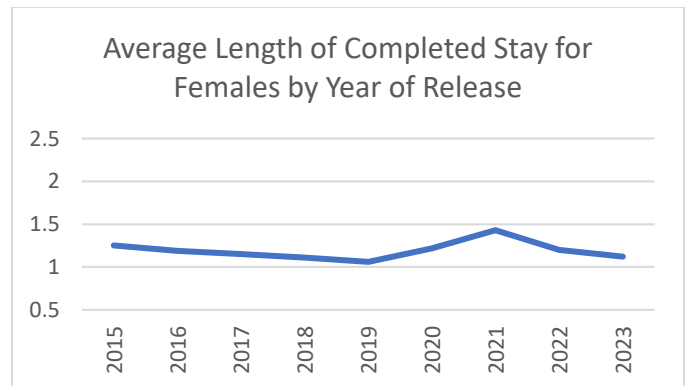
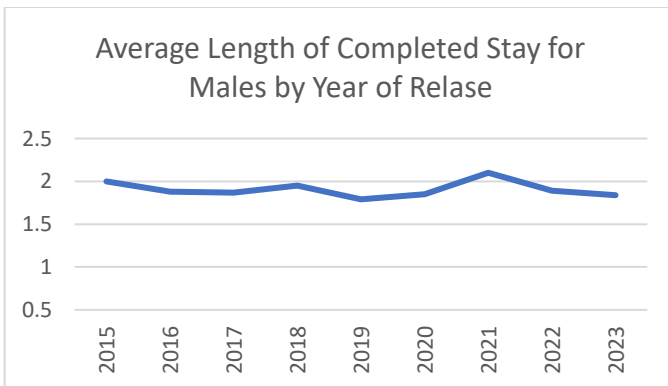

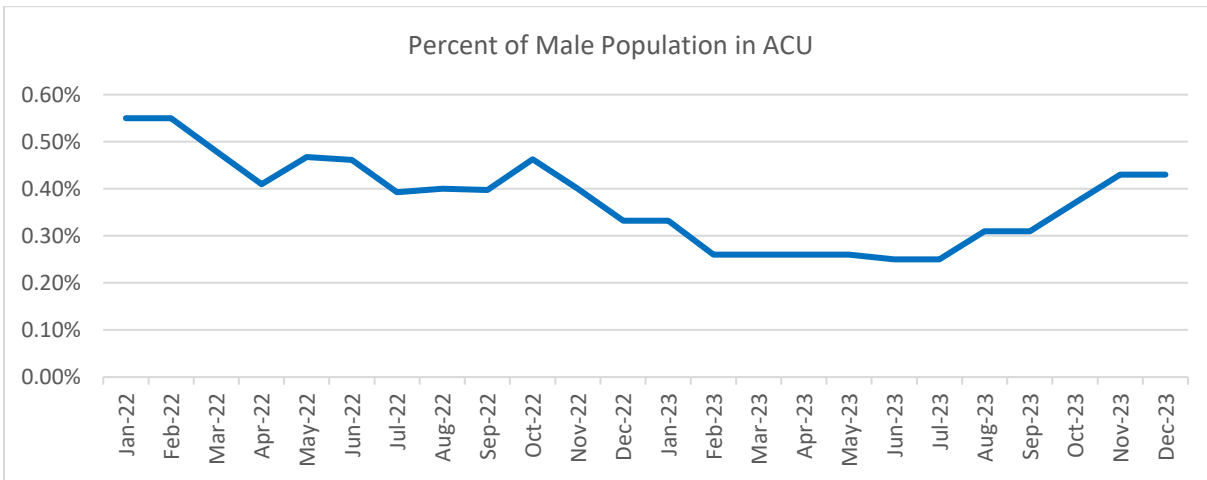
## 1.4 Administrative Control Unit Population

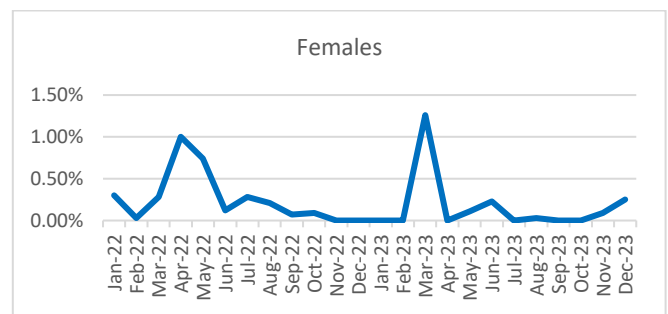
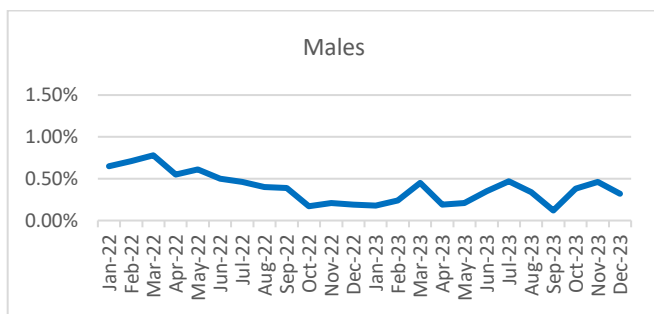

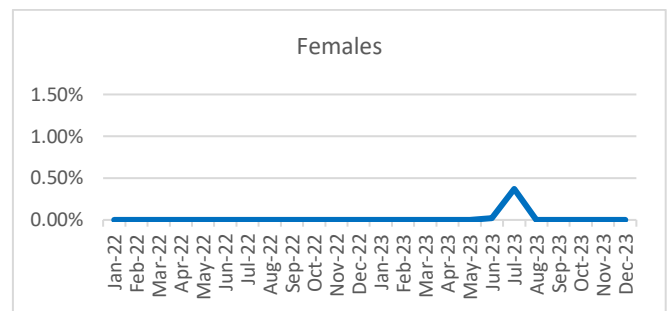
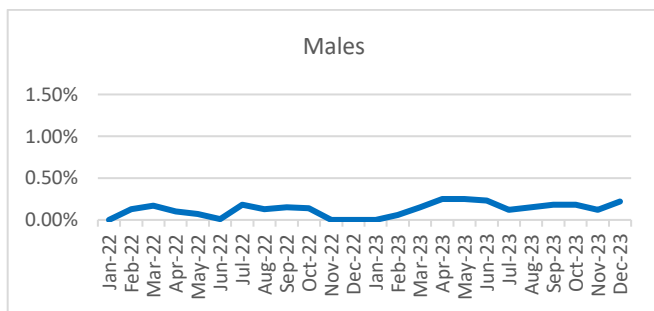
## Average Daily Population in Restrictive Housing as a Percent of MDOC Total Population

## 1.6 Intensive Mental Health Unit Average Population

The Intensive Mental Health Unit (IMHU) is located at the Maine State Prison. The purpose of the IMHU is to treat and help stabilize those with severe and persistent mental health conditions within MDOC adult facilities, as well as residents of county correctional facilities who need intensive mental health stabilization services. The average daily population (ADP) year over year has not varied much, although the day-to-day census varies within a few residents.

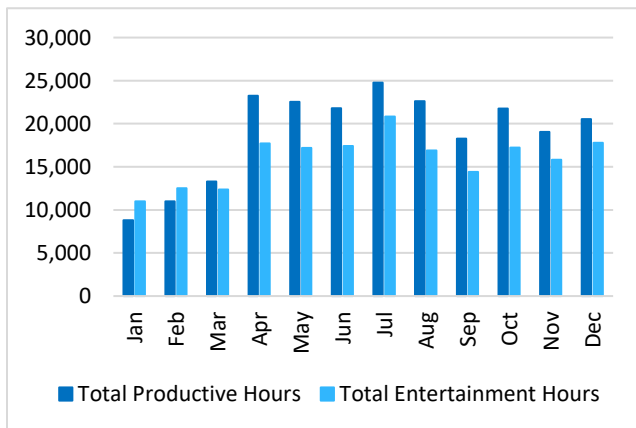
## 2.3 Programming Tablets

Programming and entertainment tablets are available to residents at specific levels in the following facilities: Maine State Prison, Maine Correctional Center, and Mountain View Correctional Facility. They are corrections grade and operate on a closed, managed network that allows residents access to thousands of hours of free academic, vocational, life skills, and therapeutic programming designed for all learning levels.

## **2.4 Case Management**

Case management and programming had a comeback year in 2023, enjoying a year free of most pandemic related restrictions. It was a year in which our focus was getting back to the basics of effective case management practices while simultaneously enhancing programming availability to all residents trusted to our supervision.

All case managers participated in targeted training at Central Office. Case managers completed Ethics training, a training on Cognitive Behavioral Therapy and one especially well received presentation by community providers who shared regarding their available services to our releasing population. We hosted Recidiviz, a non-profit partner that assists the Department in advancing the use of our data, as they rolled out their user-friendly Supervised Community Confinement Program tool that is utilized by case managers across the DOC. All Central Office gatherings were well attended, and staff enjoyed a level of normalcy in the social connections which had been limited during the pandemic.

2023 was also a year in which core programming (risk reduction) really exceeded pre-pandemic availability. Specifically, interventions addressing domestic violence were active year-round. Secure facilities (MSP and MCC) completed four cohorts while MVCF and BCF completed two. This program was made available at BCF for the first time. As a result of the efforts of facilitators at each facility, residents were able to address a high need area and move forward in the MDOC system. In total, 72 residents completed the high intensity Cognitive Behavioral Intervention for Domestic Violence while 108 residents completed the less intensive SAFE (Stopping Abuse for Everyone) programming in 2023.

The Programming Division also was active in enhancing recovery opportunities for our residents. The formation of a Resident Recovery Steering Committee was solidified. This committee consists of a resident representative from each facility with the charge of creating recovery pathways for residents of the MDOC. They assisted in the creation of local recovery councils as well as participated in the creation of a solid infrastructure to support Recovery Coaching in all facilities. Through an MOU with Portland Recovery Community Center, more than 75 new recovery coaches were trained and provided more than 4,500 hours of support to their peers in recovery. These efforts will only expand in the year 2024. The folks on the Steering Committee also guided their facilities in creating a very dynamic and informative Recovery Month in September.

Late in 2023, DOC partnered with author of the book "My Addiction and Recovery," Ed Kressy, in piloting a virtual recovery program entitled "Recovery and Writing" or RAW. With a cohort from the Maine State Prison and one from the Maine Correctional Center, groups of men were provided a copy of Ed's book and attended a weekly virtual recovery meeting dedicated to hearing a speaker in recovery and then being provided journaling prompts. All the speakers are well known nationally (some internationally). The initial success of this group is overwhelming. The participants at MSP have never missed a group. This opportunity is being extended to include youth at Long Creek Youth Development Center in 2024.

## 3.6 SCCP Cases

The purpose of the Supervised Community Confinement Program (SCCP) is to provide a means of successful reentry of adult facility residents into the community. Residents transferred to supervised community confinement are still considered to be in the legal custody of the Department while in the program. The place of confinement is in the community, rather than in a Department facility. Participation in this program is a privilege which may be afforded to eligible residents who meet the criteria.

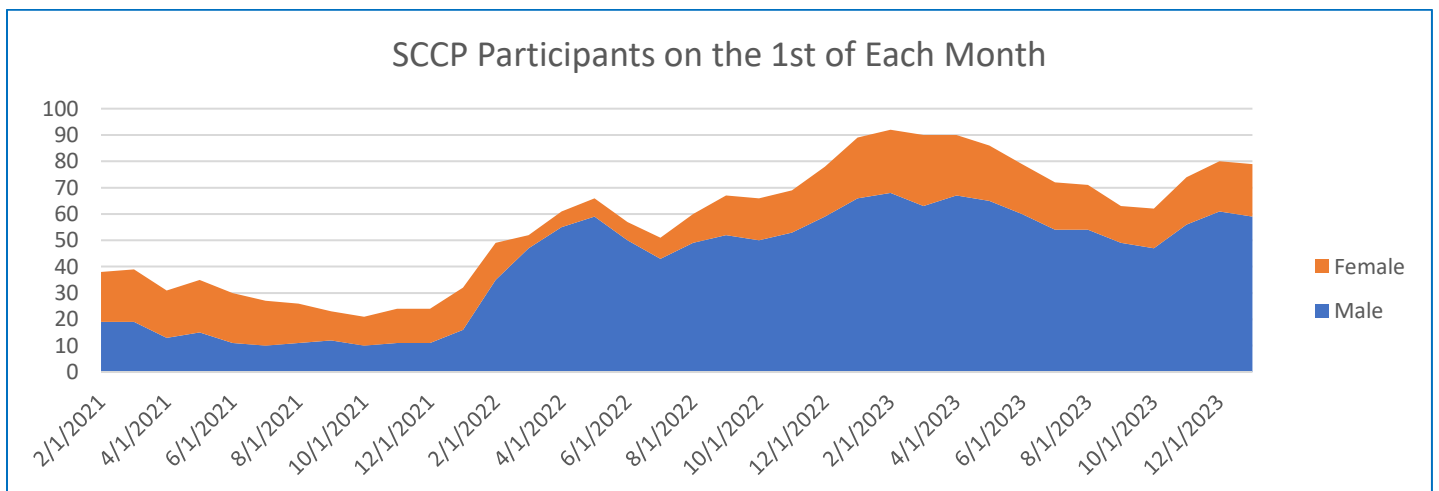

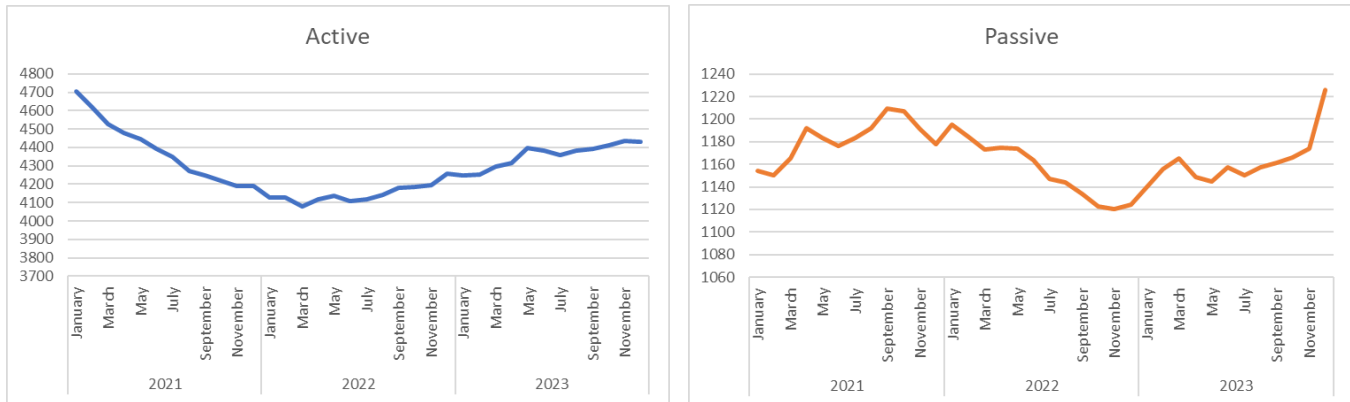




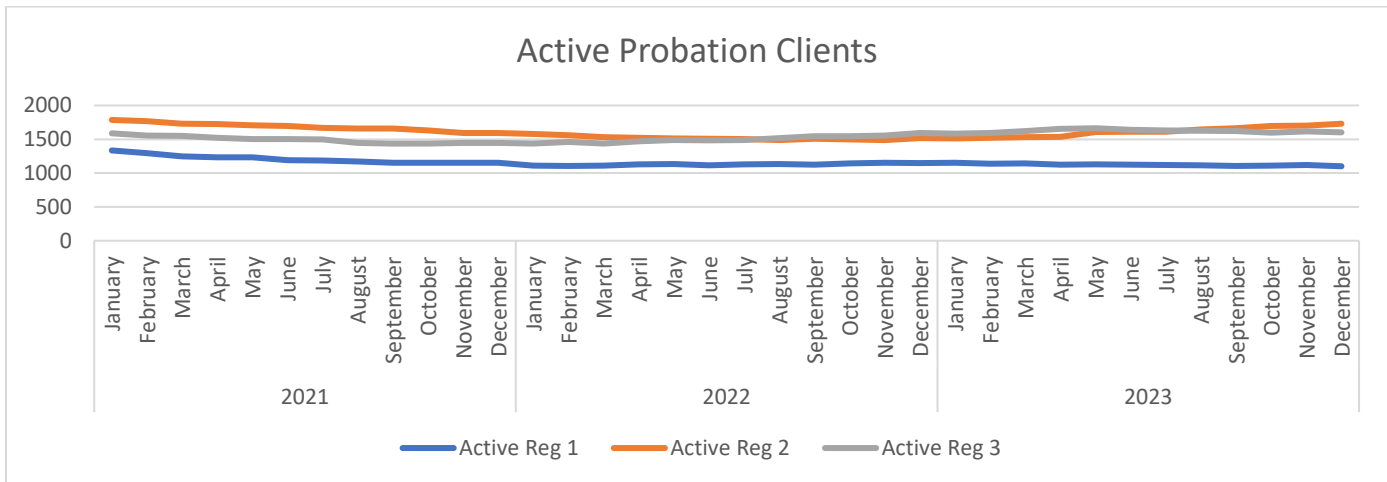

### Adult Community Corrections Population Overtime

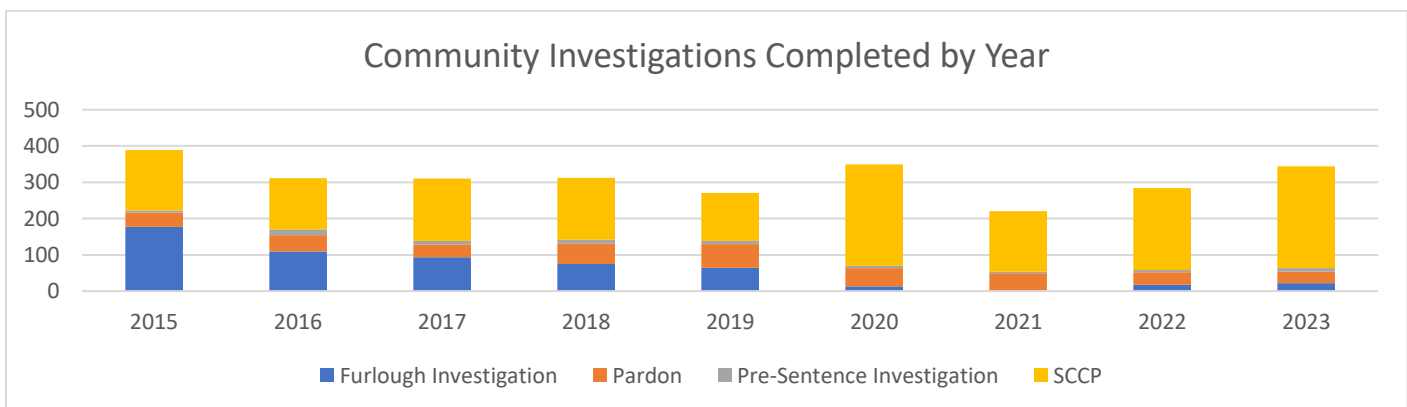

### Community Investigations Completed by Year

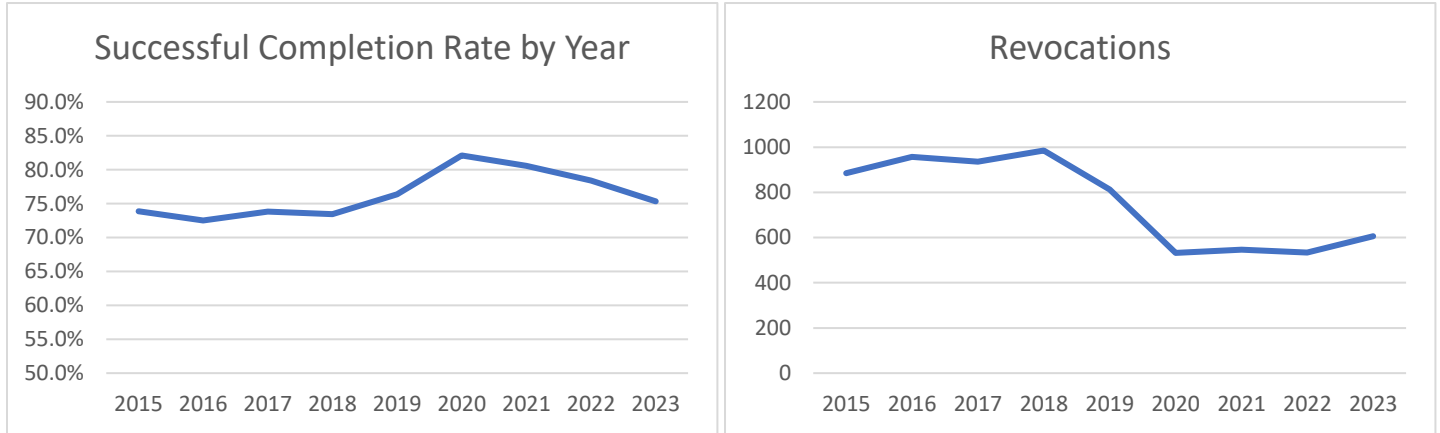

A completion of probation is considered successful when a client is transferred from probation to society because their probation has terminated due to completion of the sentence. Should a client have a full revocation, or a partial revocation with termination, then their probation ends unsuccessfully.

## Community Transition House - Leading the Way

Leading the Way is a 12-bed community-based transitional living program in Bangor. It provides safe, structured, living with connection to community supports and services. These include behavioral health, independent living skills, and other targeted intervention services. Clients can stay rent free for up to 6 months. Referrals come from MDOC facilities' Supervised Community Confinement Program (SCCP), Probation Offices, and criminal justice programs like drug court.

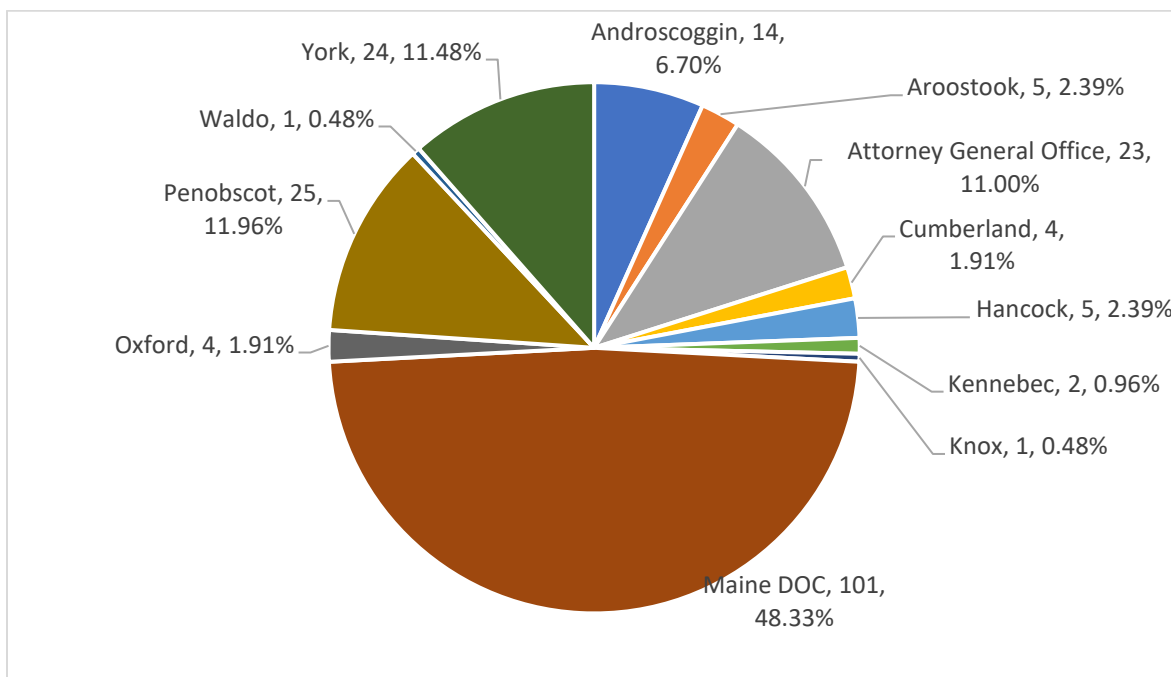


## 5.0 Office of Victim Services

The MDOC OVS is required to ensure that victims who request notice of release receive it according to Maine Criminal Statutes 17-A §2106 “Notification of defendant’s release or escape”. MDOC polices were formed outlining preferred practice. The Statute requires victims to submit a Victim Notification Request with the office of the attorney for the State or directly to the MDOC in order to receive notification of release. Once a Victim Notification Request is filed, the victim must receive notice of the resident’s unconditional release and discharge from institutional confinement upon the expiration of the sentence or upon release from commitment under Title 15, section 101-D or upon discharge under Title 15, section 104-A and must receive notification of any conditional release of the resident from institutional confinement, including probation, supervised release for people with problem sexual behavior, parole, furlough, work release, funeral or deathbed visit, supervised community confinement, home release monitoring or similar program, administrative release or release under Title 15, section 104-A; and must receive notification of the resident’s escape.

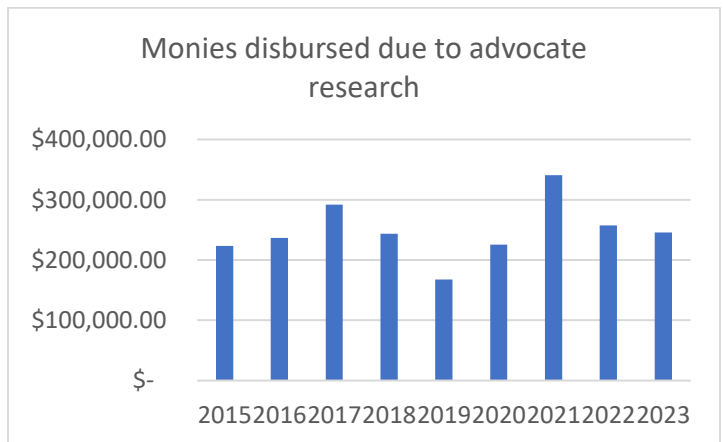
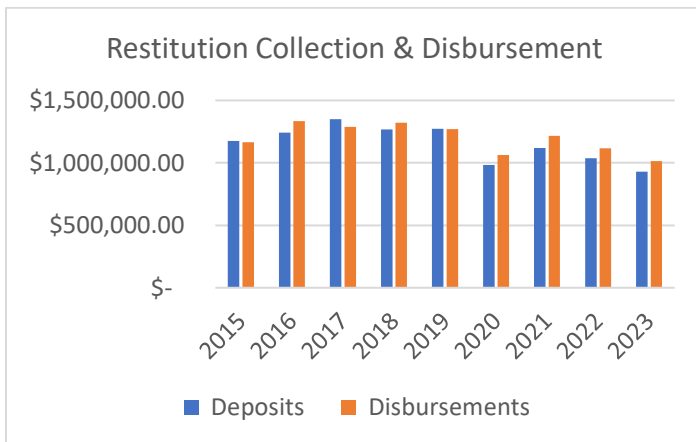

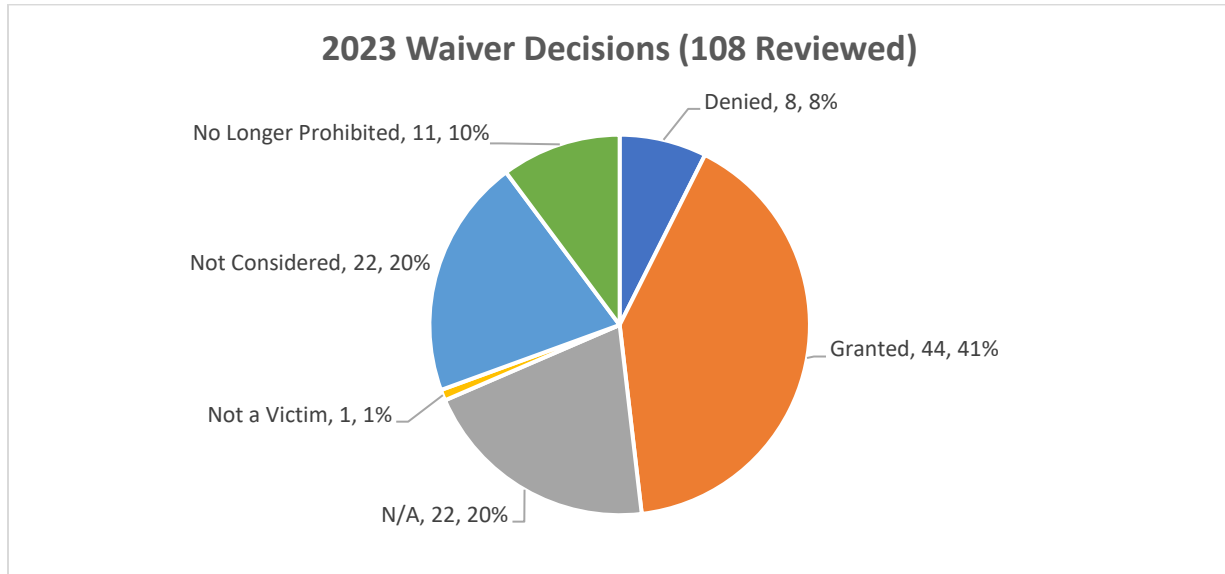
The OVS assisted victims with restitution in which they are to receive per Court order for losses they have incurred. OVS provided information and resources related to these restitution cases in which the MDOC is responsible for the collection of such restitution either through Probation, at the facilities or through the Maine Revenue Service. The OVS acts as a liaison between the victim and Probation and Parole, District Attorney’s Office and the Courts in order to provide resources, information and options for the victim to obtain their restitution while advocating for victims and advising victims of their rights.

According to policy 6.3, contact with victims, waiver requests for contact are reviewed and approved by the Commissioner, or designee. The OVS continues to assist MDOC facility staff providing support regarding this policy. The Director of Victim Services reviews all waiver requests as the Commissioner’s designee.



OVS participates in several statewide stakeholder commissions, panels, and other board and association memberships in order to be a voice for victims and an information source regarding the rights of victims. Additionally, presentations are made regularly in order to promote victim services and educate the MDOC and other stakeholders across regarding victims’ rights and statutes, the victim services offered at the MDOC, and policies and procedures pertaining to such. The OVS completed 15 presentations and trainings in 2023.
