Dear fellow Juvenile Justice Stakeholders,

The Maine Department of Corrections (MDOC), Division of Juvenile Services is committed to reducing the use of institutional secure confinement by increasing the capacity and use of community-based programming and supports.

In the last five years, the Division of Juvenile Services has significantly reduced the use of secure confinement (Long Creek Youth Development Center) by strategically investing in community-based programming for justice involved youth. These investments target three major areas: Referral (pre-adjudication), Supervision (probation), and Commitment/Reentry.

The attached Juvenile Justice Overview Report provides statewide and regional metrics identifying the three major target areas listed above.

I would like to thank all the MDOC staff, community providers and stakeholders for contributing to this work.

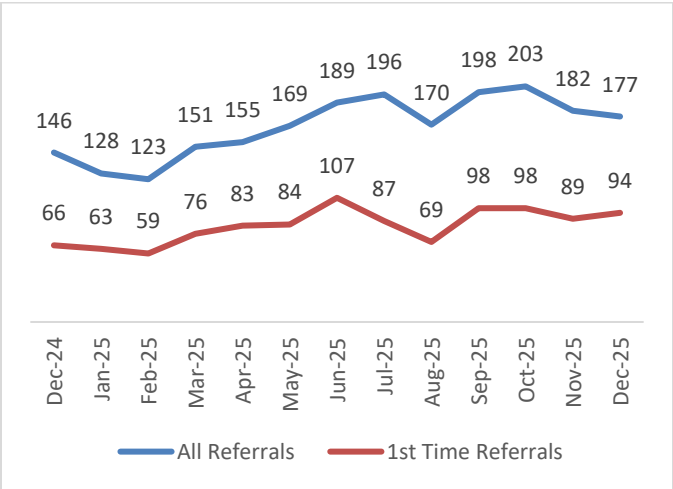

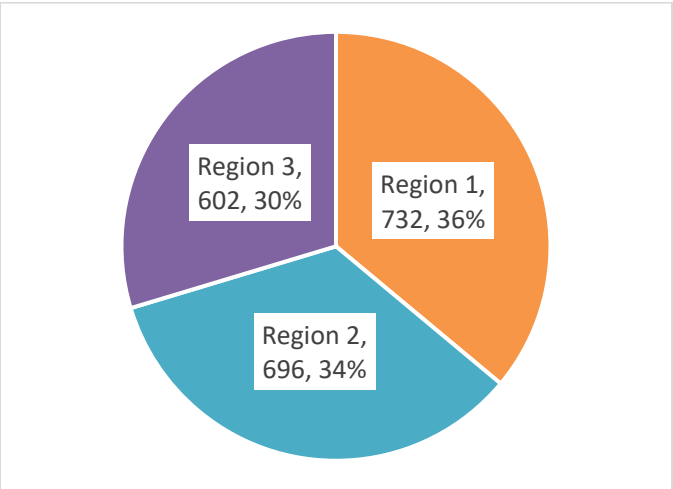

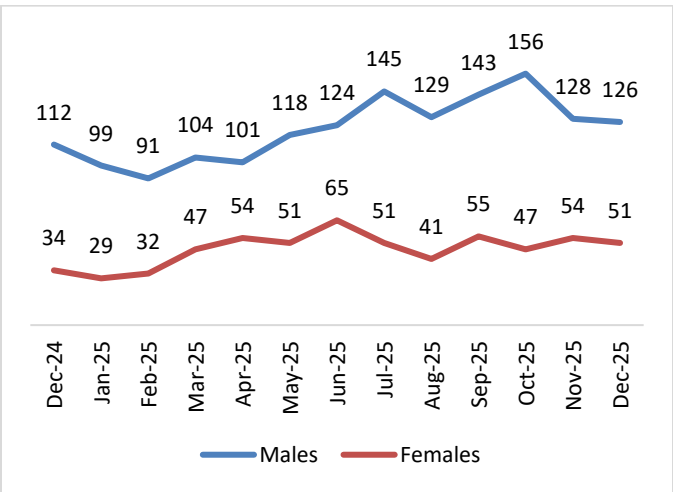
Referrals over the past Year (All and 1st Time)



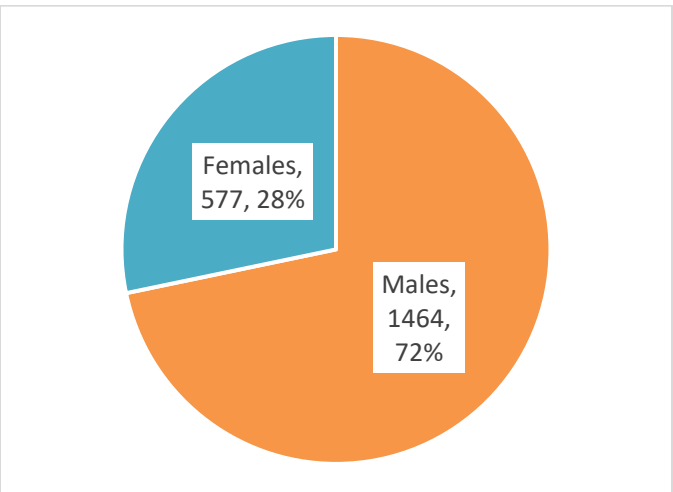
All 2025 YTD Referrals by Region



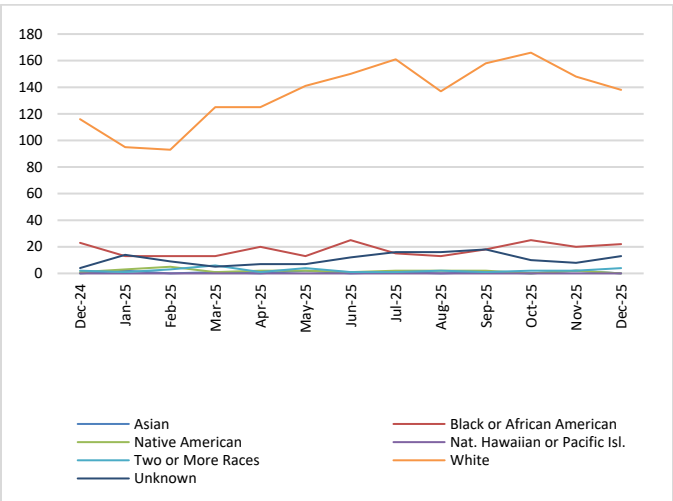
All Referrals by Gender



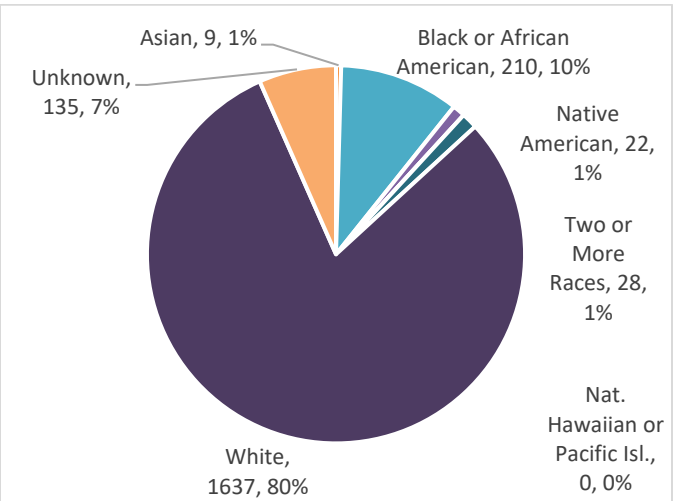
All 2025 YTD Referrals by Gender

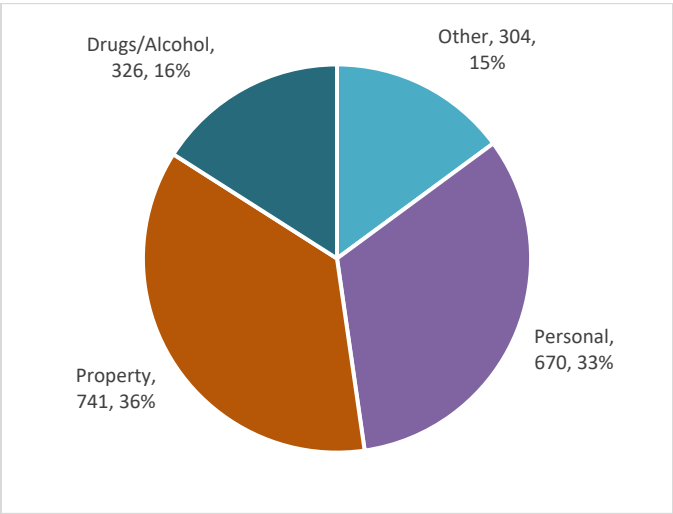

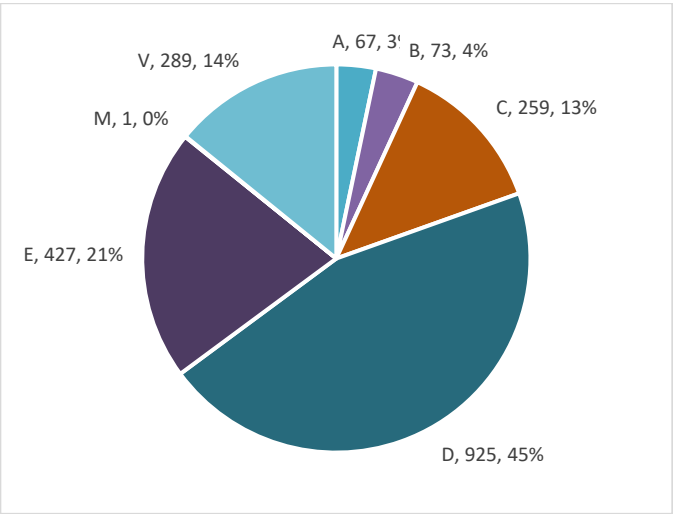

All Referrals by Offense Type 2025

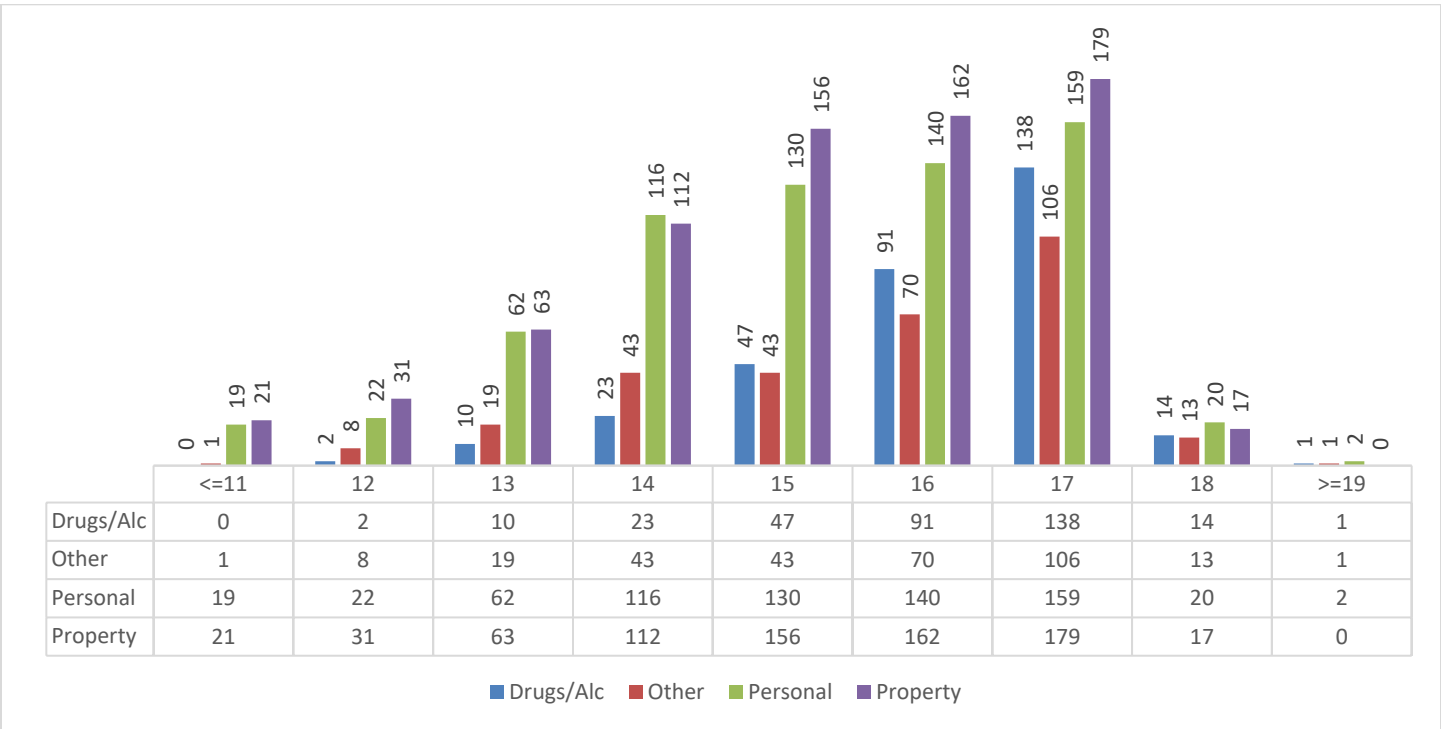


All Referrals by Offense Class 2025



All Referrals by Age and Offense Type 2025

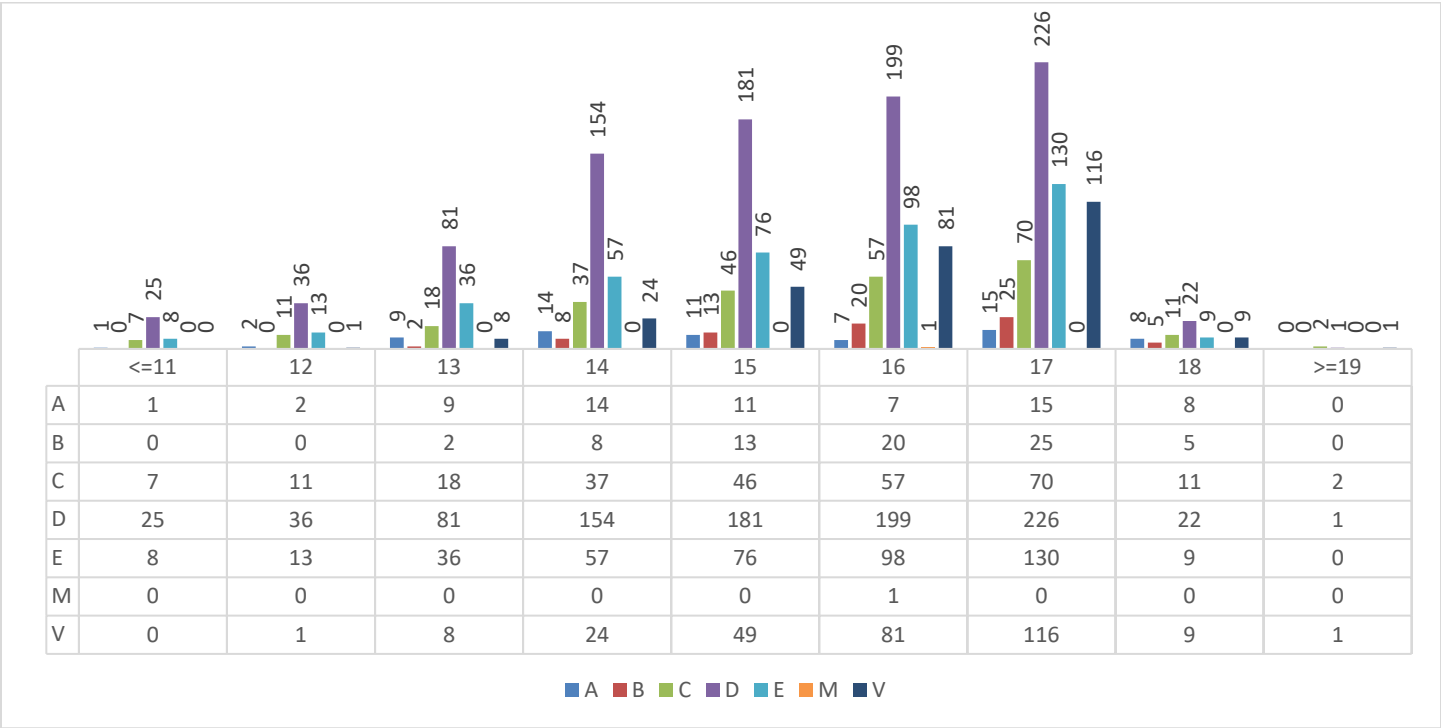

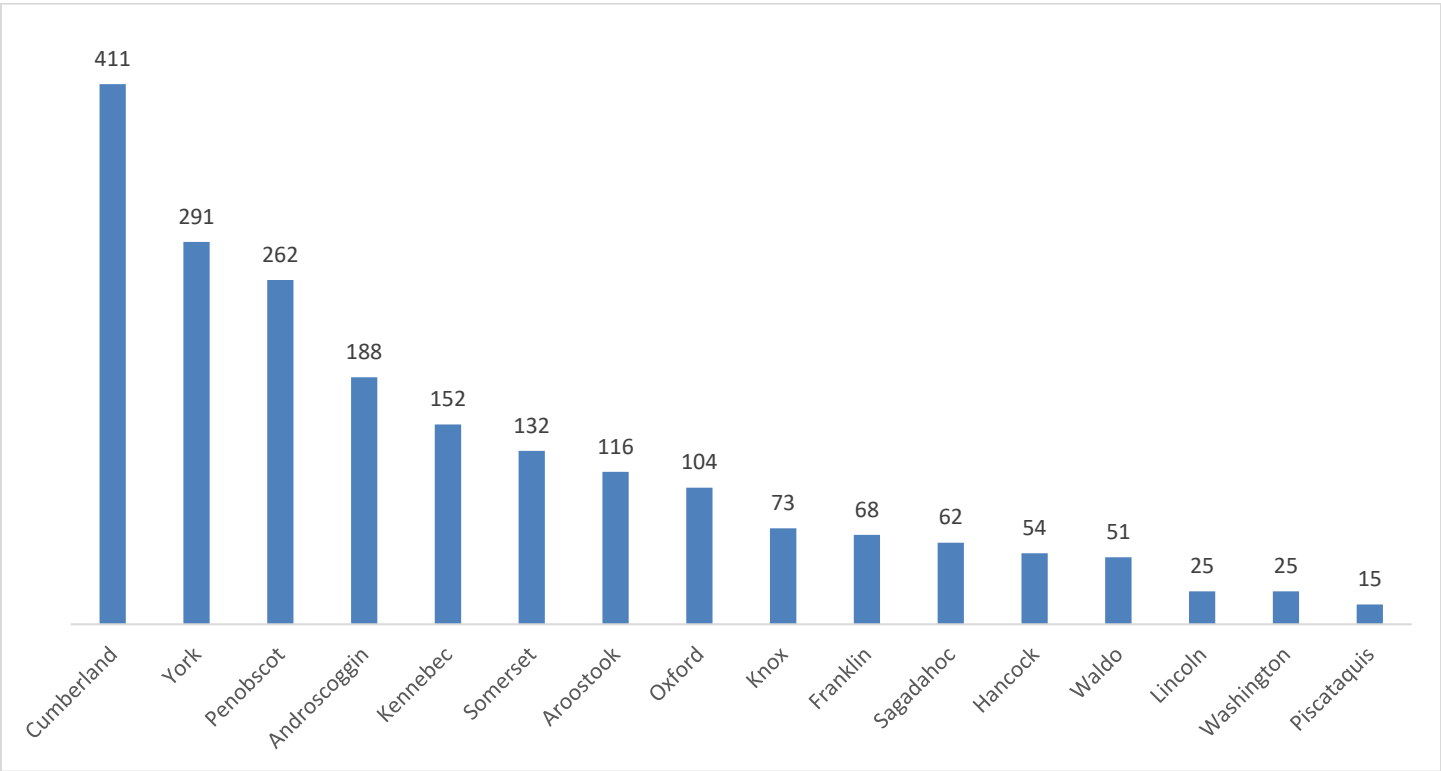

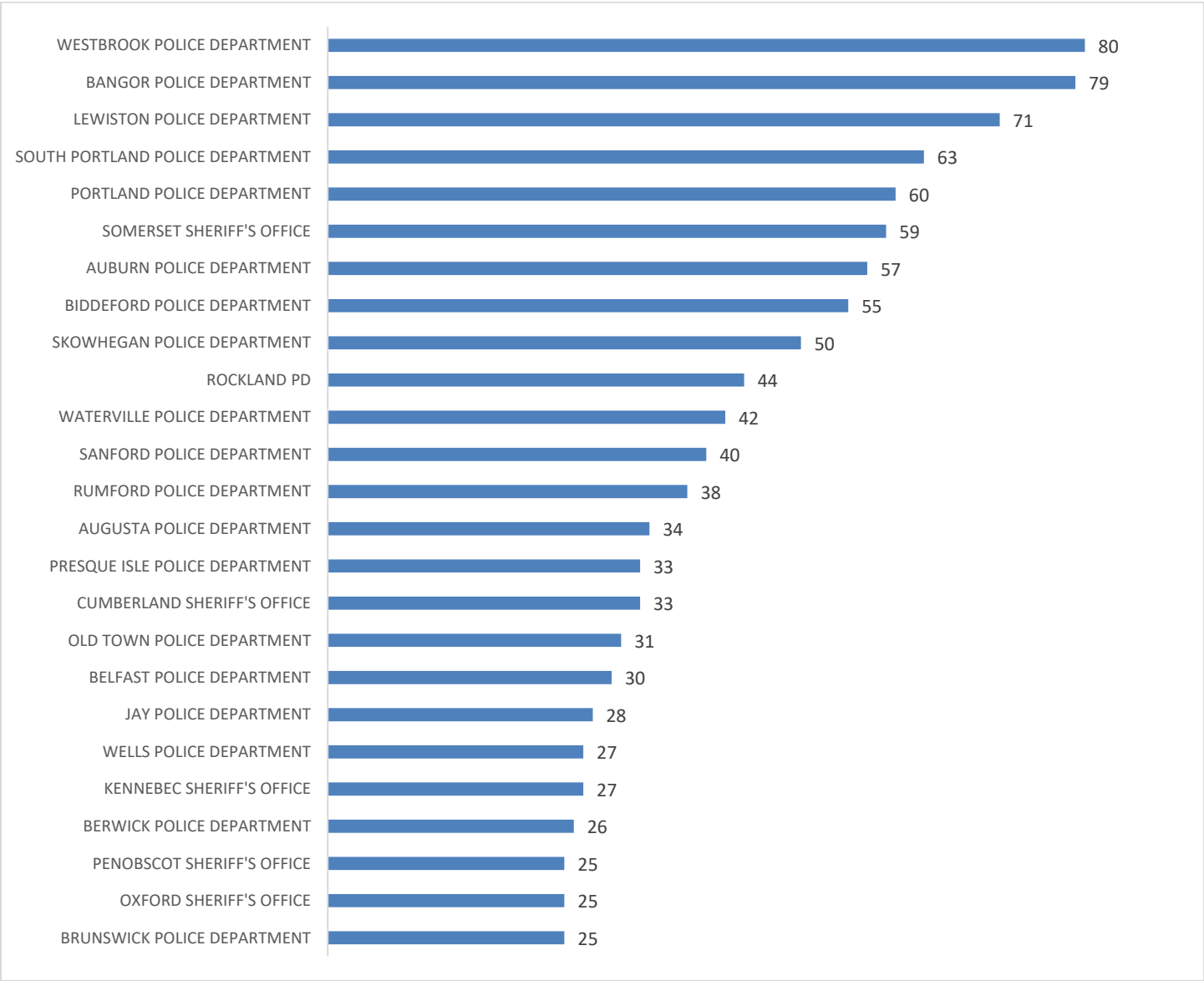

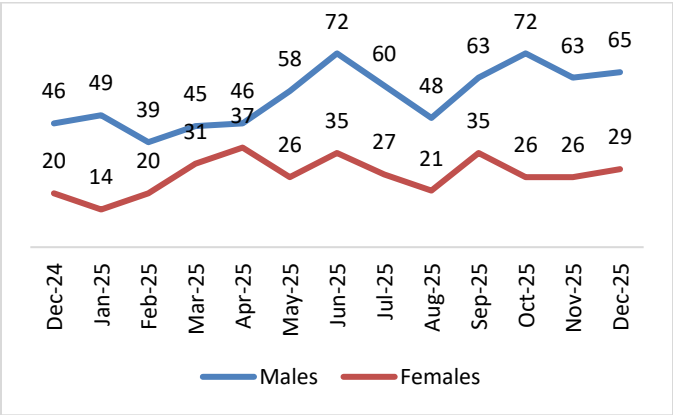
All Referrals by Police Agency (Top 25) 2025



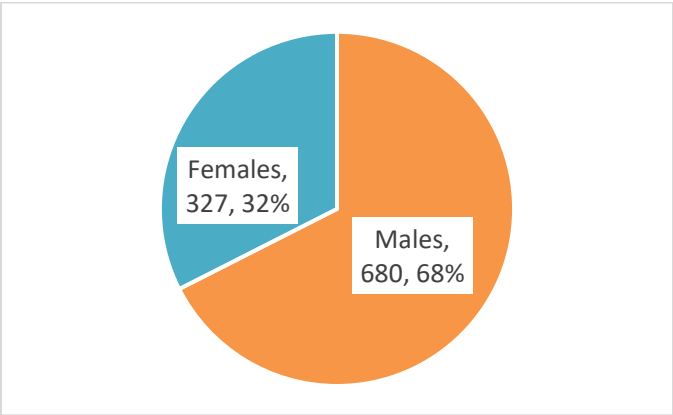

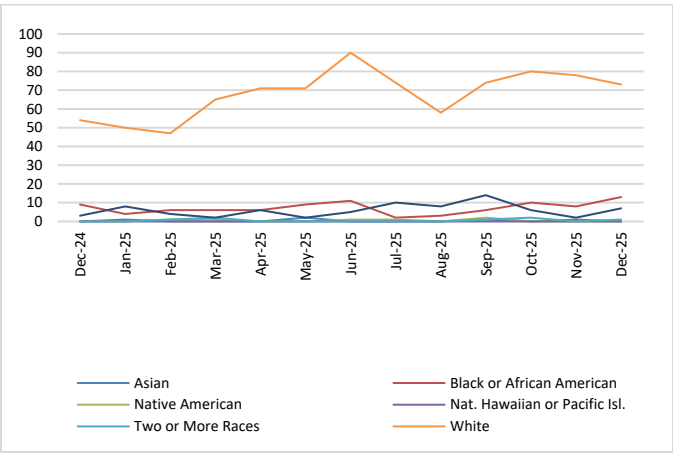
1st Referrals by Gender over the past 12 months



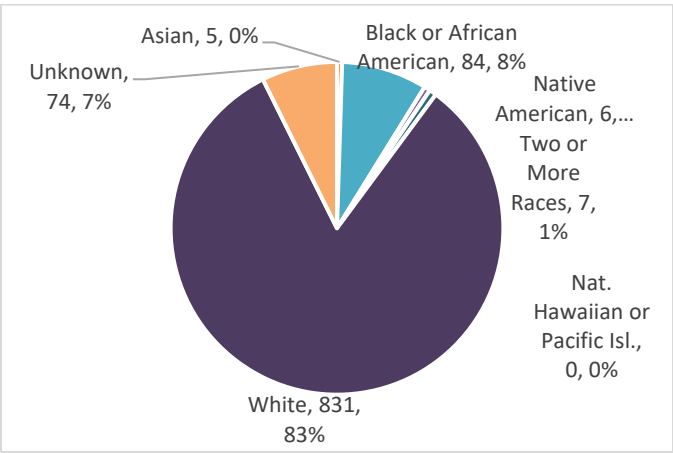
1st Referrals by Gender 2025



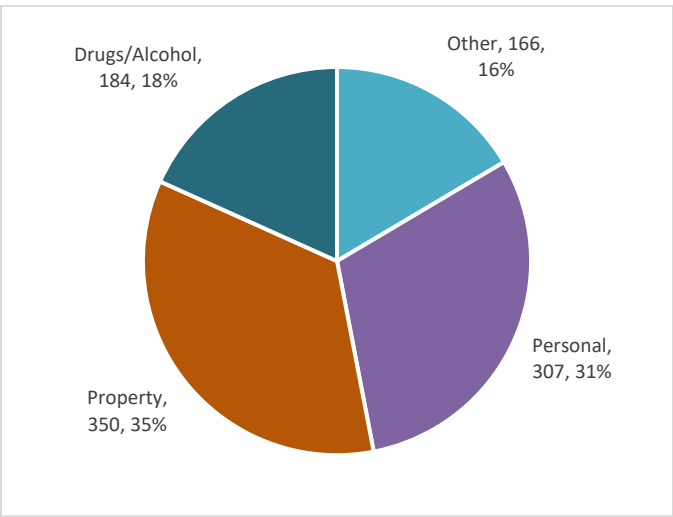
1st Referrals by Race over the past 12 months



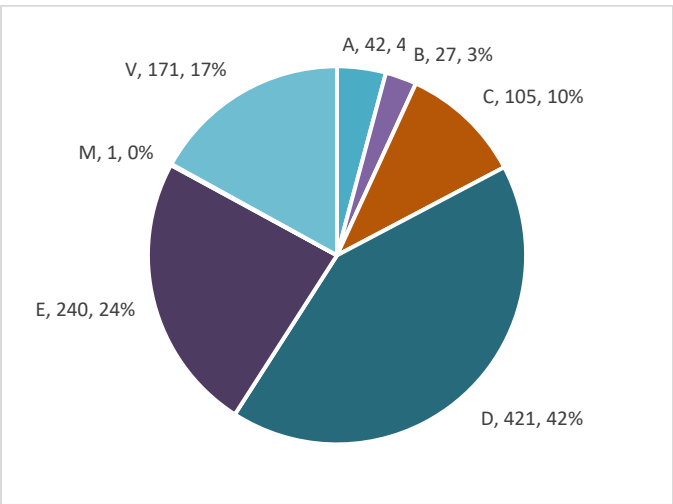
1st Referrals by Race 2025

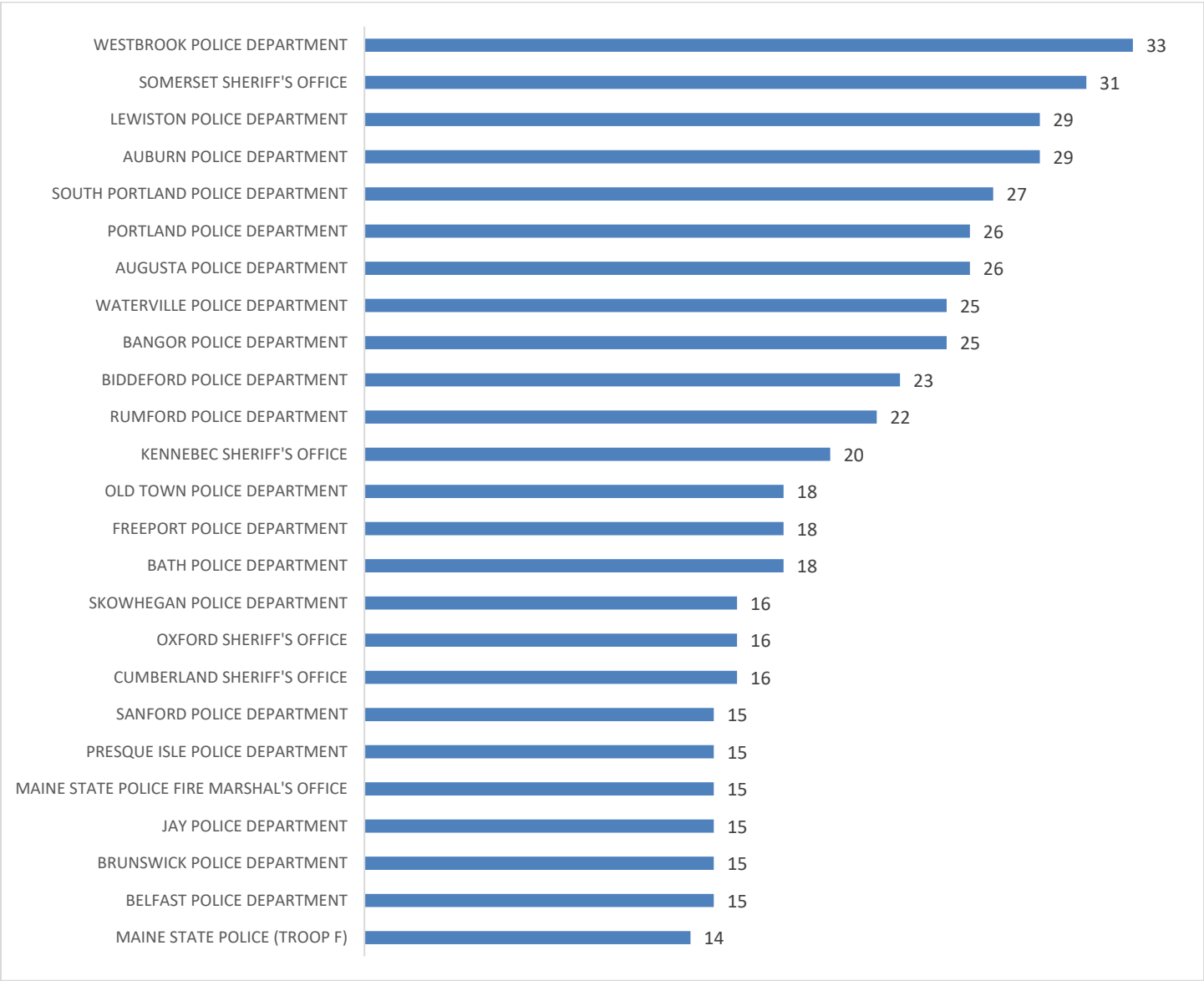

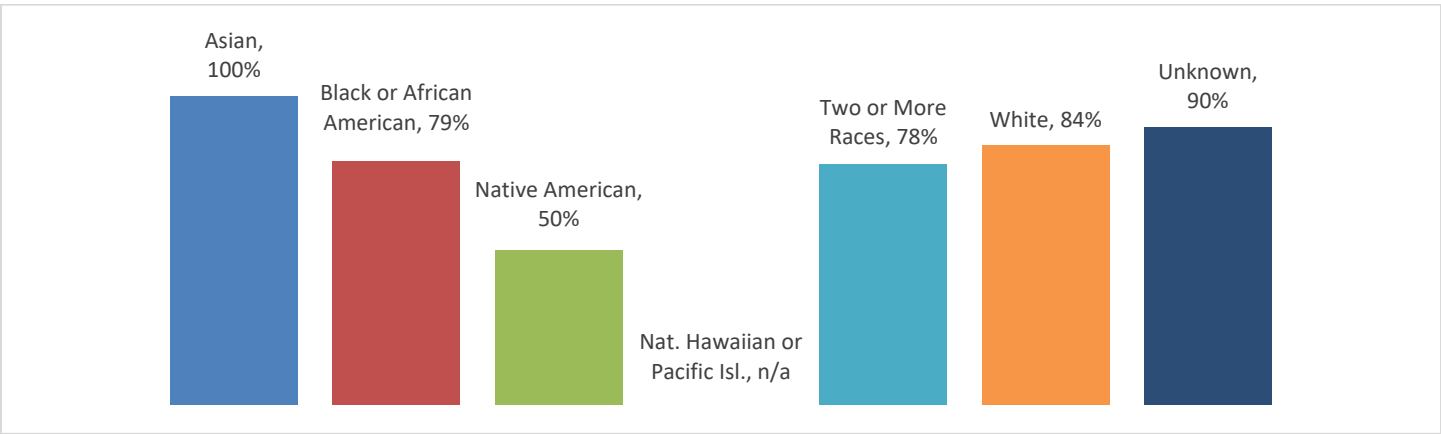

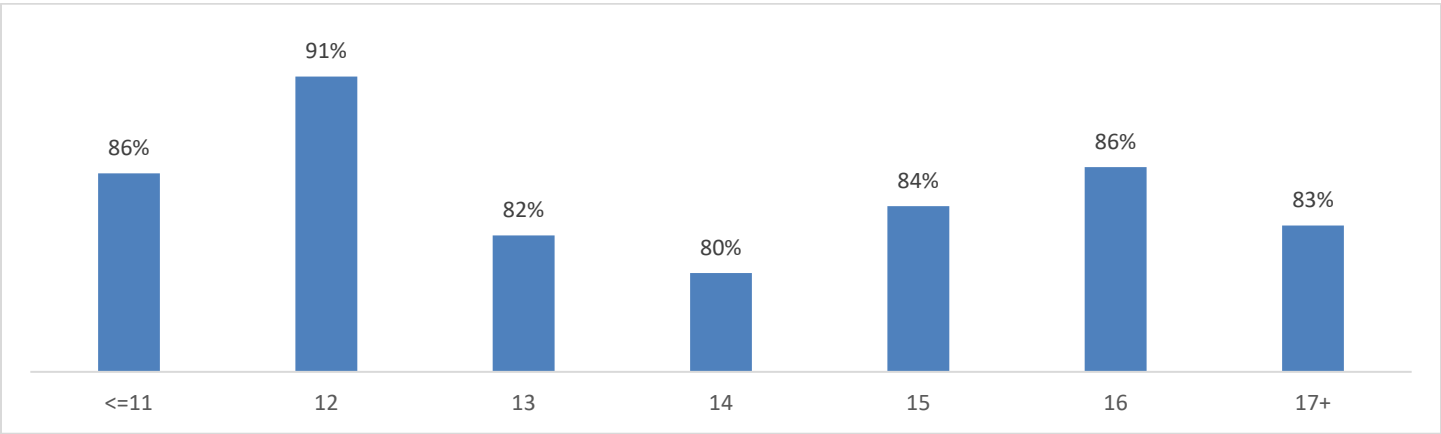
Referral Diversion Rates by Gender

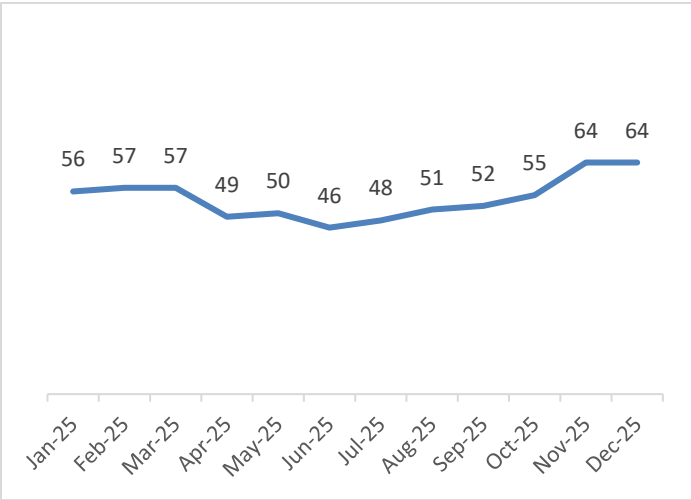

This graph illustrates the number of juveniles on probation each month.

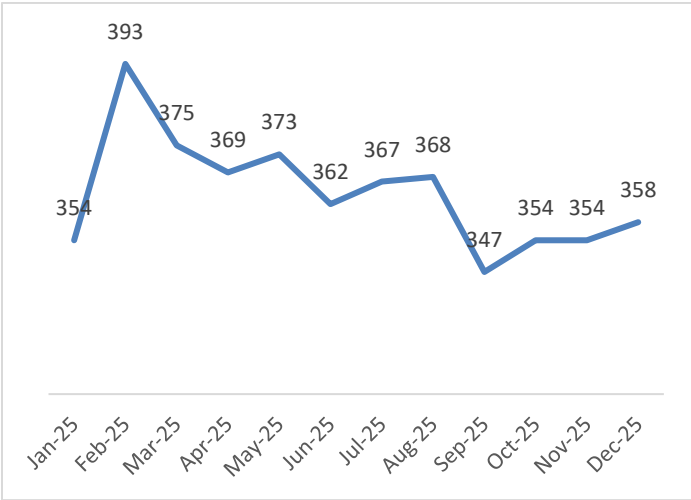
The average number of juveniles on probation each month in 2025 was 54.

The average number of days juveniles spent on probation in 2025 was 365.

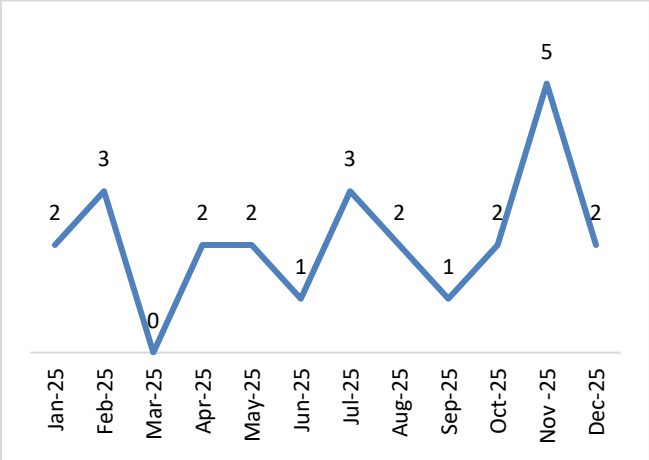




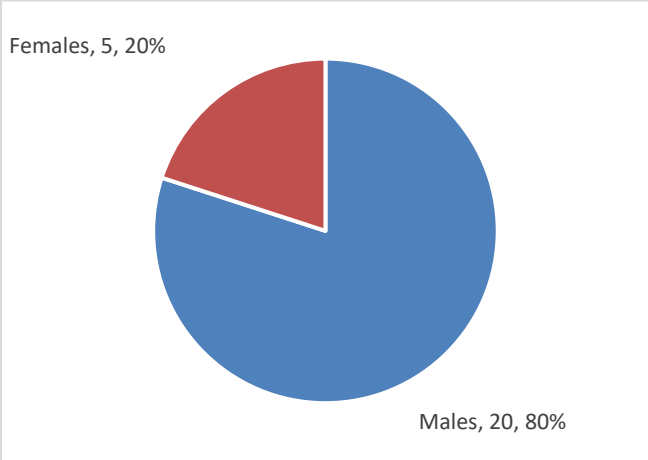

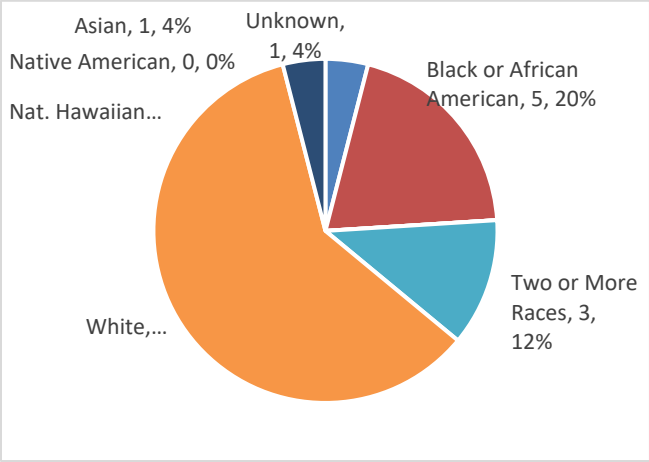
Specified Period of Confinement up to 30 Days

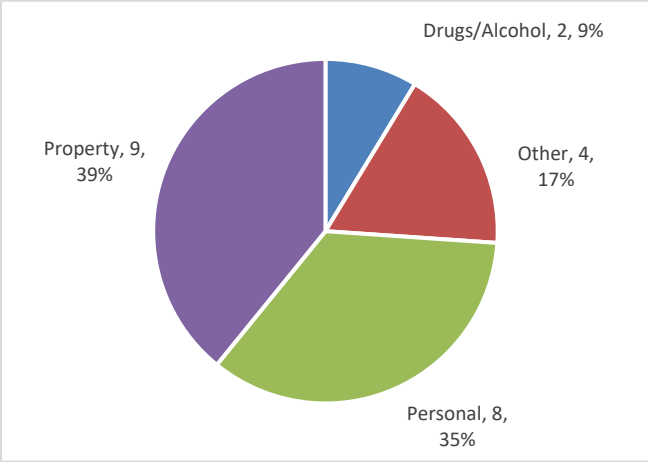
Specified Period of Confinement up to 30 Days by

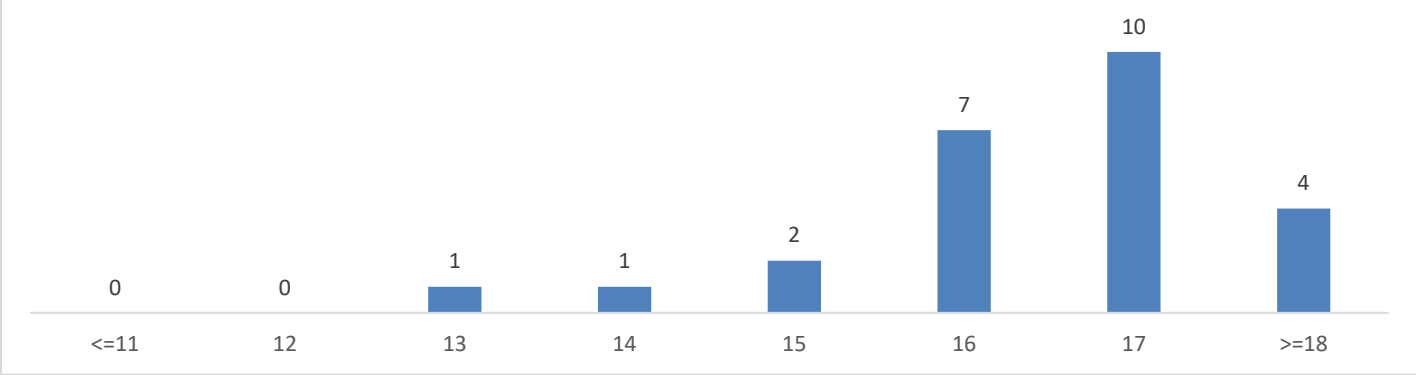

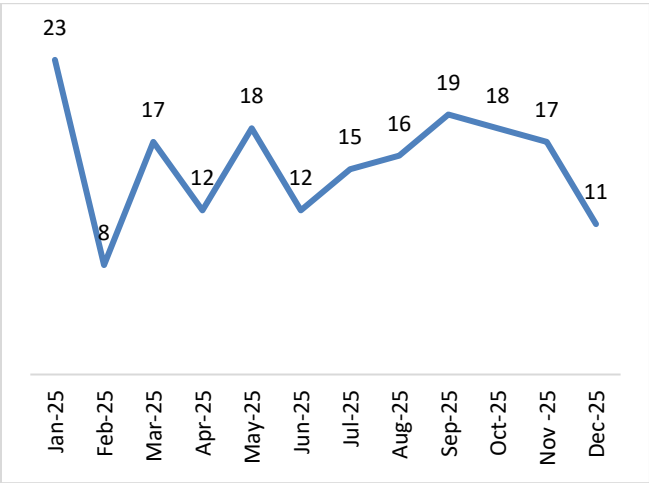

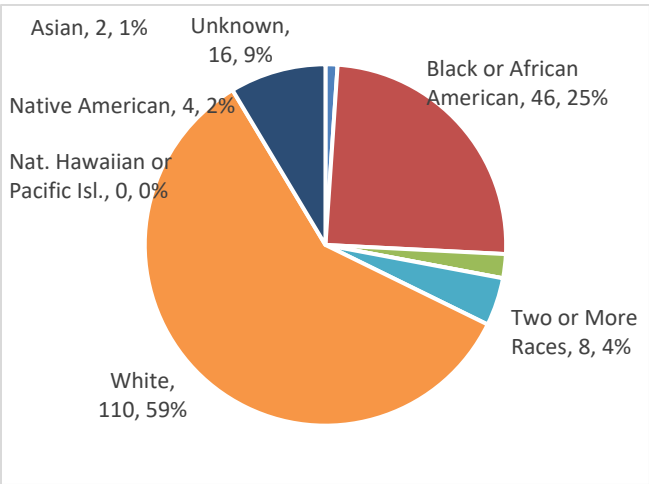
Detention Admissions Over Time



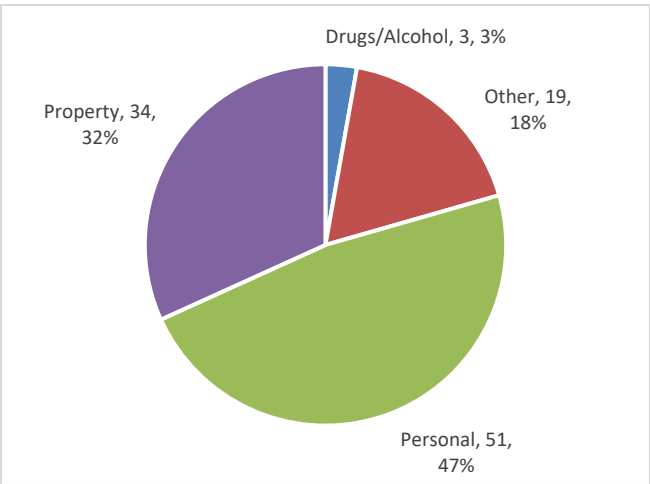
Detention Admissions by Gender 2025



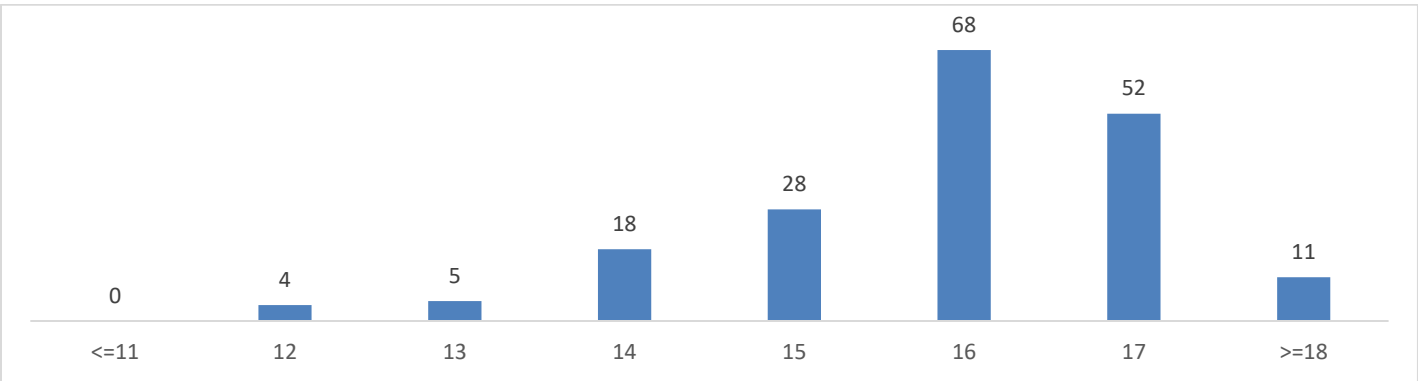
Detention Admissions by Race 2025



Detention Admissions by Offense Type 2025



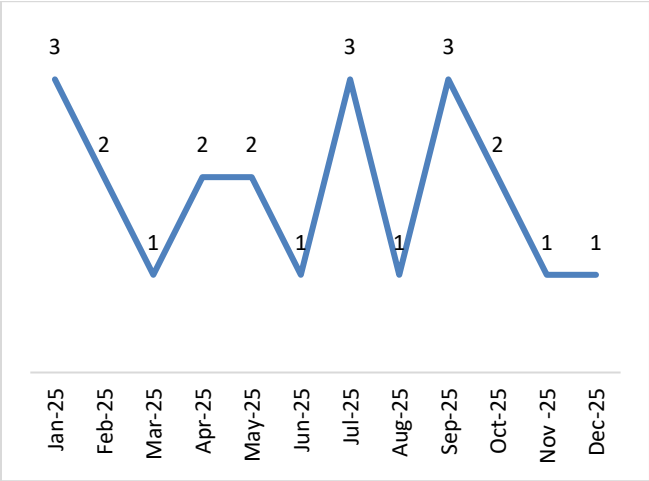

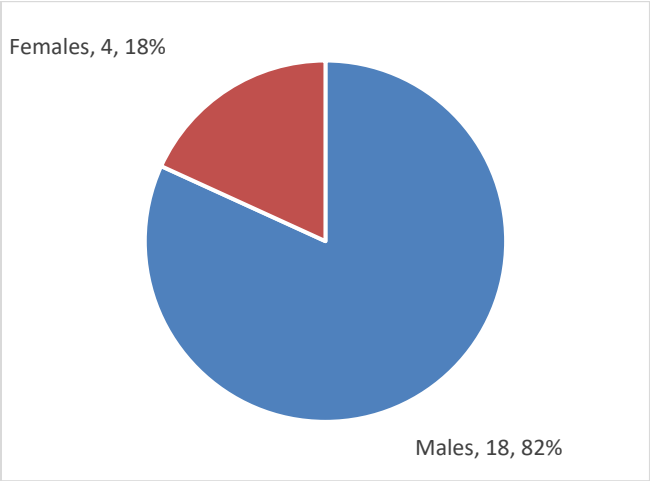

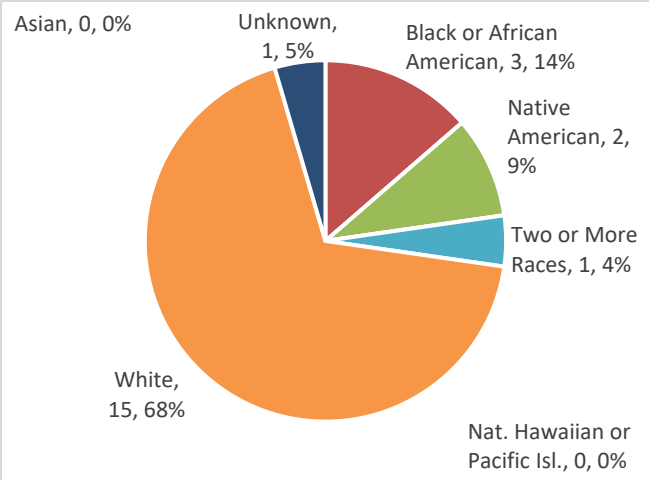
Indeterminate Commitments Over Time



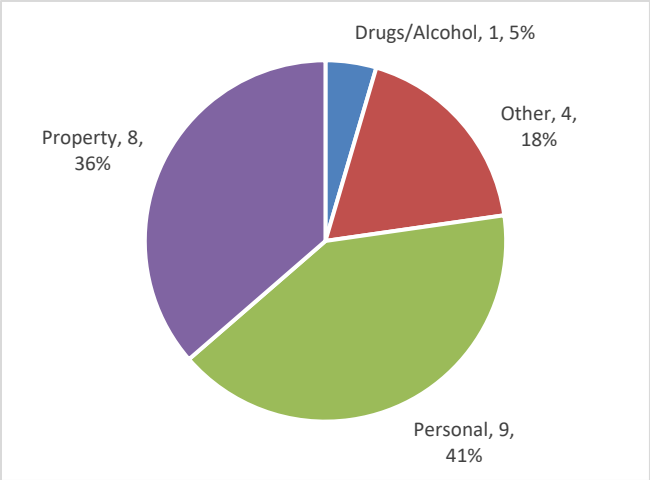
Indeterminate Commitments by Gender 2025



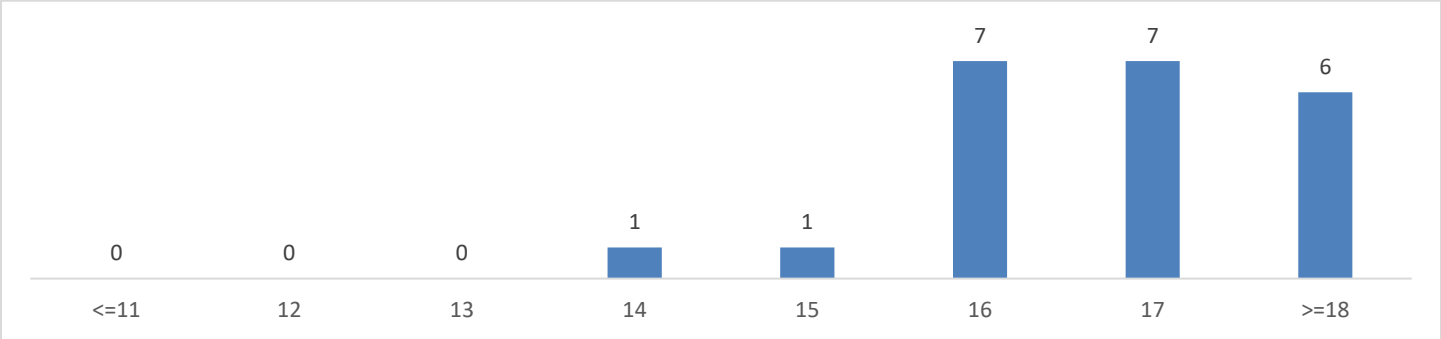
Indeterminate Commitments by Race

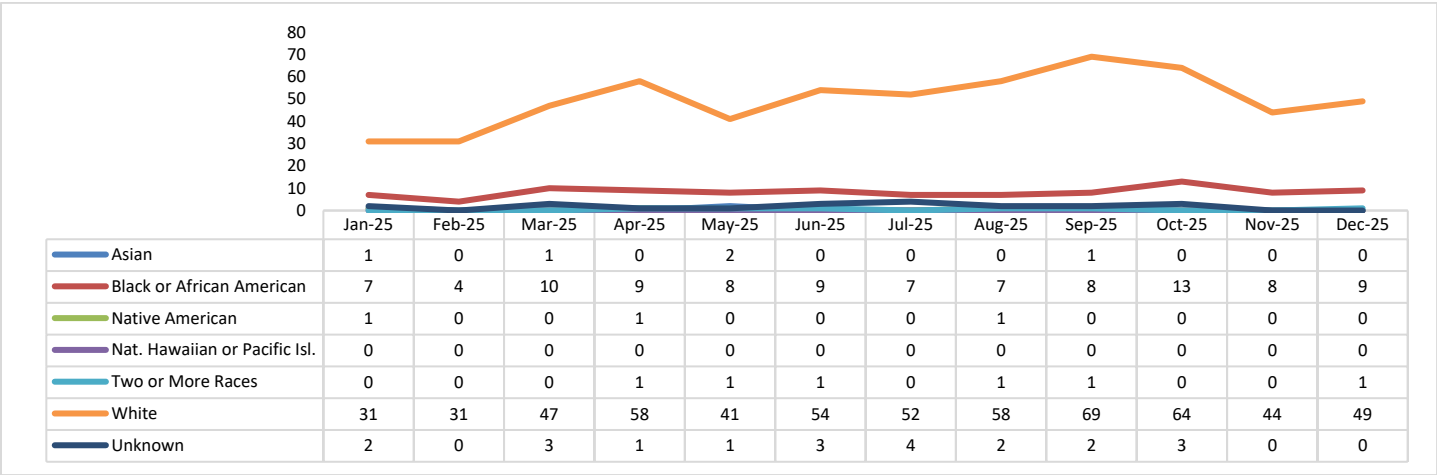
Region 1 Referrals in Over Time



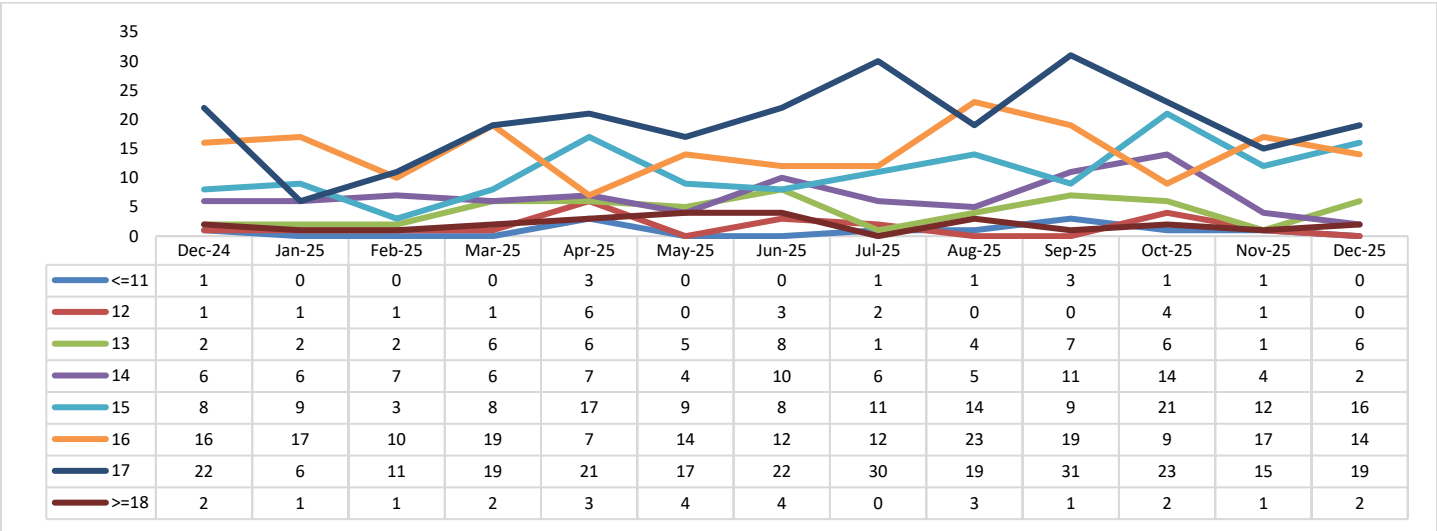
Region 1 Referrals by Gender Over Time

Region 1 Referrals by Age Over Time

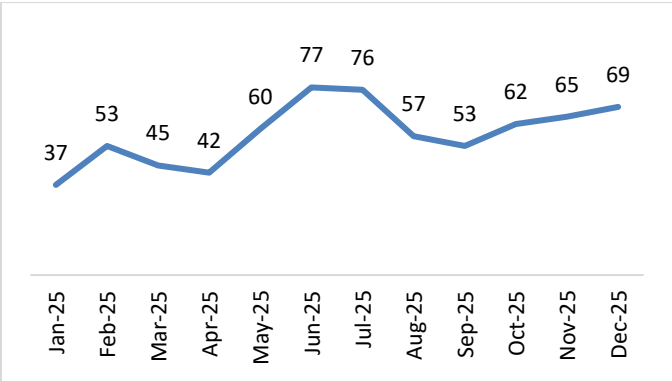




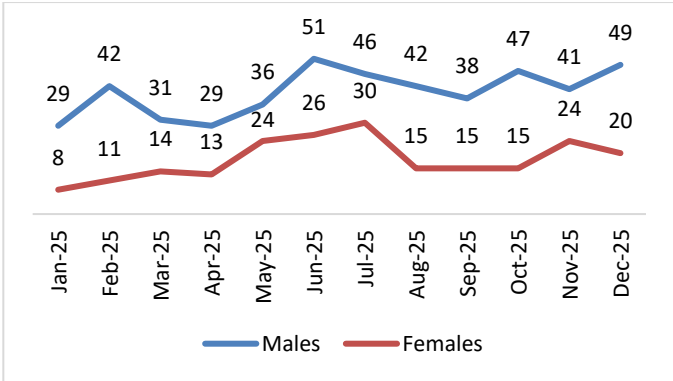

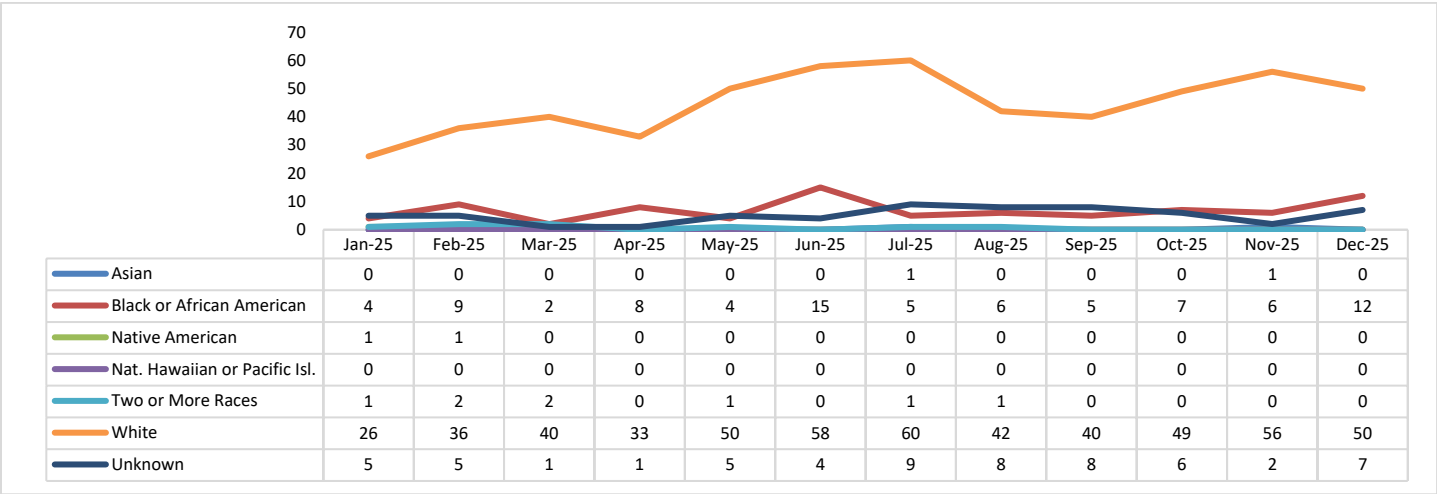
Region 2 Referrals Over Time



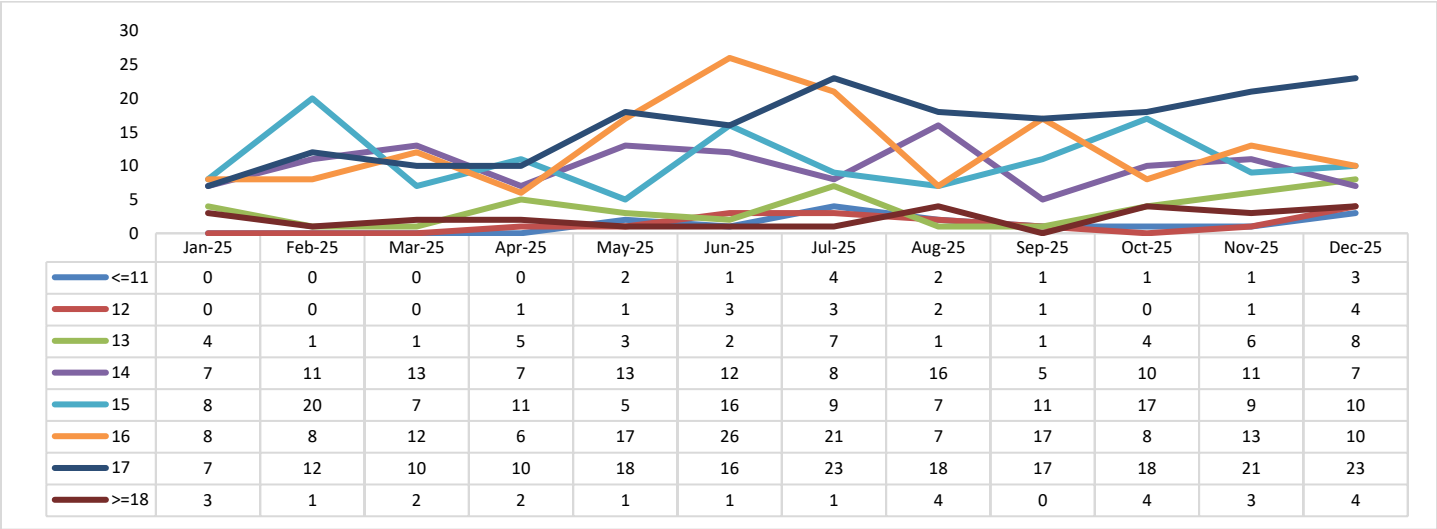
Region 2 Referrals by Gender Over Time

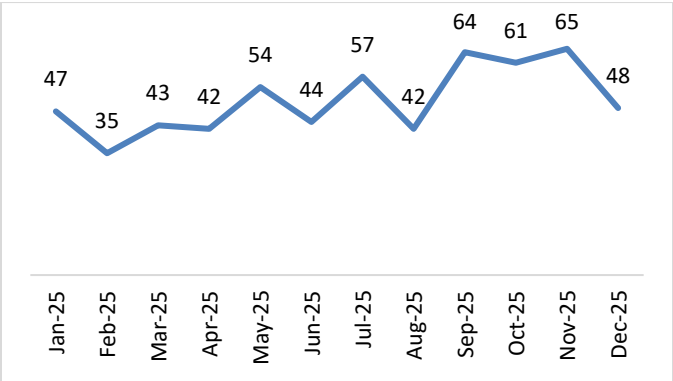




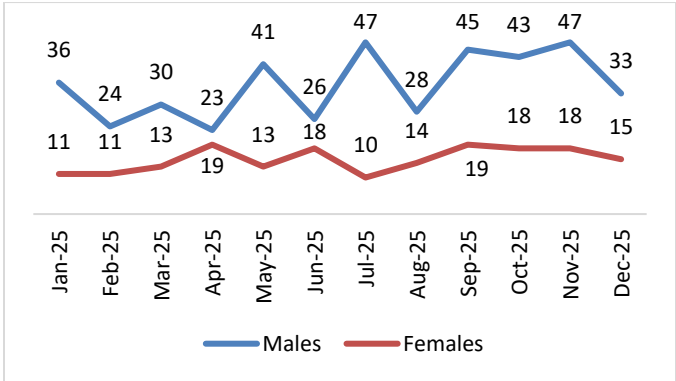

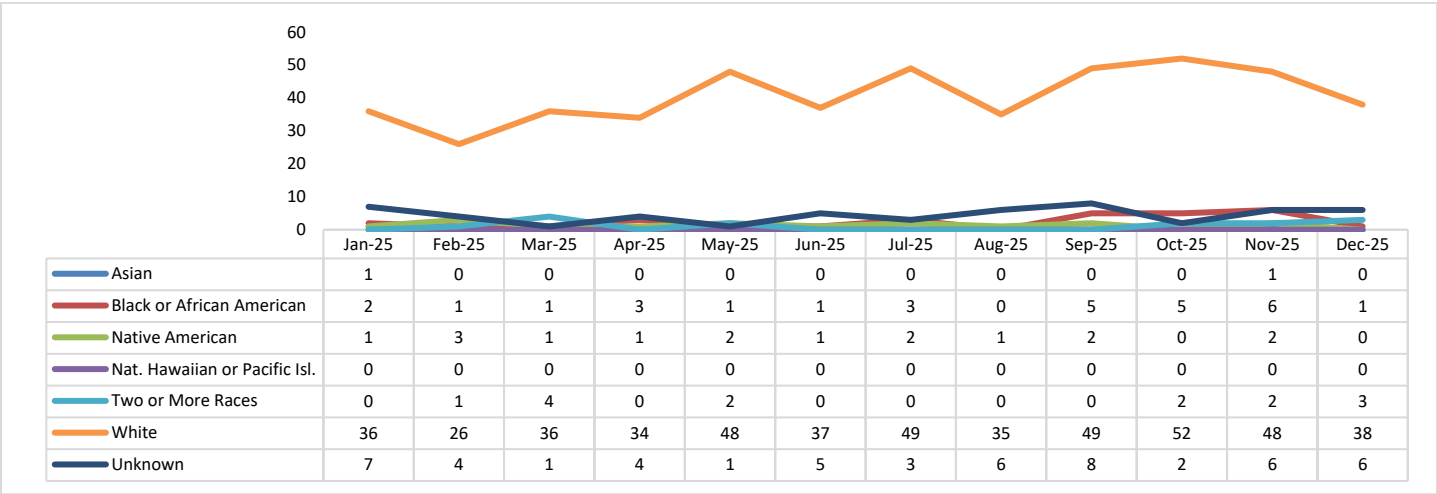
Region 3 Referrals Over Time



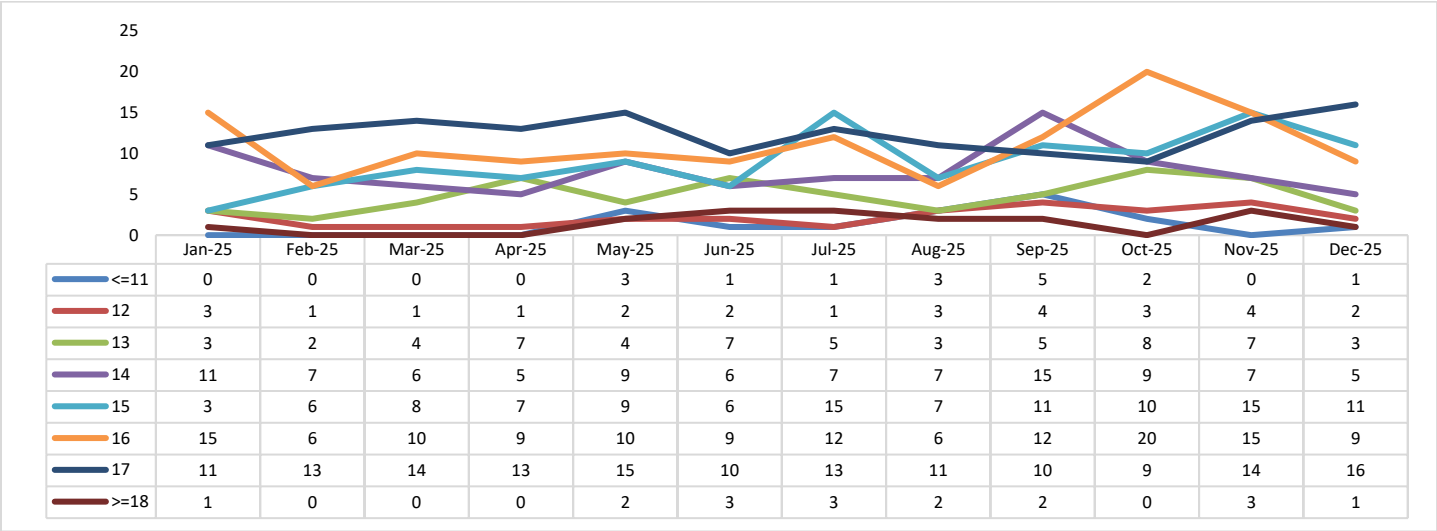
Region 3 Referrals by Gender Over Time

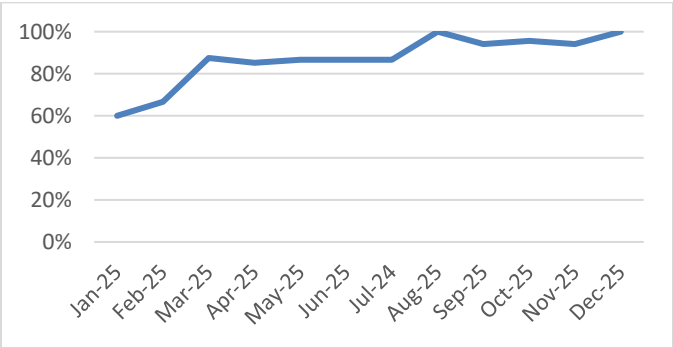

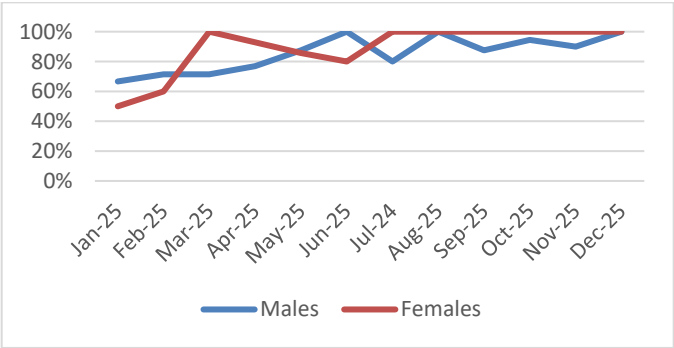

Region 1 Diversion Rates

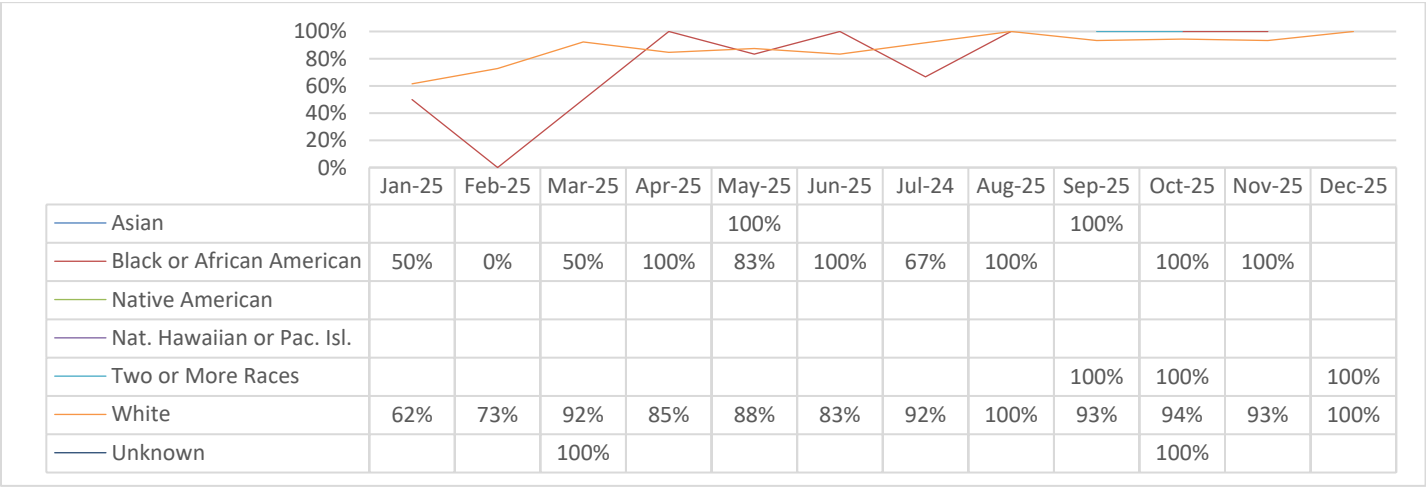
Region 1 Diversion Rates Over Time



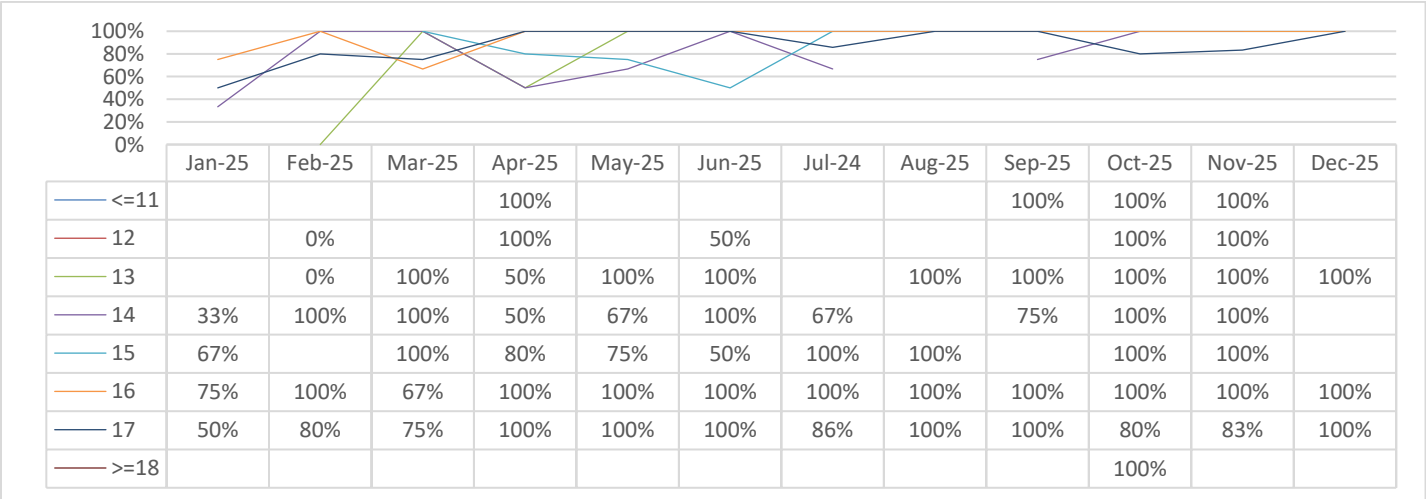
Region 1 Diversion Rates by Gender Over Time

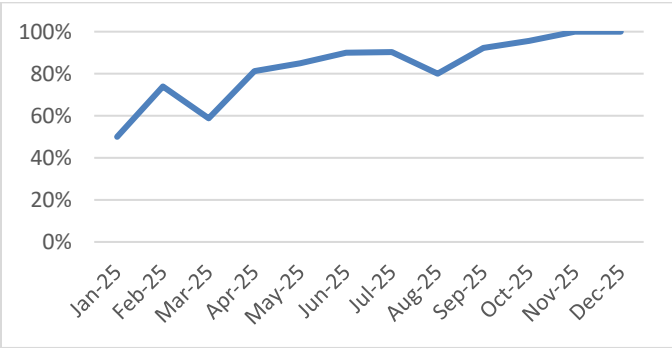

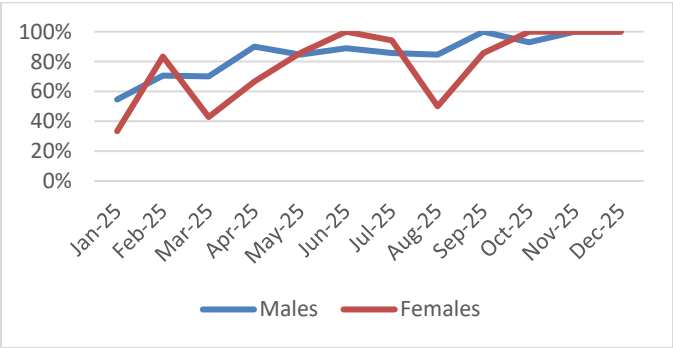

Region 2 Diversion Rates

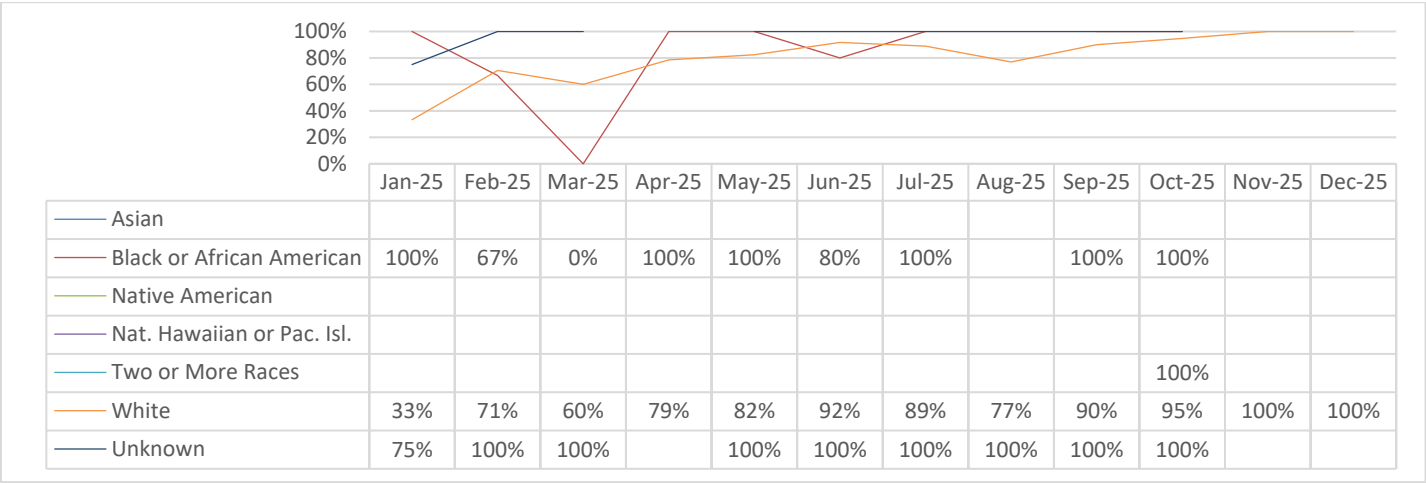
Region 2 Diversion Rates Over Time



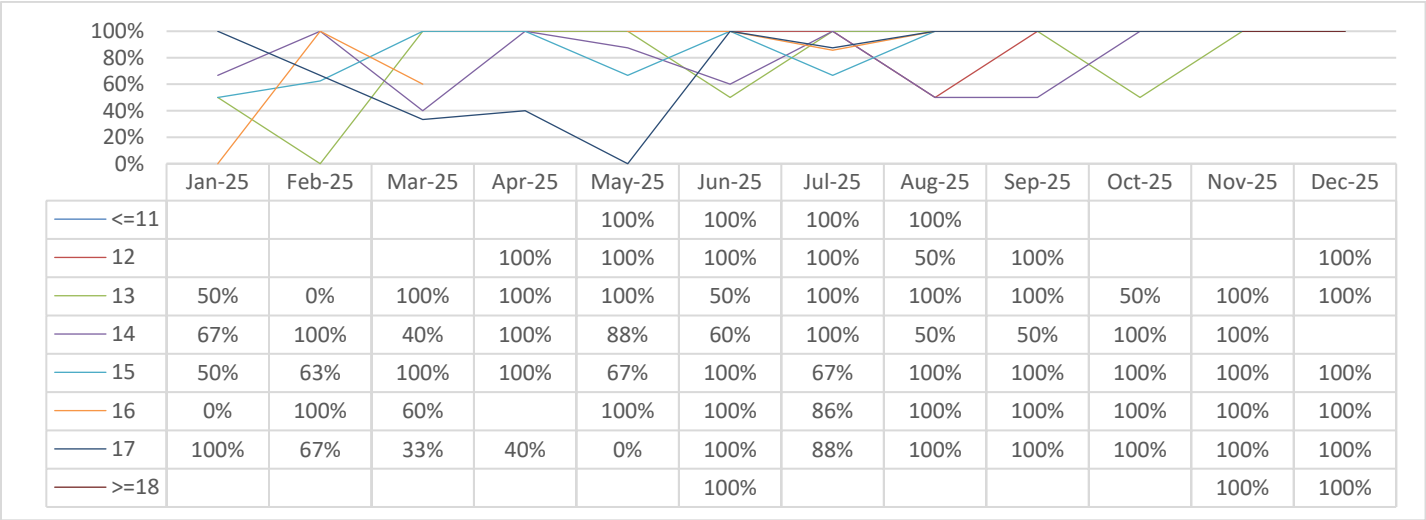
Region 2 Diversion Rates by Gender Over Time

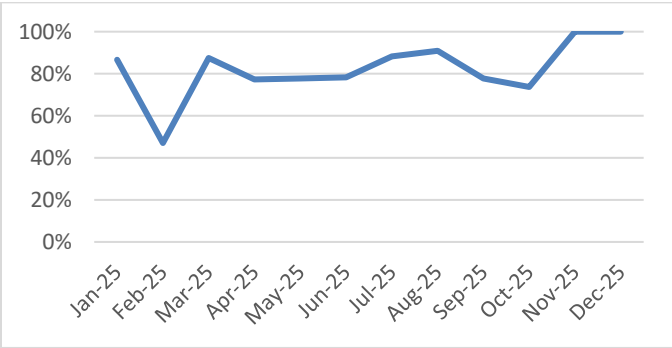

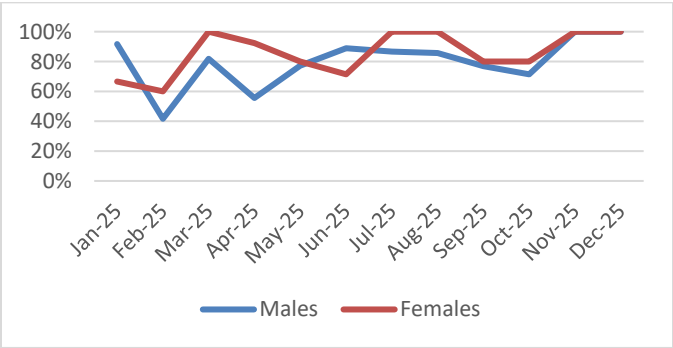

Region 3 Diversion Rates

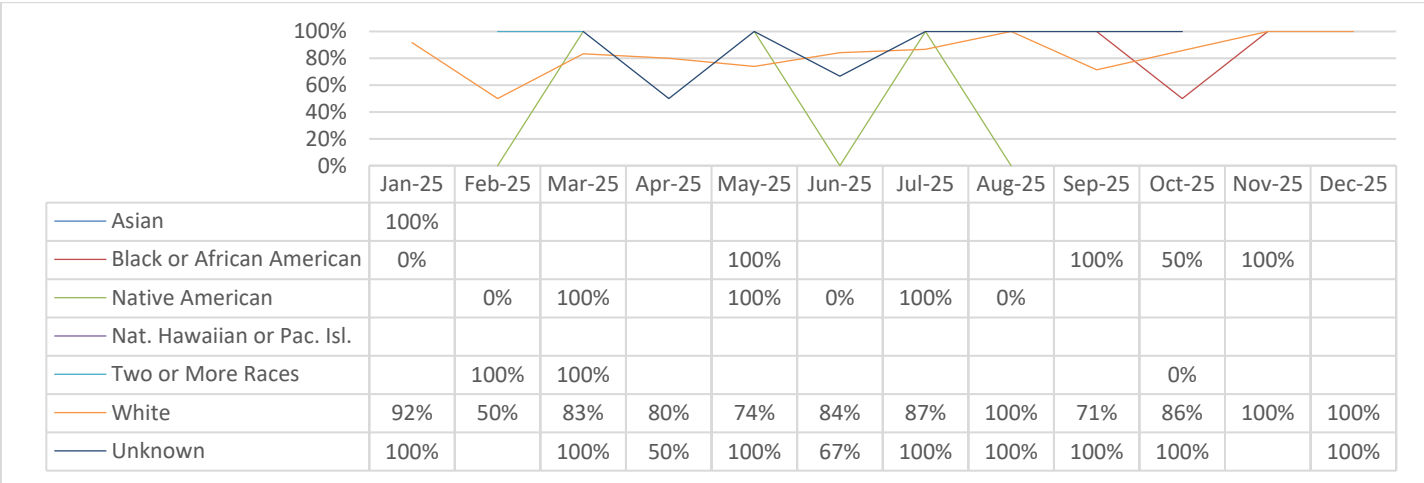
Region 3 Diversion Rates Over Time



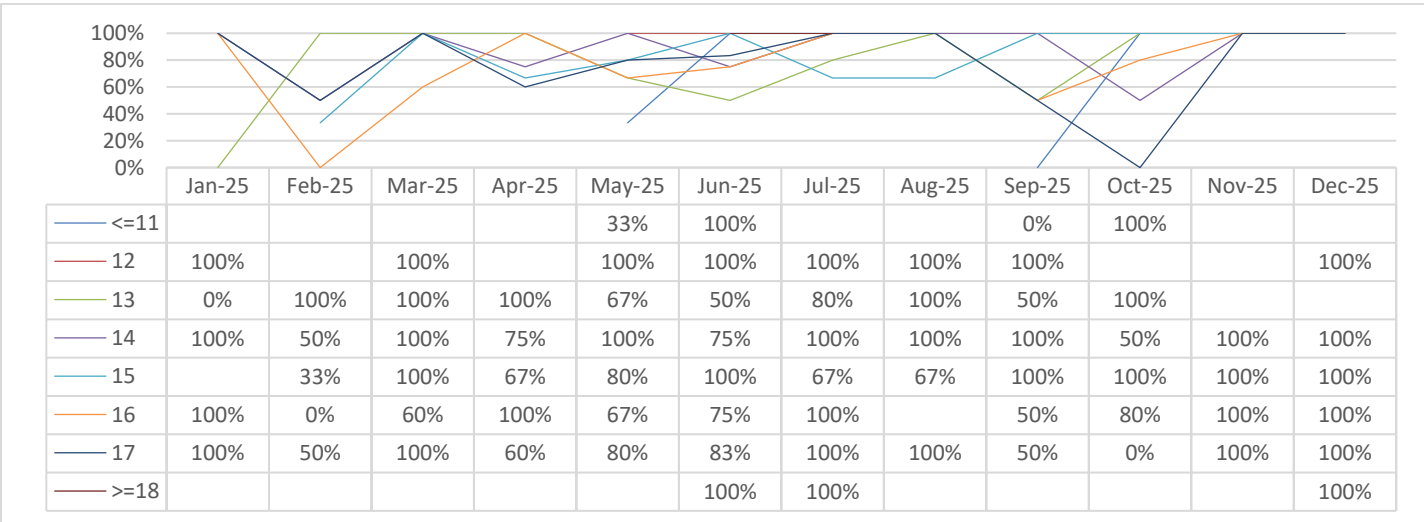
Region 3 Diversion Rates by Gender Over Time

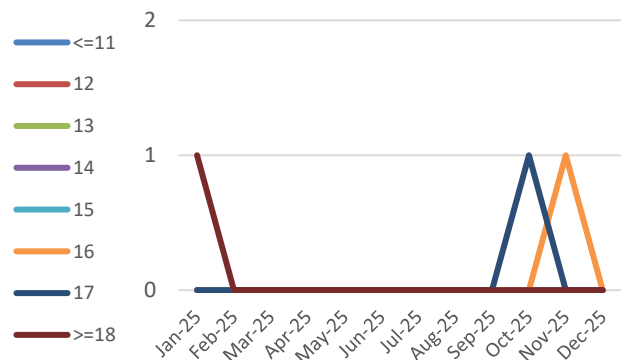
Specified period of confinement up to 30 days by Gender
