Collections are to be made from a resident's General Account only, unless noted with an asterisk\*, in which case collections are to be made from both the General Account and the Phone Account. Collections from earnings are figured based on gross earnings (unless, in the case of a DHHS ongoing child support order, net earnings are specified in the order).

Note: Collections shall not be made from any benefits checks sent directly to a resident from the Veterans Administration except for the following obligations: child support, court-ordered filing fees (federal and state), and medical co-pay, unless the resident specifically requests the funds, or a portion thereof, be applied to another obligation.
