Dear HFM stakeholders,

The Animal Welfare Program (AWP) has spent \$468,912 to pay for **3,845** Help Fix Me (HFM) vouchers since the start of the current fiscal year (7/1/21). A major update to the HFM program occurred in January 2022, when the reimbursement rates to veterinarians were increased by 50% to activate better utilization of this program. Updating the reimbursement rate proved to be a success, and now, with the program's popularity and the success of clinics that use large quantities of vouchers, demand for HFM vouchers is close to outpacing available funding.

The HFM program currently has \$309,057 in outstanding vouchers with \$317,266 available funding as of 4/8/22. AWP anticipates receiving another \$41,130 in revenues to cover the remaining HFM expenses until the end of the fiscal year (6/30/22).

Below is a breakdown of the Help Fix Me revenues and expenses from 7/1/21 through 4/11/22:

AWP understands that HFM is a critical program to its stakeholders and that demand is high for the vouchers to successfully meet the needs of our partners. However, given the robust activities presented above, it is important to be fiscally prudent and avoid issuing vouchers beyond funding availability.

AWP recognizes that spring is a key timeframe for spay services. HFM will honor the requests for May clinics and individual voucher applications that the program has already received. Otherwise, as of April 13, 2022, AWP will temporarily pause the HFM program until such time that there is funding availability to sufficiently cover voucher demand. AWP will continue to carefully watch HFM revenue streams and evaluate reopening on a monthly basis. Thank you for your understanding and patience as we continue to monitor the situation carefully.
