Anyone using propane cylinders, NOT supplied by Osterman Propane, are required to get a permit from the West Springfield Fire Department for the storage and use of propane. Cost of the permit is \$65.00 dollars, payable to the Town of West Springfield. Permits shall be submitted to the West Springfield Fire Department, Fire Prevention Office PRIOR to the start of the Big E for processing and to schedule an inspection.

Please distribute copies of these regulations to all vendors. Vendors using their own cylinders, without proper permit, will be required to remove their cylinders from the fairgrounds.

ORDER OF NOTICE (1/23/2019) West Springfield Fire Department

In accordance with the provisions of M.G.L. c. 148 Sec 5, you are hereby notified that STORAGE OF PROPANE CYLINDERS inside ANY/ALL enclosures (BUILDINGS, TENTS, TRUCK STORAGE VEHICLES, DELIVERY VANS) on the Exposition Fairgrounds is a Violation of NFPA 1 Massachusetts Fire Code – 1.7.7.2. "The AHJ shall have authority to order, in writing, any person(s) to remove or remedy any dangerous or hazardous condition or material as provided in the Massachusetts General Laws Chapter 148 Fire Prevention and NFPA 1 Massachusetts Fire Code." Violation of Fire Code: "Any person(s) who knowingly violates a rule or regulation of fire prevention regulations shall, except as otherwise provided, be punished by a fine of not less than \$100.00, nor more than \$1,000.00. (M.G.L. c. 148, Sec 10B)."
