## Conservation Related Information and Issues – What We've Heard So Far

### ***Excerpts from Initial Outreach Interviews – Comments from Interviewees***

Environmental Impacts. Concern was expressed about development causing water quality issues, especially from development along shorelines, as well as noise and light pollution, and increased potential for toxic waste or other impacts from development. The increased pressure on recreational resources due to the pandemic, as well as environmental impacts from recreational activities, such as noise pollution from motorized vehicles and damage to trails from large off-road or all-terrain vehicles, are also concerns.

Location of Development. There is a lack of readily available developable land in towns and rural hubs, which can put more pressure on the Service Area for development.

Service Area Character. Unique habitats and wildlife are abundant in the Commission's approximately 10.5-million-acre service area. Low levels of development keep these areas intact, which is important to many of the people who live, recreate, and work in the service area.

Land and Water Access. Conservation efforts have increased in recent years, and many large landowners have collaborated with conservation groups to conserve land in the Commission's service area.

Climate Change. Many species are predicted to migrate north as weather patterns change and the climate warms. Migration north depends on undeveloped corridors and areas for plant and animal population survival.
