## ANNOUNCEMENT OF PUBLIC SCOPING SESSIONS

Members of the public are invited to present their views on issues that the Land Use Regulation Commission should consider in its review of a concept plan proposal for approximately 426,000 acres in the Moosehead Lake region

AUGUSTA, Maine (July 22, 2005) – Plum Creek Land Company and Plum Creek Maine Timberlands, LLC, have submitted to the Maine Land Use Regulation Commission (LURC) a petition, in the form of a concept plan, to rezone 426,000 acres of its land in the Moosehead Lake region. The proposed concept plan sets forth areas that Plum Creek proposes to develop and other areas that Plum Creek proposes to conserve.

Due to the unprecedented scope of Plum Creek's proposal, LURC staff will be holding four scoping sessions, at the times and places stated below, to receive information from the public for purposes of identifying issues that LURC should consider as it reviews the petition.

During these scoping sessions, LURC staff particularly welcomes the public to identify issues related to:

- Consistency of the concept plan proposal with LURC's Comprehensive Land Use Plan, including, among other things, the policies to protect the "principal values" of the jurisdiction (fiber and food production; recreational opportunities especially for primitive pursuits; high value natural resources; and the uniqueness of a vast, largely undeveloped forest); support and promote the management of all resources based on the principles of sound planning and multiple use; and guide development to the most suitable locations. LURC's Comprehensive Land Use Plan may be viewed online at www.maine.gov/doc/lurc/reference/clup.html.
- Consistency of the concept plan proposal with LURC's rezoning criteria, including, among other things, the demonstrated need in the area for the proposed rezoning and impacts of the proposed rezoning on existing uses and resources.

 Consistency of the concept plan proposal with LURC's review criteria for concept plans, including, among other things, protection of the natural environment at least equal to what is currently in place; striking a reasonable and publicly beneficial balance between appropriate development and long-term conservation of lake resources; and demonstration that conservation measures apply in perpetuity or provide for long-term protection of resources.

It is emphasized that these public scoping sessions are an informal part of the very initial stage of LURC's review of Plum Creek's rezoning petition. These sessions are designed to inform the LURC staff and consultants of issues that should be explored in the review process. The scoping sessions are <u>not</u> a forum for receiving public comment substantively addressing the proposal itself. There will be opportunities in formal public hearings and in writing for testimony and other information to be submitted to LURC concerning the merits of the proposal. These scoping sessions are <u>not</u> part of any formal public hearing process on Plum Creek's petition. Members of the public who wish to testify or present substantive information or views about this proposal or otherwise wish to participate in the public hearing process will have the opportunity to do so, as provided by the rules and procedures established for the conduct of LURC's public hearings.

All interested persons are invited to attend these scoping sessions, but doing so is not a pre-requisite to later furnishing substantive comments and testimony on the proposal. Comments appropriate to these sessions may also be submitted in writing to LURC (22 State House Station, Augusta, ME 04333-0022). Persons with disabilities planning to attend the sessions are requested to inform LURC staff in advance to make arrangements for services they may require.
