On February 9, 2022, the Commission approved a public hearing request for the pending Amendment F to Development Permit DP 3639 application submitted by Big Lake Development, LLC. - The location of pump stations- existing and proposed
- Evidence the existing pump stations have sufficient capacity
- A cost estimate and financial capacity for any required upgrades
