Dear Mr. Hinkel,

Groups 2 and 10 object to CMP's most recent attempt to fast track the regulatory process. With the federal process for a Presidential Permit still underway and unlikely to resolve until after the first of the year, there is no reason for the Land Use Planning Commissioners to feel pressured into a shortened review period for their deliberative process. There is equally no compelling reason for Commissioner Pray to be required to participate in the review of this application. To argue, as CMP does, that reading the voluminous materials, including testimony and transcripts of hearings, is analogous to attendance at the hearings and digesting the materials contemporaneously, simply ignores reality. The very reason for the hearings was to enable the Commissioners to receive first hand testimony and ask direct questions. Reading transcripts is not a substitute. For these reasons, CMP's requests should be denied.
