Dear Freeport Resident:

Over the past few years many areas in the Town of Freeport have been heavily infested with browntail moth caterpillars. The level of infestation of browntail moths in Freeport during these years was high enough to have these areas declared a public health nuisance by the State Bureau of Health. In both 1999 and 2000, the Town of Freeport conducted an aerial application of pesticides in an effort to limit the human health impacts of this insect. Due to the number of residents who did not want to have their property sprayed the town was only able to spray about half the area that the Maine Forest Service recommended to be treated, resulting in a substantially compromised level of control. Because of the limited success and continued resistance to the aerial spray program, the town did not implement a spray program during the spring of 2001.

As you may be aware, the spring, summer and even fall of 2001 were extremely difficult for many Freeport residents because of the browntail moth caterpillar. Browntail moth caterpillars shed tiny hairs that are often toxic to humans with reactions ranging from skin rashes to significant respiratory difficulty. Local doctors offices and emergency rooms confirmed that the number of severe cases of reaction to the browntail moth caterpillars has increased. Several calls came into the Town Hall describing emergency runs to the hospital due to severe reactions. Many residents called to detail the agonizing impact of the browntail on their families, while others came into the office to show the full extent of their reaction bodies covered with red, swollen, prickly welts which are excrutiatingly itchy.

The levels of infestation of browntails in Freeport continues to increase. Surveys reveal that over 2,000 acres are highly infested and should be treated in the Spring of 2002. In order for the town to conduct an effective aerial spray program, participation levels need to increase among residents in affected areas. As a result, we are requesting that those of you who do NOT wish to have their property included in a municipal spray program to let us know (please see form attached and its provisions, particularly its first paragraph) by January 31, 2002. A decision on whether or not to implement a spray program in the Spring of 2002 will be made after that date.

While the town respects each individual's personal decision not to participate in a municipal aerial spray program to control browntail moth caterpillars, we urge each of you to carefully consider your decision, knowing that your decision may greatly impact the health of your neighbors. Before deciding to opt out, you may want to consider attending the public information meeting on January 10, 2002.

NOTICE TO PROPERTY OWNERS IN THE 2002 INSECTICIDE SPRAY PROGRAM FOR BROWNTAIL MOTHS <u>AND</u> PROPERTY OWNERS WITHIN 500 FEET OF THE SPRAY BLOCKS

Dear Freeport Property Owner:

The Town of Freeport is making its final plans for an aerial application of pesticides to control browntail moth caterpillars **ON OR NEAR** your property. The spraying program is scheduled to occur in your area between April 25 - May 20, 2002. The purpose of this spray application is to control the growth and spread of browntail moth caterpillars. Browntail moth caterpillars shed tiny hairs that are often toxic to humans with reactions ranging from skin rashes to significant respiratory difficulty. While the moth caterpillars can also cause severe damage to the trees and shrubs they infest, the Town's primary effort and concern is directed toward limiting the human health impacts of the insect. Therefore, the spray program is limited to areas most heavily infested around residences. The chemical product Dimilin, which cannot be sprayed within 150 feet of the shoreline, will be used in this spraying program.

The Town had sent an initial notice in the month of December to those individuals who owned properties in the areas recommended to be sprayed by the Maine Forest Service. Based on the inability to spray within 150 feet of the shoreline and the responses from those who do not want their property sprayed, the spray blocks have significantly changed from the map which was sent to you in December. Please check this map carefully to determine whether or not your property is still within a spray block. Since the attached map is quite small, a larger map is available for inspection at the town hall.

Please find enclosed the following materials:

- A formal Notice of Intent to Spray along with a map of the final spray areas
- A Refusal of Consent form that you may use and return to the Town Hall if you do NOT want your property sprayed (This must be returned by April 20, 2002 but please return as soon as possible)
- A copy of the Town's Browntail Moth Spray Policy for 2002 & a list of Ground Sprayers should you want to contract your own ground sprayer
- A list of precautions and winter management tips prepared by the Maine Forest Service
- A copy of the Declaration of a Public Health Nuisance

As the date(s) of spraying is dependent on weather conditions, the day(s) of spraying may need to change. Public Notice of the intended date of the aerial spraying, subject to change because of weather conditions, will be placed on the Public Safety Visual Display Board on Main Street twenty-four (24) hours prior to the spraying. Updated information will also be posted at Bow Street Market, Dick's Subshop, Freeport Post Office, South Freeport Post Office, Village Store, FCTV and the Town's Website.

The Town of Freeport, Maine hereby gives notice of its intent to conduct an insecticide spray program in the Town of Freeport to reduce human health risk and nuisance exposures to the browntail moth and browntail moth caterpillar. The spray program is expected to last one or two days between April 25 - May 20, 2002, weather conditions permitting. This notice, provided pursuant to 22 MRSA Chapter 257-A gives further detail and contacts for more information on this program.

Target Areas: There are several general areas selected upon review and recommendation of the Maine Forest Service and modified due to non-consenting neighbors and/or the inability to spray within 150 feet of the shoreline. PARTS OF AREAS AROUND: Lower Flying Point, Flying Point, Lambert Road, South Freeport Road, Spar Cove, Staples Point, Pine Street, Lower Mast Landing, Bartol Island Road, Litchfield Road and Wolfe Neck Road. Please refer to the enclosed map plan for details as these spray blocks have been adjusted significantly from the initial mailing of 12/31/01 (Please note: the pesticide cannot be applied within 150 feet of the shoreline).

Spraying will occur between 5:00 a.m. - 8:30 a.m. Public Notice of the intended date of the aerial spraying, subject to change because of weather conditions, will be placed on the Public Safety Visual Display Board on Main Street twenty-four (24) hours prior to the spraying. On the day(s) of spraying, please schedule your morning walk or run to avoid the spraying. It is recommended that residents stay indoors and keep pets indoors during the spraying and for approximately 30 minutes after the spraying.
