Permit by Rule (PBR) Application Guidance and Installation Standards

A Permit by Rule (PBR) must be submitted to the Maine Forest Service (MFS) for the installation of a permanent crossing over a stream or brook or for soil disturbance within 75 ft. of a protected natural resource within organized towns. A PBR application may be found online at <u>https://www.maine.gov/dacf/mfs/rules_and_regulations.html.</u>

A PBR application must be completed in full and include all necessary attachments before it can be processed. Once a complete application is submitted, applicants must wait 14 days before construction begins, unless the PBR is approved by MFS before this. Projects that take place between **July 15—Oct. 1** are exempt from the 14 day waiting period. Multiple projects may be included in one PBR application. When completing your PBR application please pay special attention to the items identified below:

(1) <u>Description of Project Including Structure Type and Timeline</u>: Please include structure dimensions and installation timeframe. A PBR may not be used for a crossing of a non-forested wetland or significant river segment.

- (2) Check one This project does (or) does not involve disruption of the stream bed: Keep in mind that culvert installations are considered disruption of the stream bed.
- 3 Activity Adj. to Protected Natural Res. (NRPA Sec. 2): A PBR is required if you are disturbing soil within 75ft. of a protected waterbody, such as construction of a log landing. This does not include stream crossings.
- 4 Stream Crossing (SWS or NRPA Sec. 10): Check this box if you are installing a permanent stream crossing. A crossing that is in place for more than 7 months or constructed using fill material is considered permanent.
- 5 Attached Map: The project location must be clearly identified. If the project is in a town subject to Statewide Standards in shoreland areas (SWS), please use a SWS map. A SWS map can be found online at: www.maine.gov/dacf/mfs/policy_management/water_resources/sws/sws.html.
- 6 Attached Dept. of Inland Fisheries and Wildlife (IFW) Request for Approval of Activity form: This should be completed by the applicant and signed by IFW. IFW contact info may be found online: www.maine.gov/ifw/about/contact/department-directory.html#regionalheadquarters.



Crossing structures must meet or exceed installation standards that apply to organized towns that have adopted Statewide Standards for Timber Harvesting in Shoreland Areas (SWS), and/or Natural Resources Protection Act (NRPA) standards if the town has not adopted SWS. Below is a summary of those installation standards. To view these standards in their entirety, please visit www.maine.gov/dacf/mfs/rules_and_regulations.html.

Stream Crossings (SWS or NRPA Sec. 10)

Whether or not you are working in a town that has adopted SWS, the following installation standards apply to any **permanent** bridge or culvert over a stream or brook at a timber harvesting operation within organized territories:

Bridges and culverts must be installed and maintained to provide an opening that is at least <u>**3 times the cross-sectional area of the stream channel.</u></u> For guidance on determining the cross-sectional area of a stream channel, reference the MFS BMP manual available online: <u>www.maine.gov/dacf/mfs/policy_management/water_resources/bmps.html.</u></u>**



Stream channels, banks and approaches to crossings of water bodies must be stabilized on completion of harvest, or as soon as practical after snowmelt. If, despite such precautions, sedimentation or the disruption of shoreline integrity occurs, such conditions must be corrected.

For towns that have <u>not</u> adopted SWS, the following additional standards apply, per NRPA standards: 1.) Culverts must be limited to 75ft. In length. **2.)** Culverts must follow the alignment and grade of the stream channel, not to exceed 1% gradient on perennial streams. **3.)** Where more than 1 culvert is installed, additional culverts must be offset to concentrate low flows into the culvert within the natural channel.

Exception for towns that have adopted SWS: Structures over streams draining <u>less than 300 acres</u> may be constructed in a manner not in conformity with the requirements above, provided reasonable measures are taken to avoid the disruption of shoreline integrity, sedimentation of water, and the disturbance of stream banks, stream channels, shorelines, and soil lying within ponds and wetlands.

Activities Adjacent to Protected Natural Res. (NRPA Sec. 2)

For projects that include earth moving activities adjacent to (within 75 ft. of) a river, stream, brook, great pond or nonforested wetland, a PBR must be submitted, including all attachments listed in Chapter 305, Section 2 of the NRPA. These include:

1.) A brief narrative explaining why there is no practicable alternative to location of the activity; and

2.) A scaled plan or drawing of the area affected including: **a.)** Property lines **b.)** The waterbody **c.)** The location of the proposed activity **d.)** The 75 ft. setback **e.)** Any site constraints that prevent the activity from taking place beyond 75 ft.
