• Acting Director Michael Boardman reported that the Spirits RFP has been issued. Acting Director Michael Boardman provided a staffing update. He reported that BABLO has hired a new Office Associate II who will be working directly with Tracy Willett. There are still some new Liquor Inspector positions that need to be filled. Acting Director Michael Boardman reported that he attended the NABCA Board of Directors Meeting the week of January 3-7, 2024. ### **Lottery Operations:**

Acting Director Michael Boardman provided some staffing updates. The Lottery Field Supervisor retired. An Office Associate position has been posted. There are two positions in the process of being posted: a Warehouse position and a Marketing position. Acting Director Michael Boardman provided an update about the upcoming Cash Pop game. Acting Director Michael Boardman reported that he anticipates the Lucky for Life game will be changing. If the change is made, Lucky for Life and Cash for Life will both be replaced with a new single version game. The prize for the new game would change from one thousand dollars a day for life to one million dollars a year for life. Maine Lottery is also working on a multijurisdictional progressive Fast Play game. This game would include multiple states. The Mega millions game will be changing in spring 2025. They are working to change that game to a five-dollar price point as well as other changes.

### **Report on Tri-State Activities:**

• Commissioner Sheehan reported that the next Tri-State meeting will be February 9, 2024. Marketing Manager Lisa Rodrigue reported that a call was held with Tri-State on January 4, 2024, where Scientific Games presented the Game of Thrones instant ticket.

#### Scientific Games:

 Darrell Frecker provided a brief update. He reported that 2023 was about twenty-two million dollars better in sales compared to 2022. Instant tickets alone went from three hundred and nine million to three hundred twenty-four million. Total sales went from three hundred and ninety-eight million to four hundred and twenty million. He reported that the instants, draw, and fast play all increased year over year.

- Greta Larson presented the new fast-play ticket based on Maine Lottery's 50<sup>th</sup> anniversary that will come out February 4, 2024. Greta reported that the RewardME first tickets entered was up 3% in 2023 compared to 2022. She reported that the first tickets entered in 2022 were Powerball, Mega Millions, Megabucks, Big County Cash, Living Lucky with Luke Combs, and The Price is Right. The first tickets entered in 2023, were Powerball, Mega Millions, Megabucks, Ultimate Dash, Living Lucky with Luke Combs, and Maine Crossword. Greta provided the following Reindeer Run update:
  - Reindeer Run tickets entered for fourteen out of fifteen weeks:
    - Up +0.1% over 2022
    - Up +32.3 over 2021
    - Up +11% over 2020

Greta reported that the Jackpot Party second chance promotion began January 8, 2024. This promotion will run through the end of February.

#### Fuseideas:

• Steve Mason reported that throughout the month of December they were fully on to the Holiday campaign and the Reindeer Run promotion. They had a strong presence on television with their second chance owl spot. In January they are advertising to support Tri-State Megabucks. Next, they will shift over to Jackpot Party.
