Liquor Operations:

• Deputy Director Michael Boardman introduced and welcomed Director Louis Luchini. Director Luchini introduced himself and gave a brief statement about his background. Deputy Director Michael Boardman reported that the deadline for submission of bids for the Spirits RFP has passed. The evaluation committee will meet Friday, February 16, 2024. After this meeting the committee will make a recommendation to the Director. Deputy Director Michael Boardman provided an update regarding the liquor modernization project. This project continues to remain on schedule. It will be launched in September 2024. Some amendments have been made to the

agreement with Computronix. Deputy Director Michael Boardman provided a staffing update. There are five more Liquor Inspector positions to be filled. There is one other vacancy to be filled in addition to the Inspector positions. Deputy Director Michael Boardman introduced Mandy Veniot, Office Specialist II. Mandy will assist the Spirits Operations Manager. Deputy Director Michael Boardman reported about LD 2014, An Act Regarding Spirits Price Regulation. There is a work session scheduled for Thursday, February 15, 2024. Deputy Director Michael Boardman also reported about a Department Bill LD 2148, which establishes common carrier reporting for direct shipped wine.

Lottery Operations:

Deputy Director Michael Boardman provided a reminder that this year is Maine Lottery's 50th anniversary. Some special events are being planned, there will be some special 50th anniversary tickets, a fast-play ticket, many promotions will run, and several special events will occur. Deputy Director Michael

Boardman provided some staffing updates. There are currently three vacancies on the lottery side. Two of the three positions have been posted, the Lottery Field Representative Supervisor and the Inventory and Property Specialist. The third vacancy is a new Marketing Specialist position. This position will be working on our website and social media. Deputy Director Michael Boardman provided a reminder about some of the games. Cash Pop will be launched on May 5, 2024. Tristate Megabucks continues to grow. The jackpot is currently at \$12.75 million. Mega Millions will be changing in 2025. It will go to a \$5 price point. Deputy Director Michael Boardman provided an update about the potential for a multi-jurisdictional fast-play game. This will not happen until after the Mega Millions game change for a couple of reasons. The company that has developed a piece of equipment and the software to help facilitate this is not Maine Lottery's vendor. The company will start with the vendor sites who they are currently working with. This is because it will be the first multijurisdictional fast-play game and it is very unique. The discussion continues about the potential for merging Lucky for Life and Cash for Life into one single game. The prize for this would be one million dollars a year for life.

Report on Tri-State Activities:

• Commissioner Sheehan reported about the meeting that was held on February 9, 2024. The reboot of Megabucks is what is leading the finances on the Tristate sales report. It is reported that in Maine sales increased through Megabucks by 53%. In New Hampshire, Megabucks was responsible for an increase of 74%. Vermont had an increase through Megabucks of 83%. The audit for Tristate has been submitted with no concerns. Tristate has been very busy with marketing. Marketing Manager Lisa Rodrigue reported that there is an upcoming Tristate meeting to be held in Vermont this spring and in Maine in the fall.

• Scientific Games:

• Greta Larson provided an update that development of the marketing for Cash Pop and Golden Spin are both going well. She reported that the Jackpot Party promotion is also going well so far. There has been a lot happening on social media. There are over 5,000 unique players to date and over 25,000 tickets entered into this promo. The Drawing for this game is February 29, 2024. Greta reported the Ultimate Dash is also going well. There are over 15,000 unique players who have entered and over 207,000 tickets entered. There will be a Lucky for Life systems promotion in March. This will help elevate sales in that area. The top prize is \$100. This will run from March 17, 2024 - March 23, 2024. Greta provided an update regarding the first ticket entered. Greta presented the 50th anniversary fast-play ticket. It just launched and it is already over 7% sold. The top prize is \$500.

Fuseideas:

• Steve Mason reported that moving into January, they wanted to keep the momentum going with their sales from Tristate Megabucks. They continued to advertise Megabucks with the NFL and Bruins package. Then they introduced radio advertising supporting the new game Jackpot Party. That is doing quite well. Going into February they will continue with Megabucks at a slightly lower level of TV primarily focused on news, weather, and sports. Jackpot Party radio is continuing. Steve reported that March is Problem Gambling Awareness Month. They will be running some responsible gaming messages along with a continuation with some of their other advertising. He reported that they have been busy working on the 50th anniversary and will soon move towards execution.
