Liquor Operations:

Interim Director Boardman provided an update regarding current legislation. He also announced that an agreement has been signed with Computronix to modernize the Division's processes by implementing an electronic licensing, enforcement, and taxation system.

Lottery Operations:

Interim Director Boardman reported on the Lottery's resolve for Lottery Operations to study the bonuses paid to retailers for winning tickets sold in the Powerball Game that were not jackpot winners. He provided an update that the new \$30 game will come out May 18, 2023. He reported about new signage going up in the Walmart stores starting on May 8, 2023. Debit and credit features will be added to the vending machines in June 2023. Lottery Operations has put out an RFI (Request for Information) from consultants for the Gaming System. The Gaming System contract with Scientific Games expires in June 2025. Lottery Operations is hopeful that the Customer Service Manager position will be filled by the end of this week.

New Business:

• Rulemaking - Interim Director Boardman addressed the Commission regarding the need to update the Maine State Lottery Rules. He went over all the rules that are necessary to change. A motion was made by Commissioner Sheehan to move the Commission adopt the Basis Statement as presented for the rule changes to the Maine Lottery Rules and direct Interim Director Boardman to proceed with the rulemaking process; the motion was seconded by Commissioner Schneck. The roll was called, and all Commissioners voted in the affirmative; the motion passed unanimously.

Approval of New Games:

- Marketing Specialist Lisa Rodrigue presented three (3) new game for approval.
 - (\$1) CASH TIME
 - (\$3) DOUBLE RED BINGO
 - (\$5) JACKPOT PARTY

A motion was made by Commissioner Sheehan to accept these games as presented; the motion was seconded by Commissioner Schneck. The roll was called, and all Commissioners voted in the affirmative; the motion passed unanimously. (Games attached to the minutes.)

Report on Tri-State Activities:

• Commissioner Sheehan spoke of the Tri-State meeting she attended in April. She announced that Terrance Meehan is the new Financial Analyst for Tri-State. New technology was brought up called a Random Number Generator (RNG). It is a computer-generated drawing. Lotto America has moved to using a RNG. The next Tri-State meeting is scheduled for June 1, 2023.

Scientific Games:

• Darrell Frecker reported that Fast-Play is doing well. There are new Fast-Play games coming up in July. They are excited about Maine's first \$30 instant game. They are running a few promotions this month. The Gimme 5 game promotion runs May 14 through May 27. Loyalty program- annual Mother's Day Points for Prizes store promotion. They are currently finalizing plans for the Powerball NASCAR promotion which will run in June. They are working on the 2023 Summer promotion. They are on track with Megabucks with a new logo, adding extra draw day, with drawings on Monday, Wednesday, and Saturday now. They are continuing testing on the upcoming credit and debit project. All self-service vending machines will be able to accept credit and debit. This will happen early summer. A Pick Three Pick Four promotion was completed in April. Living Lucky with Luke Combs deadline is September 12. The Price is Right promotion is coming to an end in June. PHD sales for April this year were higher than any other April in history. Year to date sales for play central terminals are running higher than any other previous year.

Fuseideas:

• They were quiet for the first two weeks of April by plan. In mid-month they launched their Fast Play advertising supporting the new game. Fast Freddy has two 15-second spots running on TV as bookends. One is at the beginning and one at the end of a spot of advertising. They also have radio running currently. During April they also supported the Pick Three Pick Four ticket promotion with a full run of radio during the promotion dates. In May they are continuing with Fast Play TV, radio, and digital advertising. Steve presented the Fast Play Location Finder Mobile Advertising. Moving through May they will continue to support Fast Play. They have the Gimme 5 instant ticket promo from May 14 through May 27. In June they will be supporting the Powerball NASCAR promotion. They are shooting a new set of TV spots for the Reward ME too sequel next week. They are developing campaign materials for Cash Pop. They will be working on Tri-State Megabucks for the fall and the Warehouse Dash. Fuseideas was awarded a first-place prize for the Northeast Regional Addy Awards for the Maine Lottery Ugly Sweater Holiday TV spot. They are now being considered for the National Addy Awards.

Other Business:

• Interim Director Boardman addressed that there was a provision in the rules that maxed us out to a \$5 price on draw tickets, it has been changed to \$20.
