Marketing Manager Lisa Rodrigue reported on YTD (through September 2, 2023) sales as follows:

## Report on Tri-State Activities:

• Commissioner Sheehan reported that the Tri-State meeting was held on August 18, 2023. She provided an update regarding the accounting system transition from Vermont to New Hampshire. Marketing Manager Lisa Rodrigue reported that the Wearhouse Dash Tri-State instant ticket has launched in all three states. The Dash event will be in Portland Maine at Thompson's Point fall 2024. The next Tri-State ticket is in development. This ticket will likely be launched spring 2024. The next Tri-State meeting is scheduled in November.

### Scientific Games:

- Darrel Frecker provided an update regarding the vending machines and the retrofits they are doing to them. Currently 175 of the 250 machines are completed. The estimated completion date is September 21, 2023. He reported on the Megabucks game which will be changing this weekend. The first draw for the new draw pattern will be Monday September 18, 2023. He reported that Cash Pop will be replacing World Poker Tour. Four Fast Play games will be released October 15, 2023. Additionally, three Holiday games will be released November 5, 2023.
- Greta Larson reported a systems promotion will run September 17, 2023, through September 30, 2023, for the Tri-State Megabucks new draw day launch. This will be complimented by a social media giveaway which will run September 18, 2023, to October 15, 2023. Powerball first millionaire of the year began on September 1, 2023, and ends on September 30, 2023. This year the Reindeer Run promotion will run again. The Patriots promotion will run October 1, 2023, through October 30, 2023.

### Fuseideas:

• Steve Mason reported during the month of August they supported the Tri-State Ultimate Dash promotion. The first of September they switched to Powerball first millionaire of the year (2024). This will continue throughout the month. On September 18, 2023, they will be launching the new Megabucks campaign. This will continue into the middle of October. In October, they will support the Patriots promotion and in November and December the support will be on the Reindeer Run holiday promotion. They have been preparing for the upcoming launch of Cash Pop. There is a player event on October 21,2023 at the Augusta Civic Center. This is part of the second chance drawing for the Price is Right instant ticket game. They have big things brewing for 2024 as it is the 50<sup>th</sup> anniversary of the Maine Lottery. Steve shared the Tri-State Megabucks TV spot.
