- Acting Director Michael Boardman reported that Lottery Operations hosted their spin event for the Prices is Right game on October 21, 2023.
- Acting Director Michael Boardman reported that some lottery winners that went to the Patriots game last Sunday. There will be more lottery winners going to Patriots games this season. There will be a suite game for lottery winners at the end of the year.
- Acting Director Michael Boardman reported that the GEA (Government Evaluation Act) report has been sent to the Commissioner for approval. After that it will be sent to the

- Legislature, then it will get presented. Once that gets finalized the Commission members will be provided with copies.
- Acting Director Michael Boardman reported that Lottery Operations is working on a
  resolve that has to do with paying bonuses to retailers for lottery winning tickets that are
  not the jackpot. That is already done with most of the games. This resolve is being put
  together and is due on December 6, 2023. Commission members will be provided copies.

## Report on Tri-State Activities:

• Commissioner Sheehan reported that a Tri-State meeting is scheduled for November 15 - 17, 2023.

### Scientific Games:

- Darrel Frecker reported that the Megabucks game is doing 20% 30% better over the last few weeks with the added draw. Fast-Play launched three Holiday games last weekend. Quarterly games were launched in October. There are more games planned for January and going into the second quarter of next year. The Cash-Pop game is still in development.
- Greta Larson reported that the Maine Lottery has an upcoming holiday systems promotion called Holiday Ca\$h. This promotion will run from December 10<sup>th</sup>- December 23<sup>rd</sup>. If players purchase any draw game ticket of \$5 or more (excluding WPT and FP) they have the chance to win \$25

instantly. Greta reported that in the first 5 weeks of this year's Reindeer Run promotion, the Maine Lottery had 452,370 tickets entered. Greta provided the following figures for the Reindeer Run promotion.

- Tickets entered are up +14.3% or 56,506 tickets over 2022.
- Tickets entered are up +63.3% or 175,398 tickets over 2021.
- Tickets entered are up +38.8% or 126,510 tickets over 2020.

Megabucks tickets entered accounted for 10.88% of total tickets entered so far. Megabucks entries are up 91.12% over 2022's first 5 weeks of the Reindeer Run Promotion. Holiday Games (Holiday \$100s, \$200s, & \$500s) accounted for 20.09% of total entries. This category is up 10.79% over 2022's first 5 weeks of Reindeer Run promotion.

## Fuseideas:

Steve Mason reported that through the month of October they ran a Powerball Patriot's promotion. They were also running the Ultimate Dash advertising. From September 18 – November 12, 2023, they ran the Tri-State Megabucks campaign. Beginning November 13, 2023, they launched their Holiday campaign. They are now 100% Holiday Reindeer Run promotion through the end of the year. Steve then showed their Second Chance Holiday TV advertisement.
