### **Liquor Operations:**

Director Luchini also updated the Commission that the TTB added new standards of fill, which will add 14 new sizes for spirits. This rule will be effective January 10, 2025.

# **Lottery Operations**

Director Luchini reported that the Lottery is now live with Double Play and has been going well. Director Luchini also reported that the Lottery had a big Mega Millions Jackpot around Christmas and New Years so that helped with the number of sales.

Director Luchini reported on the following YTD (through December 28, 2024) sales as follows:

- Draw Sales FY 25 \$35,744,397; down \$12,372,301 from FY24, or -25.71%
- Fast Play Sales FY 25 \$10,439,525; up \$3,284,336 from FY24, or 45.90%
- Instant Sales FY 25 \$166,593,260; up \$1,992,679 from FY24, or 1.21%
- Total Combined Sales FY25 \$212,77,182; down \$7,095,286 from FY24; or -3.23%
- Lottery Profit Transfer to General Fund
  - o December \$7,648,330
  - o YTD Actual FY25 \$38,418,592; up \$3,418,594 from budget, or up 9.77%
- Profit Transfer to Outdoor Heritage Fund
  - o December \$36,107
  - YTD Actual \$173,724; Down \$226,274 from budget, or down -56.57%

### **New Business:**

Mega Millions Rulemaking: Chapter 40, Mega Millions Rules

Deputy Director Boardman presented the following basis statement for changes to the Mega Millions rules. "The Mega Millions lottery game is changing several attributes of the game in Maine in 2025, including the game matrix, price point, prizes, starting jackpot, and multiplier features. The Current rules must be amended to conform to these changes schedule to take place in April 2025."

A motion was made by Commissioner Sheehan that the commission approve the basis statement as presented for the changes for the Mega Millions game rules and direct the Bureau to commence with the rule making process. The motion was seconded by Commissioner Fitts. The roll was called, and all Commissioners voted in the affirmative; the motion passed unanimously.
