Minutes of Meeting Tuesday, December 10, 2024 Virtual Component using Zoom

### **Approval of Minutes:**

Commission Chair Fitzgerald asked for a motion that the minutes of the November 12, 2024 meeting be approved. A motion was made by Commissioner Sheehan to accept the minutes; the motion was seconded by Commissioner Fitts. The roll was called, and all Commissioners voted in the affirmative; the motion passed unanimously.

# **Liquor Operations:**

Director's Report. Director Luchini stated that the State had finalized the wholesale spirits contract with Pine State Trading Company. As directed by the Legislature, the State entered into a single10-year contract extending into November of 2034.

Director Luchini also updated the Commission on the Modernization Project that has been "live" since late October. The project has been going very well. The new system will provide licensees the ability to pay fees and submit excise taxes online, rather than mailing in checks.

Director Luchini gave a brief overview of nationwide trends on decreasing spirits sales and some potential causes. Director Luchini also noted that Costco has had their initial buy in since receiving an agency store license, which will give a bump to overall numbers.

Director Luchini reported on November 2024 sales as follows:

- Cases Sold were 114,104 TY vs. 116,150 LY; down 1.76%
- Dollar Sales were \$20,030,355 vs. 20,100,104 LY; down 0.35%
- Bailment collected \$259,243
- Depletion Allowances \$829,522

## Sales Report Year to Date:

- Cases sold YTD: 639,886 vs. 638,164 LY; up 0.27%
- Dollar sales YTD: \$111,354,237 vs. \$109,273,583; up 1.9%
- Shipping days were up 1 day over last year
- Averaged on a cases sold per day basis, cases sold are down 0.65%; and dollar sales are up 0.97%
- Spirits Operating Profit for November was \$5,048,905
- Spirits Profit Transfer for November was \$4,782,262
- Acting Deputy Director Tracy Willett presented:

The roll was called, and all Commissioners voted in the affirmative; the motion passed unanimously.

### **Label Changes:**

Acting Deputy Willett presented one item for a label change. A motion to approve the label change was made by Commissioner Sheehan; the motion was seconded by Commissioner Fitts. The roll was called, and all Commissioners voted in the affirmative; the motion passed unanimously.

### **Quarterly Price Adjustments:**

Acting Deputy Willett presented quarterly prices adjustments, including over 100 items with a decreasing price. A motion was made by Commissioner Sheehan to accept the price changes; the motion was seconded by Commissioner Fitts. The roll was called, and all Commissioners voted in the affirmative; the motion passed unanimously.

#### **Delisted Items:**

Acting Deputy Willett presented 254 items for delisting. A motion was made by Commissioner Sheehan to approve the items for delisting; the motion was seconded by Commissioner Fitts. The roll was called, and all Commissioners voted in the affirmative; the motion passed unanimously.

#### Rebates:

Acting Deputy Willett presented 29 rebates/coupons for December 2024. These rebates/coupons were all standard in nature. A motion was made by Commissioner Sheehan to approve these rebates/coupons; the motion was seconded by Commissioner Fitts. The roll was called, and all Commissioners voted in the affirmative; the motion passed unanimously.

#### **Lottery Operations**

Director Luchini reported that the Lottery is in the process of adding a new option to Powerball called Double Play. The launch has been delayed because of ICS issues, but we are expecting to roll it out in January. Director Luchini also stated that work has been going on the new rules for Mega Millions, which will change the pricing from \$2 to \$5. This change is scheduled for April. The New England Patriots promotion has been ongoing, and the lottery has sent two groups of second chance winners a Patriots game in Foxborough, MA.

Director Luchini reported on the following YTD (through November 30, 2024) sales as follows:

- Draw Sales FY 25 \$28,083,300; down \$14,545,648 from FY24, or -34.12%
- Fast Play Sales FY 25 \$8,852,584; up \$3,009,066 from FY24, or 51.49%
- Instant Sales FY 25 \$137,325,475; up \$2,200,067 from FY24, or 1.67%
- Total Combined Sales FY25 \$174,261,359; down \$9,336,515 from FY24; or -5.09%
- Lottery Profit Transfer to General Fund
  - o November \$6,447,169
  - YTD Actual FY25 \$30,770,261; up \$1,154,878 over budget, or up 3.9%
- Profit Transfer to Outdoor Heritage Fund
  - o November \$42,048
  - YTD Actual \$137,617; down \$200,843 from budget, or down -59.34%
