### **Liquor Operations:**

Director Louis Luchini reported that several staff members are at the NABCA Administrator's Conference in Montana. Director Luchini reported on the modernization project. This project will move our paper-based licensing and tax collection to an online platform. This project will go live on October 28, 2024. Municipal officials will have the ability to approve applications in the new system. The new system will eliminate the paper application and once a municipality grants approval in the system, BABLO can process applications much faster than the current process of waiting for paper applications.

### **Lottery Operations:**

Director Louis Luchini reported that the Maine Lottery is continuing with its 50<sup>th</sup> anniversary activities. There was a Wearhouse Dash event on September 28, 2024, at Thompson's Point in Portland. There were winners from each of the Tri-States (Vermont, New Hampshire, and Maine) who participated. The preliminary numbers for costs of the Wearhouse Dash event are over \$180,000 worth of prizes. Maine Lottery is hosting a 50<sup>th</sup> anniversary event coming up at the Augusta Civic Center on October 26, 2024. Maine will be hosting the Tri-State meeting November 13 - 15, 2024, in Portland.

This gives players a chance to win additional prizes for an additional one dollar. This double-play feature has a set top prize of \$10 million dollars along with many other prizes. The game is projected to launch on October 27, 2024.

A motion was made by Commissioner Monaghan that the commission adopt the basis statement as presented for the changes to the Powerball rules; the motion was seconded by Commissioner Sheehan. The roll was called, and all Commissioners voted in the affirmative; the motion passed unanimously.

Greta reported that the Secret Santa RewardME promotion is running from October 1, 2024, through January 13, 2025. Greta reported that there are three Points for Drawings currently active. Greta reported on the First Ticket Entered Promotion for September. Greta reported on the RewardME: Second-Chance Promotion comparison by tickets entered 2022 – 2024, excluding Reindeer Run and Sizzlin' Summer promotions. Greta reported that a new episode of the Maine Lottery Minute will be released Friday October 11, 2024.




