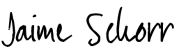



Promega is the manufacturer and vendor of proprietary kits and reagents that we use to generate forensic DNA profiles in case work and database work at the Maine State Police Crime Lab. These specific systems have been tested and validated by the Crime Lab for this purpose and cannot be switched with other DNA profiling systems.

Promega does provide a discount for these items based on how many items we use in a given period.

The process of testing, validating, and training on a new kit for DNA profiling is a lengthy and expensive process. We are very careful about which kits we choose to validate, and the quality of the item and the reliability of the vendor are equally important. The quality of the products from Promega has been superior to the Life Technologies/Applied Biosystems DNA profiling kits we used to use.
