Contacting and Scheduling an ASL Interpreter

If no "online request form" is available be sure to <u>agree upon an estimated total price</u> for the appointment (including travel, if applicable) <u>in advance</u>.

Once you have agreed upon an estimated total price with the vendor and scheduled the interpreter appointment, follow these instructions (<u>AdvantageME Delivery Order Instructions</u>) to create a Delivery Order against the Master Agreement (MA) number shown below the vendor's name. When you receive the invoice after the service has been provided, <u>payment must be</u> <u>made within 30 days from when you receive the invoice</u>. You may need to contact your Service Center to accomplish this part of the process, which will vary by department.
