RFP# 202408159 - Pre-Qualified Vendor List for PFAS Project
Consulting Services

I. Summary

- The Department of Environmental Protection will pre-qualify environmental consultants to assist Department staff at PFAS Sites, with the ongoing PFAS investigation, and with PFAS related projects.

II. Evaluation Process

Consensus scoring:

- My consensus scoring team consisted of our public service coordinator (Tracy Kelly), and environmental scientist IV (Margaret Watson-Pierce - also the residuals unit manager), and an environmental hydrogeologist (Kayla Michaud). I was the note taker and facilitator.
- Tracy Kelly is currently our PFAS public coordinator and coordinates a lot of the efforts pertaining to PFAS, including running our bi-weekly PFAS meetings, tracking data, and reporting to upper management.
- Margaret Watson Pierce spent years as a project manager working on PFAS sites in Northern Maine, and now she supervises a unit comprised of project managers working on PFAS sites across the state.
- Kayla Michaud works on a number of different environmental projects, but weighs on site specific methodology for PFAS sites, offers sampling guidance, and makes GIS maps for PFAS sites.

III. Qualifications & Experience

- The team evaluated proposals based on organization, requested information – and how thorough and organized it was - past and current work with the Department, in Maine, and relevant PFAS projects.
- We also looked for relevant professional staff, certifications, litigation status.
- The highest score was 50 with most companies receiving between 35-45 points.

I. Proposed Services

- The team found that all submittals had the experience, staff and resources they need to carry out tasks provided by the department. Proposals were also evaluated on this section addressing PFAS work specifically, organization, and including all other requested information.
- The highest score was 25, with submittals ranging from 8-25 points.

- **Key components:** Number of successful completed projects, training and staff to complete projects awarded through the mini bid process.

II. Cost Proposal

- We did not have a cost proposal. We asked that submittals include a rate sheet. All submittals included one.

III. Conclusion

- The department received fifteen (15) submittals for RFP #202408159.
