**Award Justification Statement**  
**RFP# 202402030 - Pre-Qualified Vendor List for**  
**Geospatial Data Acquisition and Services**

**I. Summary**

The Maine Office of GIS sought proposals of service offerings from vendors to be considered for inclusion on a Prequalified Vendor List. The RFP outlined four service categories for geospatial data acquisition and services to deliver content either created in direct capture or as derivative content developed from derived sources. The RFP is intended to be open for response submission over multiple periods with an annual review of other service providers who wish to join the program and offer services. This competitive pool will be coordinated by MEGIS as part of administering the DAFS General Fund established to support State of Maine agencies with geospatial data acquisition needs.

Once prequalified to participate in this program, service providers may be included in a mini-bid process based on their qualification profiles where they will be asked to respond to specific scope of work and/or deliverable descriptions with a methodology and cost proposal. Each of these initiatives will have a specific selection criterion for that competitive process event.

**II. Evaluation Process for the PQVL Inclusion**

The evaluation process was informed by guidelines provided by the State of Maine for evaluation of Requests for Proposals to

- 1) Ensure fairness, transparency, and objectivity in review of the proposals and
- 2) Ensure each vendor's proposed services satisfies the criteria of the RFP for each service category the vendor chose to submit their qualified service descriptions for consideration.

The Evaluation Team: Clarence Young (Coordinator), Brian Guerrette, and Jay Clark reviewed appropriate training videos, completed the Evaluator Acknowledgment Form and signed the Agreement Disclosure Statement. The scoring structure, as published in the RFP, was used for the entire review process. A Consensus Approach was used for the evaluation.

Sections 1 and 4 were awarded points based on how well they responded to the criteria of the RFP. Sections 2 and 3 were awarded points by determining which of the 4 category areas (Orthoimagery Development, LiDAR Collection, Derivative Geospatial Products, and Geospatial Services) that they qualified to bid on. Each vendor was awarded a score for each qualified area.

A pre-evaluation meeting was held prior to review. All members of the team have previous experience with RFP evaluation. As employees of MaineIT associated directly with the Maine Office of GIS, all team members have the qualifications necessary to review the materials presented in the applications. Applicants that receive a score of 13.5 points in any of the four categories are included in the Pre-qualified Vendor List. Higher scores indicate qualification to bid in more categories. For each of the 4 categories, a separate matrix was developed to compare the variety of proposals presented and determine the qualifications of potential bidders for each area align with the program objectives. These matrices are shown in the Master Score Sheet.

### **III. Qualifications & Experience**

No bidders were disqualified during the evaluation of RFPs for the Pre-Qualified Vendor List.

No cost proposals were requested, instead the respondents were asked to submit a current rate sheet, providing a listing of all the typical fixed and hourly rates for all categories that they are proposing to bid on.

Contracts will be offered at the time work is awarded per guidance from MaineIT purchasing.

Mini-Bids will be requested and work potentially awarded based on statements of work as specific projects are identified. Assuming standardized offers, the lowest cost applicants will be chosen.




