PART III: SUPPLEMENTAL INFORMATION

1. Provide a more detailed description and explain the need for the goods, services or grant to supplement the response in Part I.

Backhoe 21-112 had worn kingpins causing the front tires to wear and axle seal leaking, these issues will prevent the loader from taking a state inspection. The kingpins were disassembled to remove hub. Both axle joints were heavily rusted, and caps were seized in yokes. Tech had to disassemble final drive and remove complete axle shaft assembly. Cut u-joints from yokes and remove caps and install new u-joints. Tech also found a service bulletin for a new style of axle seal he removed and replace both axle seals and wheel seals. Reassemble final drive and install onto axle. Install new kingpins and bushings and grease on both sides of machine. Install used tire on rim. Drain hydraulics and remove leaking hydraulic hoses and installed new hydraulic hoses. Repairs totaling \$6,910.59 where made. The decision to move forward with these repairs was made consistent with Maine DOT Fleet Management's guidance considering the equipment age, hours and anticipated replacement schedule. The estimated replacement cost for this equipment is \$140,000.00. This unit is not currently scheduled to be replaced. The decision to use a commercial repair facility was made after careful consideration of the availability and expertise of Department personnel and the operational need to get the equipment back in service.

2. Provide a brief justification for the selected vendor to supplement the response in Part II. Reference the RFP number, if applicable.

The Fleet Augusta heavy equipment shop was very busy and is down 2 Tech's and a third person was out on bereavement for a week. The Region 2 Field Technicians were missing four people. The vendor for this work has Case trained technicians and along with all the special tools needed for the repair and replacement of the parts associated with the issue. The magnitude of this repair was considered, and the logical decision was to send this unit to the dealer.

3. Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.

Beauregard Equipment is a Case dealer and we have used them numerous times over the years. Their pricing is very competitive to the industry standards. They can efficiently and cost effectively do a repair of this significance. Taking into consideration the time of year, necessity of loaders to load salt onto plow trucks and the lack of trained personnel, this is not something the department could have cost effectively done and completed in a timely manner.

4. Describe the plan for future competition for the goods or services.

If we could convince more Case dealers and service facilities to move into more locations in the state, it would potentially foster better competition.

Electronic Record and Signature Disclosure

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Carahsoft OBO Maine Department of Transportation (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you.
