<b>PART III: SUPPLEMENTAL INFORMATION</b>	
<b>1.</b>	<p>Provide a more detailed description and explain the need for the goods, services or grant to supplement the response in Part I.</p> <p>Adoptive &amp; Foster Families of Maine, Inc. (AFFM) currently holds the contract for Resource Family Support Services. The purpose of the contract is to provide support services which assist Resource Parents in their role of caregivers for Youth placed in their homes by the Department. Resource Family support services enhance caregivers' skills in their role as Resource Parents and supports Resource Parents' increased understanding of the role shared with the Department in promoting timely Permanency outcomes (including Reunification) for Youth in Care.</p> <p>The Kinship Navigator Program goes hand-in-hand with Resource Family support services and builds on it. The Kinship Navigator Program educates the general public through collaboration with school systems, medical facilities, courts, police departments and other community programs. The program provides Resource Guides with an extensive list of resources and supports for families to utilize and to better prepare them for being Kinship Families and also provides a Kinship Family-specific respite program.</p> <p>AFFM is currently providing Resource Family Support Services to foster parents and kinship families, which includes formal kinship placements and informal caregivers. The additional kinship navigator services are funded using the Federal Kinship Navigator Grant.</p> <p>This Amendment is extending the contract for an additional nine (9) months due to delays in the RFP. Funding to support this extension is also being added.</p>
<b>2.</b>	<p>Provide a brief justification for the selected vendor to supplement the response in Part II. Reference the RFP number, if applicable.</p> <p>AFFM has been providing this service for many years as the awarded bidder from RFP#201412879 and from RFP#201608158.</p> <p>Maine/OCFS has been participating in a cross-site collaborative consisting of four states: Maine, Montana, Vermont, and Wyoming, led by Generations United, Casey Family Program, and The University of Washington. The purpose of the collaborative is to develop an evidence-based kinship navigator program for the Families First clearinghouse, enabling states to claim federal IV-E funds.</p> <p>Preparation meetings for the collaborative began in April 2021, and the work officially started in June 2021. The current provider, AFFM has done the required groundwork, and staff have been hired. Full implementation in Maine begins in February 2022. AFFM has a relationship with the University of Maine, Center on Aging to collect and analyze the data.</p>

**PART III: SUPPLEMENTAL INFORMATION**

Data and findings from the collaborative will be sent to the IV-E Clearinghouse by the end of 2023 for review and rating for including in Family First Prevention Services.

Maine/OCFS' continued participation in this initiative is critical to the success of the evaluation, and will contribute greatly to the research about an evidence-based kinship navigator program. Changing the provider of the Kinship Navigator Program services so one other than the current Provider of these service, AFFM, would result in Maine's withdrawal in participation of the Collaborative.

This contract extends the agreement with AFFM beyond the typical RFP/competitive procurement timeframe to allow for Maine's/Office of Child and Family Services' continued participation in the Kinship Navigator collaboration as described above.

3. Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.

The costs in this agreement are the same as in previous contracts since RFP #201608158 was awarded.

4. Describe the plan for future competition for the goods or services.

The Department intends to issue RFP OCFS202320 for Resource Family Support Services and the Kinship Navigator Program services with a contract start date of October 1, 2025.


