1. Provide a more detailed description and explain the need for the goods, services or grant to supplement the response in Part I.

The purpose of this Contract is to procure forensic toxicology testing services for the Overdose Data to Action (OD2A) program. The Overdose 2 Action (OD2A) program will use these funds to improve the timeliness of reporting toxicology data for fatal opioid-involved overdoses. Investigations of suspected unintentional opioid-involved overdoses are done by Maine's statewide, centralized, Chief Medical Examiner (CME) system. All suspected poisoning deaths receive comprehensive toxicology testing (presumptive screens and confirmatory quantitative levels). Initial toxicology testing, for general and designer opioids, can take weeks. This testing will speed case completion and expand the number of cases receiving full testing.

2. Provide a brief justification for the selected vendor to supplement the response in Part II. Reference the RFP number, if applicable.

This initiative provides funds for toxicology screenings, which are increasing due to an increase in the number of autopsies and the sudden surge in suspected and confirmed drug overdose cases. Both a greater number of tests as well as a more sophisticated level of testing are needed due to the types of drugs, including new "designer drugs", being misused on the streets.
