1. Provide a more detailed description and explain the need for the goods, services or grant to supplement the response in Part I.

T11-587 lost the throttle and would not move. Sent our field tech out to hook up the diagnostics Laptop and run a report to find the problem. The tech found that it lost communication with the ECM. After pinning out the harness our tech determined the ECM was bad. It was sent to the closes international dealer to verify. The dealer did also determine the ECM was bad. Allegiance provided a quote of \$7,391.00 to replace and reprogram the ECU

T11-587 is a 2014 International Patrol truck with 5900hrs. The decision to move forward with the replacement of ECM were made consistent with the Maine DOT Fleet Management's guidance considering the trucks age, hours, and anticipated replacement schedule. The estimated cost to replace this truck is \$180.,000.00.

With Fleet full of work and the ECM needed to be programmed by an International dealer it was decided the timeliest way to get this truck back in service was to send to the dealer.

The Dixfield Fleet facility shop was back logged with other vehicles down and where the ECM needed to be programmed once it was installed. The logical decision was to send this unit to an international dealer where have trained technicians along with all the special tools needed for the repair

Allegiance is an International dealer and Fleet Services has negotiated a lower labor rate with them, we have also had work done there in the past and when compared with the other International dealer their rates where the same or in some cases a little cheaper. This repair would not have been something the department could have cost effectively done and completed in a timely manner.

If we could convince more International truck dealers and service facilities to move into more locations in the state it would potentially foster better competition.






## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, Carahsoft OBO Maine Department of Transportation (we, us or Company) may be required by law to provide to you certain written notices or disclosures. ### **Getting paper copies**
