Informa is the existing hosted application for MaineDOT Crew employee training. The purpose of this extension is to ensure that the Crew training is not interrupted through 2026. MaineDOT needs to continue to use its existing solution during 2026, as the new state Enterprise Learning Management System, Lumen, currently does not support the Department’s crew employee training requirements.

2. Provide a brief justification for the selected vendor to supplement the response in Part II. Reference the solicitation (RFP/RFA/RFQ) number if applicable.

MaineDOT’s existing agreement with Informa System was awarded through RFP#201410862.

3. Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.

No increase from previous year’s rates. The Department sees these rates as fair and reasonable.

4. Describe the plan for future competition for the goods or services.

During 2026, MaineDOT will review and develop a concept of operations defining its requirements for crew training. MaineDOT has evaluated opportunities to integrate with the State’s Lumen implementation, but it is not feasible in the near future.

The Department will release an RFP in 2026, publishing by August with an anticipated contract start date in December.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE
