### PART III: SUPPLEMENTAL INFORMATION

1. Provide a more detailed description and explain the need for the goods, services or grant to supplement the response in Part I.

T01-213 lost all power and would not move. Sent tech out to with laptop to diagnostics the problem. The code detected was a bad turbo actuator. Management decided to send it to O'Connor's for further diagnoses. After the vendor determining the turbo needed to be replaced, they emailed Fleet an estimate of \$9,602.73 to replace the turbo and reprogram the ECM  
T01-213 is a 2010 Volvo wheeler with 11,414hrs. The decision to move forward with the replacement of turbo were made consistent with the Maine DOT Fleet Management's guidance considering the trucks age, hours, and anticipated replacement schedule. The estimated cost to replace this truck is \$280,000.00.

2. Provide a brief justification for the selected vendor to supplement the response in Part II. Reference the RFP number, if applicable.

With Fleets back load of work and lack of Technicians we decided the quickest way to get the truck back in service was to send to the dealer. Region 3 Fleet could only perform the repair but, did not have the capabilities to recalibrate the ECM after the turbo was replaced. The vendor was able get the truck in right away. O'Connor's was selected for this work where they have certified technicians trained Volvo trained technicians along with the dealer permissions necessary for programming as well as the special tools and parts associated with this repair.

3. Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.

O'Connor's is a Volvo dealer and they have Volvo trained tech's that are able too efficiently and cost effectively do a repair of this significance. This repair would not have been something the department could completely perform without the necessary dealer permissions. The repair cost was effectively completed and done in a timely manner.

Convince more Volvo dealers that are qualified to provide this same service to move into more locations in the state it would potentially foster better competition.






## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, Carahsoft OBO Maine Department of Transportation (we, us or Company) may be required by law to provide to you certain written notices or disclosures. ### **Getting paper copies**
