T01-220 is a 2010 Volvo plow truck with 10091hrs with repairs totaling \$8129.73 were made. The decision to move forward with these repairs was made consistent with Maine DOT Fleet Management's guidance considering the vehicle's age, miles, and anticipated replacement schedule. This truck is not scheduled for replacement. The replacement cost of the truck is about \$200,000.00. With the Fleet garages full of work and low on Techs and not having all the specialty tools for the job we decided the quickest way to get the truck back in service and plowing snow was to sub the job out to the dealer.

With the work not able to be done inhouse we decided to reach out to O'Connor's to see if they were able to get it for us. After talking to them the quickest way to get it fixed was to have Portland O'Connor's do the job.

After looking the job over they called with a quote of \$70000.00. So, we had them go ahead with the work. Labor on this job was a little higher than expected because of them having to pull out the plow controls in the cab to get to the back of the motor. The total ended up being \$8129.73.

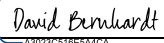
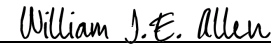

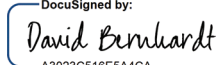

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, Carahsoft OBO Maine Department of Transportation (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. ### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you.
