1. Provide a more detailed description and explain the need for the goods, services or grant to supplement the response in Part I.

T09-001 is a 2000 with 665,560 Miles on it. The truck was giving to MDOT from the state police to be used in our ELDT driver training program. Time was a factor in determining how soon and where the repair would be done. The decision was made to send it to O'Connor's Truck because they had the diagnostic software program for the Detroit engine and available slot. The repairs totaling \$10,345.92 were made. The decision to move forward with these repairs, where this was giving to MDOT for the ELDT training the estimated purchase cost for this piece of equipment would be \$180,000.00. This unit is not scheduled to be replaced. With the Fleet garages full of work and low on Techs we decided the quickest way to get the truck plowing snow was to sub the job out to the dealer.

With the work not able to be done inhouse we decided to reach out to other vendors to see if they were able to get it for us. After calling a few different vendors O'Connor' Trucks was able to get it right in and start the job.

Once they evaluated the job for a state inspection and block heater, they quoted \$9,699.29. We then asked them to quote adding the purchase & Installation of a fifth wheel plate which was \$10,345.92. We then asked them to move forward with second quote @ \$10,345.92.





## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, Carahsoft OBO Maine Department of Transportation (we, us or Company) may be required by law to provide to you certain written notices or disclosures. ### **Getting paper copies**

You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you.
