### PART III: SUPPLEMENTAL INFORMATION

1. Provide a more detailed description and explain the need for the goods, services or grant to supplement the response in Part I.

Maine statute mandates it is the policy of the State to conserve all species of fish and wildlife found in Maine, and to maintain and enhance the numbers of species at risk of extirpation. The Rusty Patched Bumble Bee is a federally listed Endangered Species that historically occurred in Maine but has not been observed in the state since 2009. The U.S. Fish & Wildlife Service (USFWS) has partnered with Maine Dept. Inland Fisheries & Wildlife (MDIFW) via annual Section 6 grant awards to conduct targeted surveys for this extremely rare species in an attempt to document any remaining populations. Surveys also focus on searching for state-listed bumble bee species and documenting all species of bumble bees observed to augment statewide data on diversity, distribution, and status. In order to meet the State's mandate, MDIFW needs to obtain current data on the occurrence of Maine's rare bumble bee species. This contract would continue two previous years of targeted surveys by expanding into counties that have not yet been intensively surveyed for the Rusty Patched and other rare bumble bee species.

2. Provide a brief justification for the selected vendor to supplement the response in Part II. Reference the RFP number, if applicable.

Mark Ward is a Consulting Ecologist who MDIFW contracted to conduct targeted surveys for Rusty Patched and other rare bumble bee species in several mid-coast counties during 2020 and 2021. This contract would continue and expand upon these prior surveys, using the same MDIFW and USFWS protocols and methodologies. While there are a few other independent contractors potentially available in the state who are qualified to survey and identify Maine's bumble bees, Mark's expertise and familiarity with conducting the previous years' surveys are invaluable assets to implementing the current contract, requiring no training or oversight by agency staff.

3. Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.

The hourly rate negotiated for both field and office labor (\$22/hr), as well as expense reimbursement levels allocated for this contract, are equal to other contracts procured by MDIFW for similar work and expertise, and are far more competitive than the rates typically charged by most professional consultants qualified to conduct this work.

4. Describe the plan for future competition for the goods or services.

Competently surveying and identifying bumble bee species in the field, particularly rare species such as the Rusty Patched, requires extensive experience that is not widely available in Maine. Because MDIFW staff time and resources are limited, and this expertise is not available from any other in-state governmental agency, conducting this work necessitates contracting outside professional expertise. Unless other local biological or environmental consulting companies or private contractors hire staff who specialize in bumble bee surveys and field identification, the pool of in-state qualified contractors will remain very small and there will be limited opportunities for future competition.
