1. Provide a more detailed description and explain the need for the goods, services or grant to supplement the response in Part I.

As a result of the COVID-19 pandemic, the implementation of several new MHDO reporting mandates affecting hospitals and nursing homes for example, have been delayed until 2023. MHDO and its data vendor HSRI have completed project plans and building out the new infrastructure that will be needed to support these new reporting mandates that will go into effect in 2023 (assuming no continued delays due to pandemic), however, the various training webinars with the reporting entities will occur in the summer/fall of 2022 in order to go live in 2023. It is not cost effective nor efficient to not leverage the work that has been done to implement these

requirements. Additionally, Section 115 of the No Surprises Act (federal legislation), enacted as part of the Consolidated Appropriations Act of 2021 creates a federal grant program to support sates advancing and or developing an all-payer claim database (APCD). The \$2.5 million dollar grant will significantly help support several enhancements to MHDO's APCD that we have been discussing with our data vendor, HSRI for several years now. With the appropriate funding we are prepared to move quickly with HSRI to leverage both the funding resources and HSRI's intimate understanding and experience with MHDO, including our mandates, structure, data submitters and data users. Any disruption to our processes at this time will negatively impact our ability to maximize the funding opportunity and to minimize any disruption in submitting and or accessing/using MHDO data. For these key reasons we are requesting that our contract with HSRI be extended for a two-year period to implement mandated reporting requirements and maximize federal funding most efficiently and effectively.

#### 2. Provide a brief justification for the selected vendor to supplement the response in Part II.

HSRI is MHDO's contracted data vendor and is responsible for maintaining MHDO's healthcare database which includes over 1 billion health care records from payers, hospitals, prescription drug manufacturers, wholesale distributors and pharmacy benefit managers. HSRI works with and supports MHDO on all aspects of data collection, validation, processing, and data release. This includes developing the infrastructure, including data submission portals, training manuals and data submission guides so that reporting entities can submit their data to MHDO via our secure portals. Additionally, HSRI assists MHDO with fulfilling its own reporting mandates as required in Title 22, Chapter 1683; as well as ad-hoc health care reporting requests from sister state agencies.

# 3. Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.

The fees associated with this amendment are consistent with the fee structure associated with MHDO's existing contract with HSRI and reflect the additional data streams and legislative requirements of MHDO.

#### 4. Describe the plan for future competition for the goods or services.

MHDO will release an RFP in the first quarter of 2024 for a Data Vendor. The deliverables will be consistent with the deliverables and requirements in our current data vendor contract.
