1. Provide a more detailed description and explain the need for the goods, services or grant to supplement the response in Part I.

Backhoe 21-142 had issue with wainroy only turning one way. The dealer tech did some voltage testing and found a switch in the joystick was bad replaced switch now works. Dealer tech connected computer and checked for codes found code for glow plug short, tested glow plugs and found number 4 bad, dealer tech tried to remove and would not move, dealer supervisor call me and told me glow plug would not move and if it broke they would need to remove the head I told them not to continue as we just had a similar situation with another backhoe and it turned into a \$18,000.00 repair and DOT could ether park the backhoe inside or plug in the block heaters in the winter. When dealer tech was dissembling right front to replace axle seal axle nut rounded over and had to cut nut off tried to remove axle from housing but would not move had to cut axle and u-joint to remove from housing replaced parts ad resemble. Dealer tech removed multiple chafed and leaking hydraulic hoses from boom, replaced hoses and installed hose wrap for high chafe areas. Repairs totaling \$12,814.62 where made. The decision to move forward with these repairs was made consistent with Maine DOT Fleet Management's guidance considering the equipment age, hours and anticipated replacement schedule. The estimated replacement cost for this equipment is \$120,000.00. This unit is not currently scheduled to be replaced. The decision to use a commercial repair facility was made after careful consideration of the availability and expertise of Department personnel and the operational need to get the equipment back in service.

2. Provide a brief justification for the selected vendor to supplement the response in Part II. Reference the RFP number, if applicable.

The Fleet Augusta heavy equipment shop was busy and is down 4 Tech's and Region 2 is down 2 field tech. The vendor for this work has Case trained technicians and along with all the special tools needed for the repair and replacement of the parts associated with the issue. The magnitude of this repair was considered, and the logical decision was to send this unit to the dealer.

3. Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.

Beauregard Equipment is a Case dealer and we have used them numerous times over the years. Their pricing is very competitive to the industry standards. They can efficiently and cost effectively do a repair of this significance. Taking into consideration the time of year, necessity of loaders to load salt onto plow trucks and the lack of trained personnel, this is not something the department could have cost effectively done and completed in a timely manner.

If we could convince more Case dealers and service facilities to move into more locations in the state, it would potentially foster better competition.
