PART III: SUPPLEMENTAL INFORMATION

1. Provide a more detailed description and explain the need for the goods, services or grant to supplement the response in Part I.

Access to remote State Park and Historic Site islands and coastal locations, as well as bodies of inland water on the Allagash Wilderness Waterway is challenging. BPL is seeking landing craft style boats with drop-down bow ramps that can safely access these locations to facilitate operations, maintenance, increase productivity, and ensure both public and employee safety.

2. Provide a brief justification for the selected vendor to supplement the response in Part II. Reference the RFP number, if applicable.

Extensive research into various boat manufacturers was conducted and only Munson Boats was able to meet our required specifications. The landing craft style boat is conducive to in-water rescue operations, on-shore landing of equipment, materials, and personnel, and has a limited number of manufacturers available. Munson specializes in boats designed for these specific tasks, with an emphasis on public safety and governmental operations. The patented design of the Munson Boats (U.S. Patents D739331S and 8281730B2) mean that they are a single source/unique vendor which justifies their non-competitive selection.

3. Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.

The vendor provided costs that were fair and reasonable and has applied a multi-boat discount on the quote (\$13,757.00). Since the vendor has proprietary rights to these specific vessels and the specifications meet our requirements the price per vessel is acceptable.

4. Describe the plan for future competition for the goods or services.

Quotations will be solicited should other manufacturers of this type of boat enter the market.
