1. Provide a more detailed description and explain the need for the goods, services or grant to supplement the response in Part I.

The Bruker FT-IR (Fourier Transform Infrared) instrument is a critical analysis tool used at the Maine State Police Crime Laboratory by the Forensic Chemistry section to analyze trace evidence such as fibers, paints, and microplastics in criminal investigations. This one-of-a-kind instrument employs infrared spectroscopy to produce unique molecular fingerprints, enabling precise identification for compounds essential for criminal investigations and court proceedings.

During the last on-site service, the instrument technician deemed this major maintenance critical and a threat to future operations. If these malfunctions render the instrument inoperable, it will halt analysis, cause delays in casework, and impact public safety and the judicial process. Immediate repair is necessary to restore functionality, ensure compliance with accreditation standards, and maintain the lab's ability to process evidence efficiently.

2. Provide a brief justification for the selected vendor to supplement the response in Part II. Reference the RFP number, if applicable.

Bruker Scientific LLC is the original equipment manufacturer (OEM) of the FT-IR instrument and the sole source capable of performing the required repairs. The instruments complex design, including mostly proprietary components like the helium-neon laser and interferometer, necessitate service by technicians trained and certified by Bruker. Only Bruker has access to proprietary parts, diagnostic software, and technical schematics required to restore the instrument to full functionality. Alternative vendors lack the specialized knowledge, tools, and authorization to service Buker instruments and attempting repairs by an unauthorized provider could void warranty and compromise performance even further. It will negate validation of the instrument as required by national accreditation standards, thereby invalidating forensic results used in a court of trial. Market research, including outreach to other spectroscopy service providers, confirmed that no other company can meet the technical requirements for this repair. Bruker is the sole provider for service of it's instruments.

3. Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.

The costs for repair, which include on-site service and proprietary parts, and recalibration are deemed fair and reasonable based on comprehensive price analysis. Bruker's standard service rates and parts pricing align with those quoted in their service agreement catalog. Historically, previous maintenance and repair contracts show comparable pricing for parts and service. The proposed rates are within industry norms when compared to other state forensic labs for high-precision analytical instruments.

4. Describe the plan for future competition for the goods or services.

If the Bruker FT-IR instrument is replaced in the future, the lab will conduct market research to identify emerging vendors as potential replacement for spectroscopy instruments that is more

fiscally prudent. If future vendors or 3rd party service providers are capable of performing repairs to the FT-IR instrument, and are accredited, approved for validation and have access to proprietary parts, the lab will consider using other vendors to provide service for the instrument.
