2. Description of Specific Need

Please identify, and fully describe, the specific problem, requirement, or need the resulting non-competitive contract would address and which makes the goods or services necessary. Explain how the requesting Department determined that the goods or services are critical and/or essential to agency responsibilities or operations.

Since 2016 the Maine DOE has supported a cohort of over 19 schools and 53 teachers in order to support preschool programs meeting Chapter 124 Public Preschool Standards and to help align preschool through third grade assessments. Teaching Strategies GOLD (TSG) is the assessment tool that was used. This work was funded through a US Dept. of Education grant which will expire on December 31, 2019. Interest from the existing schools to continue this tool on their own has been collected through a survey. They all desire to continue and are willing to purchase it at a discounted per student rate through their local budgets and under a Maine state master agreement.

TSG is a formative assessment that addresses all domains of child development and learning from birth through third grade. Since it was used in this project over the last three school years, it is critical to keep the assessment constant so that the data can be compared. Further, this year the work includes public preschools that are in partnership with Head Start. TSG is the assessment used by the Head Start agencies. Since TSG is the assessment used by Head Start, it must be used in the partnership to ensure consistency of data collection. The purpose of this assessment is to inform curriculum and instruction. The goal is to continue to support the transfer of child data from Head Start to the public-school kindergarten teacher and allow schools to upload their data into the MAARS system.

This is the only research-based assessment tool that spans birth through third grade and includes kindergarten entry assessment (KEA) measures. Continuing the work with TSG through the master agreement enables schools to purchase individual student portfolios at a rate of \$15.95 per child, compared to \$21.95 outside of the agreement.

3. Availability of other Public Resources

TSG is the only whole-child, formative assessment tool that spans an eight-year period and assesses the whole-child. The state of Maine does not currently have a tool that addresses this need more efficiently or effectively.

4. Cost

Since a waiver of competitive bidding is being requested for this procurement, please explain how the requesting Department concluded the negotiated costs, fees, or rates are **fair and reasonable**.

The Maine Department of Education was given a reduced rate for this master agreement. Typically, the cost of a child portfolio is \$21.95; we have been offered \$15.95 per child. Individual schools and their SAUs will contract individually with Teaching strategies, LLC. No funds will be given by or to the Dept. of Education.

The amount to host a two-day training for new teachers will be paid through this contract at a cost of \$5030.00


TSG is the assessment tool used in our three-year cohort and it is widely used in Head Start classrooms throughout the state; 35% of our public preschool programs are in partnership with Head Start. In order to collect comparable data across partnerships and from preschool to third grade, this tool must be used.
