PART III: SUPPLEMENTAL INFORMATION

1. Provide a more detailed description and explain the need for the goods, services or grant to supplement the response in Part I.

The LIMS-Plus DNA Module will enable DNA Analysts to create a batch of casework samples once and carry that same list through the entire examination, extraction, quantification, amplification, and electrophoresis steps using worksheets that are custom designed for our laboratory, thereby creating a paperless work environment that increases efficiency and throughput as well as facilitates automatic discovery for the court system.

The Versaterm LIMS-Plus DNA Module will increase the capacity of the laboratory by generating lists of casework samples for downstream instrumentation (i.e., Maxwell RSC48 extraction robot, Maxprep liquid handler, QuantStudio qPCR Thermal Cycler, Rotor Gene Thermal Cycler, ProFlex Thermal Cycler, and 3500 Genetic Analyzer), eliminating the need to repeatedly type or handwrite multiple casework samples on separate worksheets for each stage of analysis (examination, extraction, quantification, amplification, and electrophoresis).

The LIMS Plus DNA Module will reduce transcription errors, typos, and missed samples while increasing the efficiency of lab work.

This module has been approved by federal grant managers for purchase under the FY2023 CEBR (backlog reduction) grant as it will create efficiencies that will greatly increase throughput and help to reduce the number of backlogged cases in the DNA section.

2. Provide a brief justification for the selected vendor to supplement the response in Part II. Reference the RFP number, if applicable.

Versaterm Public Safety US, Inc (formerly Justice Trax) is the sole provider for forensic evidence tracking products and services to the Crime Lab. We have worked closely with this vendor since 2007 and with State of Maine OIT approval. Our system is integrated with MaineIT services, and the Portal feature is integrated with the State Police FileOnQ evidence software for all Troopers. It is not possible to provide this service and software maintenance elsewhere.

3. Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.

Versaterm Public Safety US, INC (formerly JusticeTrax) has not raised prices for years but is now expanding their products and service capabilities, hence their pricing is increasing through 2026 at which time they expect customers to convert to a cloud solutions platform. This vendor is controlling their increased costs at present 7% annually over the next 3 years for us. They have quoted a locked in rate for the recurring LIMS-Plus DNA user license fees for three (3) years to control price increases over that time period.
