1. Provide a more detailed description and explain the need for the goods, services or grant to supplement the response in Part I.

The Arthur R (AR) Gould School, located at Long Creek Youth Development Center, is in need of installation of programming and equipment, as well as training of staff to allow youth the opportunity for audio production, music engineering, videography, video editing, podcasting, and graphic design. By creating this space youth will have a safe place to be creative and be self-expressive, while additionally creating and encouraging positive relationship building, teaching youth about career options and employable skills such as poetry, rapping, etc., and teaching youth life skills such as respect, teamwork, and self-awareness. All of which are essential for youth to continue to develop, grow, and be successful.

2. Provide a brief justification for the selected vendor to supplement the response in Part II. Reference the RFP number, if applicable.

The Contract Administrator conducted fair market research for music studio programs specializing in correctional facilities for juveniles. It was determined that Creative Hope Studios (CHS) was the only provider specializing in mobile juvenile corrections programs. There are no other staff development training or products that offer the same purpose or function, designed specifically for the Juvenile Justice system and schools that serve at-risk youth.

Creative Hope Studios leads a team of highly qualified unique educators/individuals. Leading the training will be an individual who is a youth mentor, program provider, national trainer, and the founder of The Vision Program which provides programs, curriculum, and workshops for at-risk youth predominately in the Juvenile Justice system. Additionally, this individual is an accredited trainer in Juvenile Justice providing training opportunities for youth-care workers and support staff, addiction counselors, judges and probation officer. Along with another individual who has over 15 years of experience.

Creative Hope Studios is the only company in the United States that offers a comprehensive program designed specifically for the juvenile justice system. Their unique blend of services and their focus on sustainability and cultural relevance makes Creative Hope Studios the premier choice for facilities looking to implement a transformative program for their youth. CHS possesses copyright, trademark, design rights and/or provides unique capabilities or body of knowledge critical to the provision of the services required.
